

## MASTER ENTERTAINER & EVENT CONTRACTOR AGREEMENT

This Agreement is entered into between **Sanctuary Social (“Venue”)** and the undersigned Entertainer / Event Contractor (“Contractor”).

---

### 1. Independent Contractor Status

Contractor is engaged as an independent contractor and not as an employee, partner, or agent of Sanctuary Social.

Contractor is solely responsible for:

- Federal, state, and local taxes
- Insurance coverage
- Personnel or assistants
- Performance content
- Equipment (except limited venue-provided items if applicable)

Nothing in this Agreement creates an employment relationship or joint venture.

---

### 2. Insurance Requirements

Contractor must maintain General Liability Insurance with minimum limits of:

- \$1,000,000 per occurrence
- \$2,000,000 aggregate

Sanctuary Social must be listed as **Additional Insured**.

If Contractor is conducting physical activity (fitness, workshops involving movement, etc.), coverage must include participant injury coverage.

If Contractor is selling products, coverage must include product liability.

A Certificate of Insurance (COI) must be provided prior to the event unless waived in writing by management.

---

### 3. Indemnification & Hold Harmless

Contractor agrees to indemnify, defend, and hold harmless Sanctuary Social, its owners, managers, employees, and agents from any claims, damages, losses, liabilities, or expenses (including attorney's fees) arising from:

- Contractor's performance or event
- Contractor's equipment
- Actions of Contractor's personnel
- Participant injuries during Contractor-led activity
- Sale or distribution of Contractor's products
- Contractor's negligent acts or omissions

This applies during load-in, event execution, and load-out.

---

#### **4. Use of Venue Equipment (If Applicable)**

If venue speakers, mixer, tables, or other equipment are provided:

Contractor agrees to:

- Operate equipment professionally
- Not rewire, alter, or disassemble systems
- Maintain reasonable sound levels
- Report malfunctions immediately

Contractor is responsible for negligent damage caused to venue equipment and agrees to reimburse reasonable repair or replacement costs.

Sanctuary Social is not responsible for loss or damage to Contractor-owned equipment.

---

#### **5. Revenue Share & Ticketed Events**

If event compensation includes revenue share:

- Terms must be outlined in a separate written confirmation.
- Contractor is responsible for reporting accurate ticket sales if ticketing is managed externally.

- Sanctuary Social reserves the right to verify ticket counts.

Unless otherwise agreed in writing, Sanctuary Social retains control over:

- Alcohol sales
  - POS processing
  - On-site financial reconciliation

## **6. Product Sales**

If Contractor sells merchandise or products on-site:

- Contractor is solely responsible for sales tax reporting unless otherwise agreed in writing.
  - Contractor assumes all liability for product defects, allergic reactions, or misuse.
  - Sanctuary Social is not responsible for Contractor product inventory.

## **7. Alcohol Compliance**

Sanctuary Social retains exclusive control over alcohol service.

Contractor may not:

- Bring outside alcohol
- Serve alcohol
- Offer alcohol as part of ticket packages without written approval

All alcohol service must comply with Kentucky law.

---

## **8. Safety & Conduct**

Contractor agrees to:

- Secure cords, cables, and equipment
- Maintain safe spacing and egress
- Follow fire code and occupancy rules

- Maintain professional conduct consistent with venue standards
- 

### **9. Cancellation**

Event cancellation terms must be agreed upon in writing per booking confirmation.

---

### **10. Governing Law**

This Agreement is governed by the laws of the Commonwealth of Kentucky.
