- Must work within the North Sectional boundaries.
- Assumes responsibility to communicate with all Club owners, coaches, and judges in your Section.
- Must be present at Sectional competitions, State Championships and State Congress.

South Sectional Rep – 2-year term

- Actively worked for the past 2 years at a Washington State Club.
- Must work within the South Sectional boundaries.
- Assumes responsibility to communicate with all Club owners, coaches, and judges in your Section.
- Must be present at Sectional competitions, State Championships and State Congress.

Optional Program Rep – 2-year term

- Actively coached for the past 2 years at a Washington State Club.
- A current Optional level Coach.
- Assumes responsibility to communicate with all club owners and coaches on business pertaining to Optional athletes.
- Assist Educational Rep with the planning of State Congress.
- Must be present at Optional State Championships and State Congress.

Xcel Program Rep – 2-year term

- Actively Coached for the past 2 years at a Washington State Club.
- A current Xcel level Coach.
- Assumes responsibility to communicate with all club owners and coaches on business pertaining to Xcel athletes.
- Assist Educational Rep with the planning of State Congress.
- Must be present at Xcel State Championships and State Congress

NAWGJ Rep – 2-year term

- Been a Professional member in the State of Washington for the past 4 years.
- Have served as a NAWGJWA Officer or Committee member for at least 4 years.
- Works in conjunction with the SJD on the Washington State Congress.

Per Operating Code, State Administrative Committee members must be a minimum of 21 years of age and active in our state's program. Nominations will close on July 15th, 2025. Candidate statements will be posted online, and elections will be held online from July 22nd, 2025 to August 5th, 2025. Newly elected officers will begin their term August 31st.

If there is only one qualified nominee for any position, I, as the State Chairman will cast one vote and no general election will be necessary.
