Rules and Regulations

1. Follow Pennsylvania Vehicle Code laws and regulations and understand that while you are allowed to legally ride on township roadways, you can still be cited for not obeying the laws of the Commonwealth of Pennsylvania.
2. Must have and provide proof of a valid driver's license to operate any all-terrain vehicle on any township roadway.
3. All all-terrain vehicles must be registered and insured.
4. Ride on only approved roads and NEVER enter PRIVATE or STATE owned roadways or properties.
5. Speed limit for all all-terrain vehicles is 20 MPH.
6. Please be considerate to residents while driving.

I understand that by signing this agreement I will follow all the Pennsylvania and Donegal Township ATV rules and regulations, and I will use caution while on any Donegal Township Road.

I agree to follow the speed limit of 20 MPH and understand these roads and streets are public roadways and will be respectful of those that live here.

I agree that any damage that I cause while riding on designated roadways will be at my expense.

I understand that I am riding at my own risk and that Donegal Township , Donegal Township Supervisors, and Donegal Township Employees nor any agency acting on its behalf are responsible for accidents, injuries, or property damage while riding on Donegal Township roadways, I will therefore not hold them responsible for an accident.

You are encouraged to read the Pennsylvania DCNR ATV guidelines, and by signing this agreement, I am agreeing to all terms and regulations set forth by Donegal Township as well as the State of Pennsylvania.

Rules and Regulations:

All riders must follow Pennsylvania Vehicle Code for motorized vehicles (Ch. 7) An all-terrain vehicle (ATV) on a roadway is to follow the same rules and regulations as an automobile. This means **you must have a valid driver's license, obey all traffic signals and signs.**

Permits are per driver, not per machine. Any person that operates a machine must have a permit.

Helmets are required by Pennsylvania law. They are not exempt under the helmet law and must be DOT or SNELL.

All machines must be registered and insured in the state of Pennsylvania or reciprocating state. If you have any questions regarding registrations, please contact DCNR Harrisburg at 1-866-545-2476. Registration plates must be fastened securely on the rear of the machine, and visible.

OPERATION

All riders are to remain to the right side of the roadway giving automobiles the right of way. You must ride in a single file line (NO side by side riding), and must travel at a speed no greater than 20 MPH.

Donegal Township has opened all municipal roads for ATV travel. Travel only designated areas, and in no way shall you ever enter private, state, or other municipal owned roadways or properties.

No excessive noise. All machines must have a muffler and noise kept to a reasonable level in populated areas. An ATV may make a direct crossing of a street or 2 lane highway if:

- a) The crossing is made where no obstruction prevents a quick and safe crossing.
- b) The ATV is brought to a complete stop before crossing the highway.
- c) The driver yields the right-of-way to all oncoming traffic.

When riding ATV's on Donegal Township roads, we simply ask that you use common sense. Be courteous and cooperative with those within the township.

Any permit can and will be revoked for not following the guidelines set forth by Donegal Township and the State of Pennsylvania.
