#### BUILDING PERMITS

It is your responsibility to obtain the proper paperwork for <u>ANY</u> construction prior to beginning any work. If a permit is not applied for, you will be fined 3 (three) times the amount of the permit.

**Butler County Building Permit Application** 

The above forms must be completed whether the building is exempt or not.

Agricultural Buildings are only exempt from the UCC code if it is used for: "a structure used to store farm equipment, hay, seed, grain, or other agricultural or horticultural products. Or, any building used to house poultry, livestock, horses, or other farm animals."



#### SEWAGE PERMITS
