**Basic services of funeral director and staff**.....\$1,295.00

Our basic service charge includes, but is not limited to the following:

Consultation with the family or responsible party, staff and facilities to respond to initial requests for service, coordinating service plans with cemetery, crematory and/or other parties involved in the final disposition of the deceased, securing official documents and necessary registrations, sheltering of the deceased.

Also included in this charge are overhead expenses relative to our facility such as insurance, maintenance and utility expense, secretarial and administrative costs, and equipment and inventory expenses. (This fee is already included for direct cremation, immediate burials and forwarding and receiving remains.)

**Embalming**

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

## Business Policy/Terms of Payment

### Payment policy

- A. Total funeral bill Paid-in-Full at the time of the funeral arrangement conference.
- B. Method of payment by Cashier's Check, Money Order, Visa, MasterCard, Discover, Amex, and Cash.
- C. We do not offer payment plans, financing or accept life insurance as payment.
- D. Cash advance items: (money paid a third party on the client's behalf) are necessary to conduct certain funeral arrangements. Said charges represent a cash outlay without a profit being realized by our firm. Therefore, such cash advance items listed on the statement of funeral goods & services is requested to be paid at the time of the funeral arrangement conference.
- E. Under circumstances where the deceased's estate must stand the burden of paying the funeral expenses, we ask that a friend or family member pay the funeral expenses and file their claim for reimbursement with the deceased estate.
- F. In all cases where the total payment has not been received in ten working days, a late penalty will be charged at the rate of 12% annually or 1% per month on the unpaid balance.
- G. In the event that proper arrangements have not been made within ten working days, delinquent accounts will be reported to our collection agency.
- H. Oral agreements or oral commitments to extend credit or to forebear from enforcing payment of a debt are not enforceable under Michigan State Law.
