

Pool and Park OSDH and LTHOA Rules

OSDH Rules-

Re: OSDH, 310:320-3-3. Rules and precautions for patrons, page 13-14.

1. You must shower before entering the pool.
2. No one with an open wound, bandage, or any symptom of communicable disease allowed in pool.
3. No one may swim alone in this pool.
4. All children under 12 must have an adult responsible for that child at the side of the pool at all times.
5. No running or rough play allowed in the pool area.
6. All cutoffs must be hemmed.
7. All excess body lotion should be removed before entering the pool.
8. 50 person maximum capacity in pool.

LTHOA Rules

1. No foul, or obscene language or clothing allowed in pool area.
2. No alcohol allowed in pool or park area.

****Re: OSDH, (F) See that all persons who Are under the influence of an intoxicating liquor or drugs, are excluded from the shower rooms and the pool area.”OSDH, page 10****

****OSDH, (E) See that no food, drinks, debris, or foreign substances are thrown or carried into the pool. No glass containers of any type may be used in or near the pool. Beverages should be dispensed in paper cups to avoid the hazard of broken glass. Waste containers for disposal of used cups and food wrappers shall be located at convenient points within the walk areas” OSDH, page 10.****

3. No pets allowed in pool or park area

****OSDH, (G) ”See that animals are not allowed in the pool enclosure.” OSDH, page 11.****

4. Maximum of (5) members & guests of same family to use pool at one time.

****Bylaws 15.04, “All members, their families and authorized guests shall have the right to use all of the Association's facilities, including its swimming pool, park and recreational area,**

to the extent permitted by and in accordance with the terms and in the Association's rules which to each membership which is held by other than a single individual, the use of the Association's facilities shall be only by an individual person and the family of such individual person named by such member.” Page 950-951.**

5. No babies not potty trained allowed in pool.

**Re: *Swim Diapers*, “Some research has looked into how well swim diapers and swim pants are able to keep feces (poop) and infection-causing germs from leaking into the pool. Even though swim diapers and swim pants might hold in some solid feces, they are not leak proof. Swim diapers can delay diarrhea-causing germs, like *Cryptosporidium*, from leaking into the water for a few minutes, but swim diapers do not keep these germs from contaminating the water. No manufacturers claim these products prevent leakage of diarrhea into pools.”

6. No colored “T” Shirts allowed as swimsuits.

“T” shirts can become heavy when wet and can weigh a swimmer down creating a drowning risk. Colored shirts may not be “color fast” and may cause damage to the pool filter.

7. No smoking in the pool area.

8. Only members in good standing (dues paid) shall use the pool or facilities.
