We're a 501(c)(3) organization now! What does that mean?

We're excited to share that over the summer, our club officially became a 501(c)(3) nonprofit organization! This new status allows us to receive tax-deductible donations, which will help reduce expenses and taxes on future purchases. It also opens the door for us to apply for grants and participate in vendor events—giving skaters the opportunity to raise funds for the club and/or their personal accounts.

With this change, however, comes a new approach to fundraising. To support the club's continued growth and stability, we encourage all members to participate in our fundraisers in any way they can. Every bit of support helps, especially as we prepare for our largest annual expense: the ice show.

One important update is how fundraising profits will be used. At this time, all proceeds will go toward covering club expenses. If a fundraiser brings in substantial profit or is designated specifically for skaters, we may be able to distribute funds toward individual skater accounts to help with ice show costs. If that happens, the funds will be split equally among all skaters.

If a skater would like to organize their own individual fundraiser to cover personal expenses such as travel, competitions, or ice show fees, please contact Rana Safah first. All funds must go through the club before being reimbursed to the skater. Receipts will be required for reimbursement in case of an IRS audit.

We appreciate your patience as we navigate this exciting new chapter. Your feedback is always welcome as we continue to improve and grow together!

Fundraiser Opportunities for the 2025-2026 Season

The philosophy around fundraising is the board always wants to ensure that we have sufficient funds to operate the ice show and cover monthly business expenses. To do that, we need to have a couple of fundraisers to ensure we are maintaining a stable financial position. Our fundraising committee has been working hard to ensure that we have several opportunities available to earn funds throughout the season to help support these expenses. We try to provide opportunities for goods that are easier to sell and/or are items individuals tend to purchase like chips, pizza, and seasonal plants. We are always open to ideas and suggestions from our members.

As you may or may not know, operating the club is similar to running a small business. There are certain recurring expenses that are needed to remain in compliance with USFS. These expenses include liability insurance, membership fees to the governing council, hosting our

website, and subscriptions to coaching resources. The annual ice show alone costs upwards of \$20,000 to produce with almost half of the costs for ice rental. In order to have the lighting and spotlights the way we do, that costs upwards of \$4,000. Other expenses include director and coaching fees, costumes, and props/decorations. Payments received from ice show registrations typically cover the ice rental fees. Revenue from ticket and lobby sales help close the gap between income and expenses. It's not uncommon to operate at a loss regarding the ice show. Over the last few years, we have been very strategic in our spending and have significantly reduced our losses. The 2025 show we had a loss of about \$2,600, which is still within our loss limit that we are comfortable with, but we aim to break even as much as possible, even when competing with rising costs of expenses.

Currently these are the fundraisers we will be doing (with a few still TBD with details, but we are expecting to be good to go for). We are hoping to be able to add more opportunities this year with our new 501c3 status, but as of this moment don't have extras planned out. When/if we add more, notifications will be sent out via email and posted on our Facebook page. If you have any fundraising suggestions/ideas, please reach out to Pam Larsen.

- Mum Fundraiser- Sell Schwartz's Mums Start Early August, orders Due Sept 10th. Delivery September 19th.
- Better Made Chips- Start taking orders Early August, orders Due Sept. 10th. Delivery Mid/End October (before halloween).
- Sell Schwartz's Wreaths and Poinsettias (if selected by Schwartz)- Start selling at the End of September through Mid-October for delivery before Thanksgiving/November.
- Holiday show gift card basket raffle/ lotto wreath- Start collecting Early- Mid December. Will raffle off at the Holiday show. (Also looking at selling 50/50 tickets at the show)
- Little Caesars Pizza kits start selling at the beginning of January-February online. Sale runs for 1 month.
- Schwartz's \$25 Gift card fundraiser (if selected by Schwartz)- Start selling beginning March with delivery mid April before Greenhouse opens & Mother's Day.
- Collect donation items for Ice Show Raffle- Start date will start when Ice show practices begin, with a due date of one week prior to the show.
- * Fundraisers are subject to change based on availability. Also the start, end, and delivery dates of each fundraiser are subject to change based on availability. For the most current and up-to-date information on fundraisers (current or starting soon) please keep an eye out on your weekly update emails. Current fundraisers will also be posted on our website.

We're also excited to share a great opportunity to support our club and raise funds this year by volunteering at the **2026 Midwestern Synchronized Skating Competition**. Volunteers are needed in a variety of roles, and in return, our club will earn money based on the total number of hours worked.

A big thank you to **Shaun and Tess**, who have generously stepped up as subcommittee chairs for the **Volunteering** and **Procurement** committees. They've already begun logging hours on our behalf!

In the next couple of weeks, we'll be sending out a flyer to gauge initial interest from those willing to donate their time. Freestyle Drop-In Rates:

50 minute full session = \$14 Westland residents / \$15 non-Westland residents 25 minute half session = \$8 Westland residents / \$8.50 non-Westland residents

Monthly punch cards will return this season as well, same policy - one card per individual skater, expires monthly - any unused punches will not transfer to the following month. September cards will be for 8 full sessions / 16 half sessions, you can mix 'n match however you'd like until you've used up the 8 hours!

Volunteer Descriptions

Competition – Saturday, November 1st TIME – Approximately 8:00a.m to 5:00p.m.

The All American Classic is the club's largest fundraiser and helps offset ice show expenses. Jobs include competition check-in desk, ice monitor, results poster, runner (if needed), awards, hospitality, set-up, tear-down. Shaun Taft and Abby Sitarski are the Competition Committee and will be posting positions, descriptions, and time slots using Signup Genius by October 4, 2025. Each family is required to complete a minimum of 4-5 hours of volunteer work, which is mandatory. You will incur a charge of \$100 per family if this requirement is not met. Please feel free to reach out to them should you have any questions.

Holiday Show -

This show is fairly low key, compared to the Ice Show, and is a way for our skaters to celebrate the holiday season and showcase their skills in front of an audience. We typically ask skaters and attendees to make a donation to support a local non-profit. In the past, we have supported Wayne-Westland Schools with hygiene items, collected socks and underwear for families living in a local shelter, and collected food for a pantry. Feel free to connect with Tess Kuehne if you have any ideas for the donation, would like to help decorate the lobby, and have suggestions for lobby sales.

Board Committees – Each Season July 1 – June 30th

Our club is composed of approximately 30 families with about 25 active skaters. Many of those on our board volunteer for a variety of duties and are often spread quite thin. We can always use more help. You don't need to be a board member to participate in a committee or be the point-person for it. The following committees are needed to efficiently manage club business: Competition, Ice Show, Membership, Media, Skater's Advisory, Fundraising, and Nomination. Some committees, such as Membership and Nomination Committee have one yearly project.

Others, such as Fundraising and Media are on-going. This year we are looking at adding an Entertainment Committee, which would help take care of coordinating our Welcome Back Event, Holiday show party, End of Season Event, etc. If you have an interest in learning how you might be able to assist or would like more information, please contact Rachael Alholinna-Kovacs.

Ice Show A member of each skater's family must volunteer for an ice show staff position. Around 6 hours minimum are required per family and MANDATORY participation in set-up and tear-down, one of which must be a show/performance night. You will incur a charge of \$100 per family if this requirement is not met. This tends to be the equivalent of 2-3 time slots/jobs. An ice show volunteer sign-up will be posted online in the spring, detail and a link will be provided via email. SkateSafe certification is required for many of the volunteer positions. More information about SkateSafe requirements will be provided in a separate volunteer sign-up email. Since we always struggle with show date volunteers, one of the required time slots is to be on a show/performance day. Those volunteering on a show night will receive free admission to one of the other performances. Skater Ice Show Requirements will be posted and shared by the beginning of October.

The Board understands that we have busy lives, and our availability is limited. We are always open to discussing reasonable accommodation and making arrangements that are flexible to meet unique needs. Some events, such as the competition and ice show, require volunteers to be on-site to ensure the events run smoothly. We are a small club, but we have many dedicated members who keep this club functioning and make it possible to host shows, events, and training for our skaters. We need all members to show up, take part, and share their time in order to function. Please feel free to reach out to the contact person for the activity if you need accommodation.
