- **Corinthian member (\$60 per year):** One adult (21 years up who has been a full member in good standing, but cannot be a regular participant of Club functions because of travel, moving from the area, illness, or just cause. A member in this category may not vote, hold office, or serve on a committee, but will still be entitled to all other benefits of membership, including reciprocity with other clubs.

- **Junior Member (25\$ per year):** One child (20 years of age or younger) member of a household in which at least one adult or guardian is a Full Member of the Club. A member in this category may not hold office, but may serve on committees.
- **Life Member:** To qualify for this membership, the member must have at least 15 years as a continuous member in good standing, have served the Club with untiring enthusiasm and have attained the age of at least 60 years. A member in this category is not required to pay annual dues, may not vote, hold office, or serve on a committee but will still be entitled to all other benefits of membership, including reciprocity with other Clubs
