### **Additions to Booking TERMS & CONDITIONS**

Negotiated group rates may be offered for a booking of 15 pitches or more at the discretion of the *Sherwood Pines Camping Ltd* to any organisation, and are usually a fixed rate per unit per night which can include up to 6 persons. Dogs are also welcome free of charge, with a maximum of 3 per pitch.

We require a non-refundable £25 deposit per pitch at the time of booking to secure your request, and all balances are to be paid in full at least 30 days prior to arrival by either credit/debit card or bank transfer. Any changes in reducing the numbers after payment will be forfeited. Any additions to increase the number of participants will require payment on amendment.

### **ALLOCATION OF PITCHES FOR YOUR GROUP**

The location of the pitches for your group will be identified by the site team prior to or on arrival, please note, specific pitches cannot be reserved. If you have a request, such as the Rally Field on Bracelands, please make this clear during the booking process. Our Site teams will endeavour to meet your needs, however, we cannot guarantee that all requests can be accommodated.

### **BEHAVIOUR ON SITE**

It is the responsibility of the group lead(s) to ensure all participants act in a courteous and respectful manner at all times, and be mindful not to disrupt other recreational or seasonal campers. Use of the on-site facilities should be left in a clean and orderly fashion for the benefit of all. Our campsites also operate a “quiet please” policy between the hours of 10:30pm and 07:30am with no loud music, or disruptive behaviour accepted.

Neither will we not tolerate any abusive, offensive, violent, or destructive behaviour by a member of your group in any circumstance. Such behaviour may result in all members of your group being asked to leave the site without notice or refund, and possible cancellation of other upcoming bookings from your organisation.

In regards to rubbish, our general waste and recycle bins are not to be used for disposing of items such as old or broken camping equipment/electrical items/ bedding etc. Please take it with you and dispose of it as you would do locally.

### **VEHICLES**

Entry barriers are locked between the hours of 10:00pm and 07.30am. During this time access to site will be on foot only. Barrier codes will be changed weekly and must not be disclosed to anyone other than the pitch occupiers. All guests visiting must report to Reception to obtain the code and settle any guest/visitor fees.

**DANGEROUS FLAMMABLE GOODS, GAS BOTTLES & WOOD.** No goods of a dangerous or flammable nature may be left in a unit whilst it is unoccupied. In line with the **Forestry England** guidelines, burning of **wood** is not permitted which including using wood in stoves, fire pits, BBQ's, or Pizza Ovens on any of our sites. Charcoal/ Gas BBQ's are permitted.

### **LIABILITY**

*Sherwood Pines Camping Ltd* is not liable in respect of loss or damage however caused to the unit, vehicles or its contents, nor under any obligation to take any steps whatsoever to protect the outfit or the said contents. Where the depositor is not the owner, then the depositor is deemed to be the legal agent of the owner thereof.
