## Exhibitor Contract

I acknowledge that I am entering into an agreement with ***This Is Us Bridal Show***. I agree that as a professional, I will conduct myself in a professional manner at ***This Is Us Bridal Show*** in an effort to represent the very best of the professional atmosphere that will be on display.

**Space Rental Payment** – Deposit must accompany the online application.

**Exhibitor Space** – Will be allocated by ***This Is Us Bridal Show*** on a first come basis and ***This Is Us Bridal Show*** reserves the right to relocate participants if the need arises.

**Promotional Materials** – Exhibitor at the show are ONLY to be handing out their own company's promotional material at their space. No flyers, business cards or signs permitted except those of the Exhibiting company.

**Arrangement of space** – Each Exhibitor must stay within the boundaries of their designated area and not infringe on the space of other participants. Participants may not affix any part of their display to the walls or flooring with nails, tape, etc. ***This Is Us Bridal Show*** reserves the right to restrict the use of glaring or irregular lighting effects.

**Noise** – Exhibitor must keep all music, computer generated presentations and sound levels to an acceptable limit in consideration for other participants. ***This Is Us Show Producers*** reserves the right to terminate any participant's rental space who does not comply.

**Set-Up/Take Down** – Set-up is on Sunday, April 19 from 9:00a.m. to 11:30 am. Please ensure set-up is completed by 11:30am at the latest as doors open at 12 noon. Take down will start at the end of the show 3:00 pm. All items must be removed from the hall after the show. Your area must be left clean and free from all garbage/empty boxes please.

**Show Management Liability** – ***This Is Us Show Producers*** shall not be, under any circumstances whatsoever, liable or responsible for: any loss, theft, damage, or personal injury, claims or expenses, customer attendance etc. whatsoever or howsoever caused to any property belonging to or connected to the Exhibitor; any injury, claims or expenses suffered by the Exhibitor(s) by reason of any non-foreseeable change in circumstances necessitating a change of date, time or place of show or abandonment thereof. The Exhibitor agrees to indemnify ***This Is Us Show Producers*** in respect to any such loss, damage, injury claims, costs and expenses as foresaid. Exhibitor must carry their own general public liability insurance covering bodily injury and property damage.

**General** – All matters and questions not covered by these Rules and Regulations are subject to the decision of ***This Is Us Show Producers***. ***This Is Us Show Producers*** shall have full discretion in the interpretation and enforcement of all rules contained herein and the authority to make such amendments thereto as well as governing the conduct of the Exhibitor in the show. Exhibitor agrees to abide by all decision of ***This Is Us Show Producers***.

**Weather** – ***This Is Us Bridal Show*** will be taking place rain, shine or snow. No refunds will be issued to any show vendor/exhibitor due to weather conditions

## Cancellations and Refunds

This Is Us Bridal Show reserves the right to cancel any application, at any point and for any reason, and refund money to the Exhibitor.

Any Exhibitor (or staff) who exhibits violent, aggressive or offensive behavior towards This Is Us Bridal Show, its staff, other Exhibitors, or attendees may result in immediate expulsion. In such a case, all money paid to This Is Us Bridal Show shall be forfeited and further penalties may apply.

**CANCELLATION OF CONTRACT** – If this agreement is canceled by This Is Us Bridal Show Exhibitor for any reason, or by Show Producer because of Exhibitor's default or violation of this agreement, monies paid to Show Producer by Exhibitor shall be retained as follows: If cancellation occurs 30 days or more before the start of the Show, Show Producer shall retain 50% of the total rental and return the balance to Exhibitor.

If cancellation occurs within 30 days of the Show, the entire rental paid to date by Exhibitor shall be retained by Show Producer. The retained rental shall be liquidated damages for the direct and indirect costs incurred by Show Management team for organizing, setting up and providing space for Exhibitor and additional expenses caused by Exhibitor's withdrawal including resetting the space.

**RESTRICTIONS** – ***This Is Us Show Producers*** reserves the right to restrict or remove exhibits, without refund, that have been falsely entered, or are deemed by Show Producer unsuitable or objectionable. This restriction applies to, but is not limited to, noise, P.A. systems, persons, animals, birds, things, conduct, printed matter, or anything of a character that might be objectionable to the Show or Show Staff.
