Re: Estate in Reversion known as 140 North Coast Road, Las Cuevas, Trinidad and Tobago.

Stare Decisis Law

"A state cannot refuse to give foreign nationals their treaty rights because of fear that valid international agreements may possibly not work completely to the satisfaction of state authorities. Under the supremacy clause of the United States Constitution Art. VI, clause 2, state policies as to the rights of aliens to inherit must give way to overriding federal treaties and conflicting arrangements." See **Kolovrat v. Oregon**, 366 U. S. 187, 194, 81 S.Ct. 922 (1961)

We, Kamau Isobar Yingor Bey and Aminah Tabiya Tiye Bey, sui juris, being aboriginal and indigenous Moorish American sovereign national of the continental Americas in the Moroccan Empire, being of legal age, after being duly affirmed according to law, hereby depose and state the following:

1. We are surviving *consanguinity* heirs apparent of the late ancient Moabites (modernly known as Moroccans) from the land of Moab who received permission from the Pharaohs of Kemet to settle and inhabit North-West Africa (Amexem); they were the founders and are the true possessors of the present Moroccan Empire, with their Canaanite, Hittite, and Amorite brethren who sojourned from the land of Canaan seeking new homes. Their dominion and inhabitation extended from North-East and South-West Africa, across the great Atlantis even unto the present North, South, and Central America and also Mexico and the Atlantis Islands, before the great earthquake, which caused the great Atlantic Ocean.
2. Our political status and Class A1 citizenship is aboriginal and indigenous free Moors / Moorish American sovereign nationals of the Moroccan Empire, Maghrib al Aqḍā, North-West Amexem / North America by *jus sanguinis*, and is recognized under registration number ©AA 222141, Class A, with the Clock of Destiny Moorish American National Identification Card and Zodiac Constitution recorded September 10, 1952, in the Library of Congress Copyright Office, Washington, District of Columbia, and the United States Department of Justice.
3. Our Moabite ancestors died intestate, and retain reversionary interest in the lands, territories and resources of the present Moroccan Empire at North America which the foreign hybrid occidental Europeans (et al.) presently occupy and use by de facto usufruct under the expired fifty (50) year mandate, i.e., the Treaty of Peace and Friendship of 1836 (in force 1837) between the United States of North America and the Moroccan Empire; which superseded the Treaty of Peace and Friendship of 1787 between the United States

of America, and his Imperial Majesty the Emperor of Morocco. This Treaty is the supreme Law of the Land under Article VI, clause 2 ('supremacy clause') of the Constitution for the United States of North America; and Article 25 of this Treaty avers the expired duration of such usufruct as follows:

Article 25. This Treaty shall continue in force, with the help of God, for fifty years; after the expiration of which term, the Treaty shall continue to be binding on both parties, until the one shall give twelve months notice to the other of an intention to abandon it; in which case, its operations shall cease at the end of the twelve months."

4. Per our treaty right under Article 22 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire as the surviving rightful heirs apparent, and in accordance with the international law provisions of the United Nations Declaration on the Rights of Indigenous Peoples, we hereby make claim to our inherited ancestral estate in reversion which is being held in trust de facto by the foreign corporate REPUBLIC OF TRINIDAD AND TOBAGO (Inc.) and subsidiaries as escheated fee simple property under color of law. Per the stare decisis law in the *Kolovrate* case mentioned above, our treaty right to inherit property under Article 22 of the said Peace Treaty of 1836 overrides any and all corporate policies of the foreign corporate REPUBLIC OF TRINIDAD AND TOBAGO (Inc.) and subsidiaries that are made to the contrary of the following:

Article 22. If an American citizen shall die in our country and no will shall appear, the Consul shall take possession of his effects, and if there shall be no Consul, the effects shall be deposited in the hands of some Person worthy of Trust, until the Party shall appear who has a right to demand them, but if the Heir to the Person deceased be present, the property shall be delivered to him without interruption; and if a will shall appear, the property shall descend agreeable to that will, as soon as the Consul shall declare the validity thereof.

5. We hereby make an adverse claim of aboriginal title to our ancestral estate in reversion including, but not limited to, the property described below, to wit:

6. ALL that certain plot, piece or parcel of land with resources, buildings and improvements thereon erected, situated, lying and being, known to be located at **County of Saint George, Republic of Trinidad and Tobago**, and designated as Counterfoil Receipt No. 4116074 among INLAND REVENUE SERVICE, District Revenue Office, St George East, Arima, known by street address Lot No C1 North Coast Road, Las Cuevas, Trinidad and Tobago, in Maghrib al Aqsa, North West Amexem, and geographically located on the Atlantis adjoining Island within the dominions of the Moroccan Empire in at coordinates Latitude 10.770399, Longitude -61.396119 (about 506 acres). See Exhibit: A1 attached hereto.
7. The document titled Owner's Aboriginal Title to Allodium - EXHIBIT: B attached hereto shall be used as conclusive proof of our Aboriginal Title and allodium ownership of the above described property under seal of the Consul and General Vizir (Public Minister) for the Moorish National Republic Federal Government, and is made pursuant to the aboriginal land tenure systems, traditions, and customs of our Moorish Nation in accordance with international law under Articles 26, 27, 28, 29, 30, and 37 of the United Nations Declaration on the Rights of Indigenous Peoples.
8. We are, therefore, executing this Affidavit for the purpose of attesting to the truthfulness of the facts set forth herein, and a copy of this Affidavit and the attached Owner's Aboriginal Title to Allodium - EXHIBIT: B will be made viewable for publication purposes and public scrutiny at: www.EnforceTheConstitution.org/Reversion-of-Estates.
9. If there shall be no rebuttal to this Affidavit, being made point-by-point and signed under oath or affirmation by any interested person, and sent to my mailing location within ten (10) days from your receipt of this Affidavit, then this Affidavit and the contents herein stands as prima facie evidence and conclusive proof on record.



Are vested with aboriginal title by inheritance to their ancestral estate in reversion described herein by *jus sanguinis* as rightful heir, and they are the absolute owner, in allodium, of the following Lands: ALL that certain plot, piece or parcel of land with the resources, buildings and improvement thereon erected, situated, lying and being, as an 'ancestral estate in reversion' known by the street address as 140 North Coast Road, Las Cuevas, County of Saint George, Republic of Trinidad and Tobago, and geographically located at the South American continent within the dominions of the Moroccan Empire, Maghrib al Aqṣá, South-West Amexem, at coordinates Latitude 10.770399, Longitude -61.396119 (about 506 acres, but not limited thereto)

SUBJECT to all the stipulations in a private trust titled "Allodial Irrevocable Private Living Trust of Kamau Isobar Yingor Bey and Aminah Tabiya Tiye Bey".
