WRIT OF MANDAMUS

Stare Decisis Law

See Kolovrat v. Oregon, 366 U. S. 187, 194, 81 S.Ct. 922 (1961) ("A state cannot refuse to give foreign nationals their treaty rights because of fear that valid international agreements may possibly not work completely to the satisfaction of state authorities." "Under the supremacy clause of the United States Constitution Art. VI, clause 2, state policies as to the rights of aliens to inherit must give way to overriding federal treaties and conflicting arrangements.")

ORDER

This matter is before the Consular Court on Complainant Lamont Maurice El ex rel.

LAMONT BUTLER-EL claim of treaty rights to inherit his ancestral estate in reversion known as 2345 Mill Road, ALEXANDRIA, Virginia, as reversioner heir apparent by aboriginal title and *jus sanguinis* (right of blood), and a Default Judgment was issued by this Consular Court in favor of the Complainant under consular jurisdiction and entered into case number GV22-6109 in the records of the foreign de facto ALEXANDRIA GENERAL DISTRICT COURT (Inc.) on October 16, 2023, for immediate possession and compensatory damages.

Pursuant to the above stare decisis in the *Kolovrat* case, and Article 20 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire, the Defendants Sonya L. Sacks, Marion W. Jackson, and Omar Aquino, and their heirs, successors, agents, and assigns are hereby COMMANDED to execute the following performance:

1. Deliver immediate possession of the premises commonly known as RESIDENCE INN BY MARRIOTT, ALEXANDRIA OLD TOWN SOUTH, including any Room(s) and / or Suite(s) decided by the Complainant, 2345 Mill Road, ALEXANDRIA, Virginia, in allodium, without interruption; and

 Dismiss with prejudice and close case number GV22-6109 in the records of the foreign de facto ALEXANDRIA GENERAL DISTRICT COURT (Inc.) for lack of jurisdiction and fraud.
