

It is further ORDERED AND ADJUDGED that a Writ of Possession shall be forthwith issued to the Sheriff for Montgomery County, Maryland, upon payment of proper costs therewith; and the Sheriff's office shall forthwith execute the Writ of Possession in accordance with their Treaty obligation under Article 20 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire, which aver the following:

Article 20. If any of the citizens of the United States, or any persons under their protection, shall have any disputes with each other, the consul shall decide between the parties, and <u>whenever the consul shall require any aid or assistance from our government, to enforce his decisions, it shall be immediately granted to him</u>.

There shall be no cause for the Sheriff's office to delay in executing the Writ of Possession.






