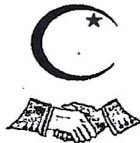

MEMORANDUM

On or about June 7, 2022, Andrea R. S. Watkins, Markisha Gross, Anthony B. Covington, Kristen Schulz, (first name unknown) Micklus #567, William Saunders #453, Devin Arends #515, Richard Swann #656, Maurice S. Johnson #714, and Troy D. Berry (hereinafter “defendants”) were duly served with process at their mailing address (either directly or by their agent) with the Affidavit of Fact: Writ of Quo Warranto [Exhibit: A] from Nina Eliza Bey (hereinafter “complainant”) which was entered in the records of case number D-042-CR-22-000811 of the private foreign de facto corporation named DISTRICT COURT FOR CHARLES COUNTY (Inc.). The defendants were given three (3) days from their receipt of the Writ of Quo Warranto to answer and prove jurisdiction. The defendants failed to answer and prove jurisdiction which constitutes default.

On June 13, 2022, the defendants, Andrea R. S. Watkins and Markisha Gross, issued a misrepresented instrument – bill of attainder / foreign bill of exchange styled as an administrative bench warrant dated June 13, 2022, during a de facto administrative hearing held on that date in case number D-042-CR-22-000811. The de facto administrative bench warrant dated June 13, 2022, was made against the fictitious corporate person / nom de guerre NINA ELIZABETH WASHINGTON (race: Black) under color of law within purview of the unconstitutional 14th Amendment which constitutes fraud in the inducement. See *United States v. Throckmorton*, 98 U.S. 61, 25 L.Ed. 93 (“*Fraud vitiates the most solemn contracts, documents, and even judgments.*”).

On or about June 22, 2022, the defendants were duly served with process at their mailing address (either directly or by their agent) with the Affidavit of Fact: Default Judgment [Exhibit: C] from the complainant which was entered in the records of case number D-042-CR-22-000811, and which ordered for the defendants to dismiss case number D-042-CR-22-000811 and any other

attachments associated thereto for lack of jurisdiction and fraud. There was no cause to the contrary made thereto, however, the defendants failed to execute their duty which constitutes wanton negligence and breach of duty.

On or about June 22, 2022, the defendants were duly served with process at their mailing address (either directly or by their agent) with the Affidavit of Fact: Writ of Error [Exhibit: D] from the complainant which was entered in the records of case number D-042-CR-22-000811, and which ordered that the misrepresented instrument – bill of attainder / foreign bill of exchange styled as a de facto administrative bench warrant dated June 13, 2022, for the fictitious corporate person / nom de guerre NINA ELIZABETH WASHINGTON (race: Black), and any other attachments associated thereto, are unconstitutional, notwithstanding, null and void ab initio, and are unenforceable for lack of jurisdiction and fraud. There was no cause to the contrary made thereto.

Wherefore, it is this 18th day in the month of July, 2022, in the Morocco Consular Court at the Maryland state republic,

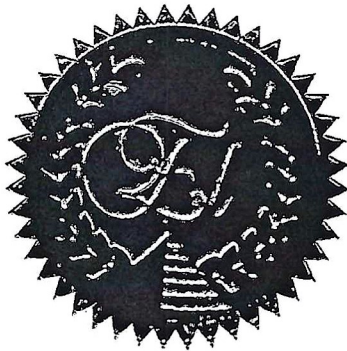
ORDERED AND ADJUDGED that a writ of error be and the same is hereby entered against the defendants, Andrea R. S. Watkins, Markisha Gross, Anthony B. Covington, Kristen Schulz, (first name unknown) Micklus #567, William Saunders #453, Devin Arends #515, Richard Swann #656, Maurice S. Johnson #714, and Troy D. Berry;

It is further **ORDERED AND ADJUDGED** that the misrepresented instrument – bill of attainder / foreign bill of exchange styled as an administrative bench warrant dated June 13, 2022, and any other attachments associated thereto are **UNCONSTITUTIONAL, NOTWITHSTANDING, NULL and VOID AB INITIO** and are **UNENFORCEABLE** for lack of jurisdiction and fraud;


It is further ORDERED AND ADJUDGED that the collusive action and de facto administrative proceedings under color of law in case number D-042-CR-22-000811, in the records of the foreign DISTRICT COURT FOR CHARLES COUNTY (Inc.), including the de facto administrative hearing held on June 13, 2022, and any other attachments associated thereto are UNCONSTITUTIONAL, NOTWITHSTANDING, NULL and VOID AB INITIO and are UNENFORCEABLE and CLOSED for lack of jurisdiction and fraud.
