This lawful notice has been served as notice of your two (2) employees / agents / contractors (name and badge unknown) and their unwarranted harassment activities, or the equivalent thereof, which led to such persons trespassing upon the private property known as [REDACTED]; Welcome, Maryland republic, on September 17, 2022. This private property is protected under consular jurisdiction in accordance with the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire. See the attached documents which were pulled from the records of case number C-08-CV-22-000576 of the foreign CIRCUIT COURT FOR CHARLES COUNTY (Inc.). Per the 'Full Faith and Credit Clause' under Article IV section 1 of the Constitution for the United States of North America, your full faith and credit shall be given to the attached documents recorded in such records.

You are required to **cease and desist** all unwarranted visits to the private property known as 5805 Fire Tower Road, Welcome, Maryland republic, including, but not limited to, any attempt to enforce any instrument styled as a 'Judgment' / 'Order' / 'Injunction' issued under color of law by any representative of the CIRCUIT COURT FOR CHARLES COUNTY (Inc.) and filed in case number C-08-CV-22-000576.

Failure to comply with this lawful cease and desist notice constitutes a breach of your oath and obligation to uphold and support the Constitution for the United States of North America and Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire, and the immediate **forfeiture** of your alleged position as 'Sheriff' along with your oath of office and surety bond, and will result of a lawsuit filed in Morocco Consular Court under consular

jurisdiction seeking monetary damages. This includes all employees / agents / contractors under your command.

MEMORANDUM

On September 9, 2022, Byron David Bell- Bey declared his nationality / citizenship as Moorish American, being an aboriginal and indigenous sovereign national and heir of the Moroccan Empire at North-West Amexem / North America; and made adverse claim to his ancestral estate in reversion known as WELCOME, Maryland republic, by his secured treaty right to inherit under Article 22 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire. See attachments **EXHIBIT: A1** (Affidavit of Fact: Adverse Claim of Title and Reversion of Ancestral Estate dated September 9, 2022), and **EXHIBIT: B** (Affidavit of Dispute); and see **Kolovrat v. Oregon, 366 U. S. 187, 194, 81 S.Ct. 922 (1961)** (*"A state cannot refuse to give foreign nationals their treaty rights because of fear that valid international agreements may possibly not work completely to the satisfaction of state authorities. Under the supremacy clause of the United States Constitution Art. VI, clause 2, state policies as to the rights of aliens to inherit must give way to overriding federal treaties and conflicting arrangements."*).

On September 9, 2022, you, Sharon L. Hancock, acting in collusion with you, Reuben B. Collins II, Edwards Wesley Adams III, Elizabeth Dorothy Theobalds, Sanjiv Das, and Troy D. Berry, filed a misrepresented instrument - bill of attainder / foreign bill of exchange titled WRIT OF SUMMONS dated September 9, 2022, in the de facto records of case number C-08-CV-22-

000576 which was addressed to the fictitious corporate person / nom de guerre BYRON DAVID BELL SR (Race: Black) under color of law within purview of the unconstitutional 14th Amendment which constitutes fraud in the inducement. See **EXHIBIT: A2** attached hereto; and see **United States v. Throckmorton, 98 U.S. 61, 25 L.Ed. 93** (*"Fraud vitiates the most solemn contracts, documents, and even judgments."*).

Furthermore, it has been proved beyond reasonable doubt by conclusive evidence in de facto case number(s) C-08-CR-21-000334, D-042-CR-22-000811, 08-K-13-000884, and citation numbers 0T90W93, 0TF0W93, 0TC0W93, 0TD0W93, and 0TB0W93 in the records of the private foreign de facto CIRCUIT COURT FOR CHARLES COUNTY (Inc.) that the STATE OF MARYLAND (Inc.) and all subsidiaries thereof, including the de facto CIRCUIT COURT FOR CHARLES COUNTY (Inc.), COUNTY COMMISSIONERS OF CHARLES COUNTY (Inc.), and the CHARLES COUNTY SHERIFF DEPARTMENT (Inc.), and representatives thereof, were not delegated Article III judicial authorization and consular jurisdiction to hear and decide 'diversity of citizenship' cases affecting the person and private property of Moorish American nationals in disputes with citizens of the United States, and therefore, lack jurisdiction and venue. See **Elliot v. Peirsol, 26 U.S. 328, 340 (1828)**, (*"Courts are constituted by authority and they cannot act beyond the power delegated to them. If a court acts without authority, its judgments and orders are regarded as nullities. They are not voidable, but simply void; and form no bar to a remedy sought in opposition to them, even prior to a reversal. They constitute no justification; and all persons concerned in executing such judgments, or sentences, are considered, in law, as trespassers."*).

Wherefore, it is this 9th day in the month of September, 2022, in the Morocco Consular Court at the Maryland state republic,

ORDERED AND ADJUDGED that a writ of error be and the same is hereby entered against the defendants, Sharon L. Hancock, acting in collusion with Reuben B. Collins II, Edwards Wesley Adams III, Elizabeth Dorothy Theobalds, and Sanjiv Das, and Troy D. Berry;


It is further **ORDERED AND ADJUDGED** that the misrepresented instrument – bill of attainder / foreign bill of exchange titled WRIT OF SUMMONS dated September 9, 2022, and any other attachments associated thereto are UNCONSTITUTIONAL, NOTWITHSTANDING, NULL and VOID AB INITIO and are UNENFORCEABLE for lack of jurisdiction and fraud;

It is further **ORDERED AND ADJUDGED** that the collusive action and de facto administrative proceedings under color of law in case number C-08-CV-22-000576, in the records of the foreign CIRCUIT COURT FOR CHARLES COUNTY (Inc.), including the de facto administrative hearing on September 9, 2022, and any other attachments associated thereto are UNCONSTITUTIONAL, NOTWITHSTANDING, NULL and VOID AB INITIO and are UNENFORCEABLE and CLOSED for lack of jurisdiction and fraud.



Stare Decisis Law

“A state cannot refuse to give foreign nationals their treaty rights because of fear that valid international agreements may possibly not work completely to the satisfaction of state authorities. Under the supremacy clause of the United States Constitution Art. VI, clause 2, state

policies as to the rights of aliens to inherit must give way to overriding federal treaties and conflicting arrangements.” See **Kolovrat v. Oregon, 366 U. S. 187, 194, 81 S.Ct. 922 (1961)**

I, Byron David Bell-Bey, sui juris, an aboriginal and indigenous Moorish American sovereign national of the Moroccan Empire at Maghrib al Aqṣá, North-West Amexem / North America, being of legal age, after being duly affirmed according to law, hereby depose and state the following:

1. I am one of the surviving *consanguinity* heirs apparent of the late ancient Moabites (modernly known as Moroccans) from the land of Moab who received permission from the Pharaohs of Kemet to settle and inhabit North-West Africa (Amexem); they were the founders and are the true possessors of the present Moroccan Empire, with their Canaanite, Hittite, and Amorite brethren who sojourned from the land of Canaan seeking new homes. Their dominion and inhabitation extended from North-East and South-West Africa, across the great Atlantis even unto the present North, South, and Central America and also Mexico and the Atlantis Islands, before the great earthquake, which caused the great Atlantic Ocean.
2. My nationality / citizenship and political status as an aboriginal indigenous Moorish American sovereign national of the Moroccan Empire and direct descendant of the ancient Moabites (Moroccans) by *jus sanguinis*, is recognized under registration number ©AA 222141, Class A, with the Clock of Destiny Moorish American National Identification Card and Zodiac Constitution recorded by Charles Mosley Bey, a Moorish American and my kin by consanguine, on September 10, 1952, in the Library of Congress Copyright Office, Washington, District of Columbia, and the United States Department of Justice.

3. My Moabite ancestors died intestate, and was vested with reversionary interest in the lands and resources of the Moroccan Empire at North America, which is in de facto occupational use, in usufruct, by the foreign hybrid European colonists exercising feudal law practices under color of law as citizens / members / beneficiaries of the UNITED STATES (Inc.) under the expired fifty (50) year mandate, i.e., the Treaty of Peace and Friendship of 1836 (in force 1837) between the United States of North America and the Moroccan Empire; which superseded the Treaty of Peace and Friendship of 1787 between the United States of America, and his Imperial Majesty the Emperor of Morocco. This treaty is the supreme Law of the Land under the 'Supremacy Clause' of the Constitution for the United States of North America Article VI, clause 2. Article 25 of the aforesaid Treaty of 1836 avers the expiration term as follows:

Article 25. This Treaty shall continue in force, with the help of God, for fifty years; after the expiration of which term, the Treaty shall continue to be binding on both parties, until the one shall give twelve months' notice to the other of an intention to abandon it; in which case, its operations shall cease at the end of the twelve months."

4. Per my treaty right to inherit under Article 22 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire, and in accordance with the international law provisions of the United Nations Declaration on the Rights of Indigenous Peoples, I am competent to make claim to my inherited ancestral estate in reversion as a surviving rightful heir apparent, which is being held in trust de facto by the foreign corporate STATE OF MARYLAND (Inc.) and subsidiaries as escheated fee simple property under color of law within purview of the

unconstitutional 14th Amendment to the United States Constitution. Per the stare decisis law in the *Kolovrat* case mentioned above, my treaty right to inherit property under Article 22 of the said Peace Treaty of 1836 overrides all state policies that are made to the contrary, which aver the following:

Article 22. If an American citizen shall die in our country and no will shall appear, the Consul shall take possession of his effects, and if there shall be no Consul, the effects shall be deposited in the hands of some Person worthy of Trust, until the Party shall appear who has a right to demand them, but if the Heir to the Person deceased be present, the property shall be delivered to him without interruption; and if a will shall appear, the property shall descend agreeable to that will, as soon as the Consul shall declare the validity thereof.

5. I hereby make an adverse claim of aboriginal title to my ancestral estate in reversion as described below, to wit:

ALL that certain plot, piece or parcel of land with resources, buildings and improvement thereon erected, situated, lying and being, known to be located near corporate WELCOME, Maryland republic, known by the street address of
, Welcome, Maryland, at Maghrib al Aqşá, North-West Amexem, and geographically located on the North American continent within the dominions of the Moroccan Empire at Maghrib al Aqşá, North-West Amexem, Latitude 38.501350, Longitude -77.111750, GPS (Global Positioning System) coordinates 38° 30' 4.86" North; and 77° 6' 42.3" West;

6. This claim is made pursuant to the aboriginal land tenure systems, traditions, and customs of my ancient Moabite Foremothers and Forefathers in accordance with international law under Articles 26, 27, 28, 29, 30, and 37 of the United Nations Declaration on the Rights of Indigenous Peoples.
7. The above-described property is registered in a private allodial trust titled: Allodial Irrevocable Private Living Trust of Bryon D Bell- Bey dated September 8, 2022, which I am the Trustee of; and the document titled Memorandum of Trust shall serve as proof of such trust.
8. Any mortgage, hypothecation, lien, encumbrance, or fee simple deed (color of title) attached to my ancestral estate in reversion known as **Welcome, Maryland**, claimed or held by any citizen(s) of the United States via feudal law practice within purview of the 14th Amendment to the United States Constitution, being recorded in the Land Records of CHARLES COUNTY, Maryland, and / or any other de facto records similarly situated, are held to be ineffective, invalid, null, void and unconstitutional per the Congressional Record Proceedings and Debates of the 90th Congress, 1st Session, Volume 113 – Part 12, June 12, 1967, page 15614 (The 14TH Amendment Is Unconstitutional).
9. I am, therefore, executing this Affidavit for the purpose of attesting to the truthfulness of the facts set forth herein.
