For the record, I am Charis Antoinette Wilkinson-Bey, a natural person, in full life, in propria persona, sui juris, authorized representative, ex-rel. CHARIS ANTOINETTE WILKINSON. My nationality / citizenship is Moorish American, being aboriginal and

indigenous national and heir of the Moroccan Empire at North-West Amexem / North America, and a foreign national inhabitant near corporate LAUREL, Maryland.

I hereby rescind the Driver's License (driver's license number:

autograph / signature made thereon nunc pro tunc due to fraud, because such instrument is spurious as it does not identify me, but identifies the fictitious corporate person / nom de guerre CHARIS ANTOINETTE WILKINSON (Race: Black) created by the unclean hands of others under color of law within purview of the unconstitutional 14th Amendment which constitutes denationalization and dehumanization. Furthermore, I am not required to obtain a Driver's License (permission) from you or from any other representative of the foreign de facto MARYLAND DEPARTMENT OF TRANSPORTATION MOTOR VEHICLE ADMINISTRATION (Inc.) in order for me to exercise my unalienable right to travel. See "Universal Declaration of Human Rights" Article 13, 2. Everyone has the right to leave any country, including his own, and to return to his country.

Therefore, the Driver's License (driver's license number:) is void ab initio and unenforceable for lack of jurisdiction and fraud. See United States v. Throckmorton, 98 U.S. 61, 25 L.Ed. 93 ("Fraud vitiates the most solemn contracts, documents, and even judgments.").

Enclosed you will find a copy of the MARYLAND DEPARTMENT OF TRANSPORTATION MOTOR VEHICLE ADMINISTRATION Certified Statement / receipt showing that the Driver's License was voluntarily surrendered on September 7, 2024.
