Please forward the contents of this email and all attachments to Anthony Jerome McAllister in regards to an emergency situation regarding our Moorish-American national Lamont Maurice Butler-EI who is being unlawfully held at the MARYLAND CORRECTIONAL INSTITUTION -JESSUP (Inc.) under a false name and citizenship, i.e., . The Morocco Consular Court requests that Mr. McAllister comply with his constitutional treaty obligations pertaining to:

Lamont Maurice Butler-EI (ex rel. LAMONT BUTLER, DOB: 05/15/1984) SID#3849414, DOC 424942, case number 00424942 in the records of the foreign MARYLAND PAROLE COMMISSION (Inc.)

In accordance to Article 6, 20, 21, and 24 of the Treaty of Peace and Friendship, the Constitution for the United States of America, and the Maryland State Constitution and the oath sworn to by all of its agents, the Morocco Consular Court makes the following demands:

**Demands Without Delay:**

1.

You must **without delay** cease and desist the denationalization of Lamont Maurice Butler-El. Correct the name and citizenship on SID#3849414, DOC 424942, case number 00424942 in the records of the foreign MARYLAND PAROLE COMMISSION (Inc.) are to be corrected to Lamont Maurice Butler-El (Race: Human/asiatic) (Citizenship: Moorish-American). He is not a subject of these dominions and you shall no longer make prize of him or his effects as of receipt of this letter.

2.

In accordance with the United States Department of State Consular Notification and Access Manual, you are obligated to provide our Moorish-American national, Lamont Maurice Butler-El SID#3849414 DOC 424942 case number 00424942), notification and access to his consulate **without delay**.

3.

In accordance with the authority under Articles 20 and 24 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire, and the 'Supremacy Clause' of the Constitution for the United States of North America under Article VI, clause 2, you are to immediately schedule **within (3) three days** a Habeas Corpus hearing for Lamont Maurice Butler-El. You must provide the Morocco Consular Court the date, time, and video-audio access to the hearing.

4.

You are hereby COMMANDED to produce the body of our Moorish-American National, Lamont Maurice Butler-El, being detained on the information of LAMONT BUTLER, DOB: 05/15/1984, SID#3849414, DOC 424942 at the foreign defacto prisoner-of-war camp known as MARYLAND CORRECTIONAL INSTITUTION -JESSUP (Inc.) to be RELEASED forthwith without condition or delay in accordance with Article 6, 20, and 24 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire.

We DEMAND prompt correspondence in regards to the above matter.
