STATEMENT OF CHARGES

It is alleged that the subject of this report has violated the following conditions of supervision:

1. Report as directed to and follow your Parole Agent's Instructions.

On 9/2/2023, Mr. Lamont Butler was released from Charles County Detention Center. Mr. Lamont Butler hasn't made any efforts to report to the Division Parole and Probation Hyattsville Field Office. Mr. Butler is a self-proclaimed sovereign citizen. Based on Mr. Lamont Butler's actions, he doesn't believe in community supervision. The Division of Parole and Probation doesn't have any valid address or cell phone number for Mr. Lamont Butler in order to give reporting instructions for his parole case.

4. Obey all laws

On 12/02/2022, Mr. Lamont Butler was charged with Count-1 CON-FIREARM POSSESSION WITH FELON CONVICTION in Circuit Court for Charles County Maryland case# C-08-CR-22-000652. The offense date was on 11/13/2022. The trial date was on 4/19/2023. On 6/07/2023, Mr. Lamont Butler entered into a plea of nolo contendere to Count-1 CON-FIREARM POSSESSION WITH FELON CONVICTION. Mr. Lamont Butler was sentenced to 10 years suspended all but 405 days with 206 days time served credits with 5 years of unsupervised probation.

10. You must pay a monthly supervision fee as required by law unless the Parole Commission exempts you wholly or partly from payment of the fee.

Mr. Lamont Butler was ordered to pay \$2,650 in supervision vision for parole and \$100 drug testing fee. Mr. Butler paid a total amount of \$566.20. The last payment was on 10/22/2023 for \$150.00. Mr. Butler's outstanding balance is \$2,183.80.

Special Conditions

1. Submit to, successfully complete and pay any required costs for any and all evaluations, treatment programs, testing and aftercare as directed by the Division of Parole and Probation, which may include substance abuse, mental health, anger management, parenting domestic violence and other issues. Take all medications prescribed by your treatment provider.

On 8/8/2019, Mr. Lamont Butler completed the drug/alcohol assessment with Prince George's County Health Department. He tested positive for THC. The recommendation was Continue Urinalysis at a monthly rate. Also, he was referred to the Self-help/other support group via Smart Recovery for up to 4 meetings within 90 days. In the case notes, there are no notations that Mr. Butler went to Smart Recovery, a treatment provider, and participated in monthly drug/alcohol urinalysis.
