### SHOW CAUSE ORDER

Evidence of fraud and swindles

UPON CONSIDERATION of the Petition for Contempt, which alleges that Respondent, Byron Bell, has violated the Order of this Court dated, September 12, 2022, it is hereby,

**ORDERED**, this 5th day of October, 2022, by the Circuit Court for Charles County, Maryland, that Respondent show cause, if any he has, why the relief prayed herein should not be granted; and it is further

**ORDERED**, that the Respondent shall have until the 8th day of November, 2022 to file an answer or response to the Petitioner's Petition for Contempt; and it is further

**ORDERED**, that this matter shall be set for a hearing on 18th day of November, 2022, at 1:30 a.m./p.m., as to whether the Respondent is in contempt of this Court, but only if Defendant has been served on or before the 24th day of October, 2022; and, it is further

**ORDERED**, the Respondent shall appear at the hearing or be subject to arrest.

### TO THE PERSON ALLEGED TO BE IN CONTEMPT OF COURT:

1. It is alleged that you have disobeyed a court order, are in contempt of court, and may be assessed a fine and/or jailed until you obey the court's order.
2. You have the right to have a lawyer. If you already have a lawyer, you should consult the lawyer at once. If you do not now have a lawyer, please note:
  - (a) A lawyer can be helpful to you by:
    - (1) explaining the allegations against you;

Evidence of threat against a foreign national which constitutes treason and acts of war.

- (2) helping you determine and present any defense to those allegations;
  - (3) explaining to you the possible outcomes; and
  - (4) helping you at the hearing.
- (b) Even if you do not plan to contest that you are in contempt of court, a lawyer can be helpful.
- (c) If you want a lawyer but do not have the money to hire one, the Public Defender may provide a lawyer for you.

To find out if the Public Defender will provide a lawyer for you, you must contact the Public Defender after any prehearing conference or master's hearing and *at least 10 business days before the date of a hearing before a judge.*

If no prehearing conference or master's hearing is scheduled, you should contact the Public Defender as soon as possible, *at least 10 business days before the date of the hearing before the judge.*

The Court Clerk will tell you how to contact the Public Defender.

- (d) If you want a lawyer but you cannot get one and the Public Defender will not provide one for you, contact the Court Clerk as soon as possible.
- (e) **DO NOT WAIT UNTIL THE DATE OF YOUR COURT HEARING TO GET A LAWYER.** If you do not have a lawyer before the court hearing date, the judge may find that you have waived your right to a lawyer, and the hearing may be held with you unrepresented by a lawyer.
3. **IF YOU DO NOT APPEAR FOR A SCHEDULED PREHEARING CONFERENCE, MASTER'S HEARING, OR COURT HEARING BEFORE THE JUDGE, YOU WILL BE SUBJECT TO ARREST.**

**Evidence of conspirators committing acts of war and overt acts of treason under color of law**

PETITION FOR CONTEMPT

The County Commissioners of Charles County, Maryland, a body corporate and politic, by and through their attorneys, E. Wesley Adams, County Attorney, Elizabeth D. Theobalds, Deputy County Attorney, and Marc R. Potter, Associate County Attorney, move this Honorable Court to issue a show cause order upon Respondent for constructive civil contempt on the following grounds and reasons:

1. That, on September 8, 2022, Petitioner filed an Emergency Petition for Temporary Injunctive Relief against Respondents for violating the Charles County Code §297-212(61), which prohibits the use of a residential property within the Agricultural Conservation Zone for a "rifle and pistol range, war games, archery ranges or other recreation using weapons" absent a special exception permit allowing such activities.
2. On September 9, the Court held a hearing on the Petitioner's request and issued an order that day granting the Petitioner's request. The written order, filed by this court on September 12, 2022, ordered that:

"the discharge or shooting of any firearms by the Respondent or any other person on the property in question is prohibited . . ." and further ordered that "the injunction shall remain in full force and effect until the Respondents obtain the requisite special exception . . ."

3. Respondents [redacted] canceled the event which prompted the filing of the injunction request and subsequently removed all of their possessions from the property known as [redacted]. Although they continue to receive calls from the Charles County Sheriff's Office for the discharge of firearms at the property, they maintained they have not engaged in the prohibited conduct since the order was issued.
4. That Respondent, Byron Bell, owns the subject property located at Welcome, Maryland 20673.

5. Since the injunction was issued, Respondent Byron Bell has continued to utilize the subject property to discharge and shoot firearms in direct violation of the September 12, 2022, Order issued by this Court.
6. Since the injunction order was issued, it has been reported that the discharge of firearms routinely occurs on several days of the week but especially on Sundays from approximately 11:00 a.m. – 8:00 p.m., though it is not limited to any specific time of day. Continuous gunfire has been reported as heard by the owners of neighboring properties, both inside and outside their homes.
7. It is reported that Respondent Byron Bell intends to host an event advertised as “Sunday Gunday” at the subject property beginning on September 25, 2022, and for every Sunday thereafter. Promotional materials for “Sunday Gunday” are attached and referenced herein as Exhibit A.
8. As of this date, Respondent has neither applied for nor has been granted a special exception to discharge or shoot any firearms on the subject property.
9. Respondent’s lack of compliance with the September 12, 2022, Order and subsequent expansion of the violative behavior is willful and constitutes contempt of Court.


WHEREFORE, the Petitioner requests this Honorable Court to:

- A. Schedule a hearing to show cause why Respondent should not be found in contempt of the Order dated September 12, 2022;
- B. Issue an order requiring the Respondent, Byron Bell to appear at the scheduled hearing to show cause why he should not be found in contempt for his willful failure to comply with the Order of this Court; and
- C. Find the Respondent Byron Bell in contempt for violating the Order of this Court and impose sanctions against him as this case may require including incarceration.; and
- D. For any such other and further relief as the nature of this cause may require.

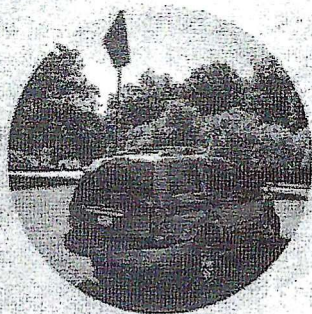
