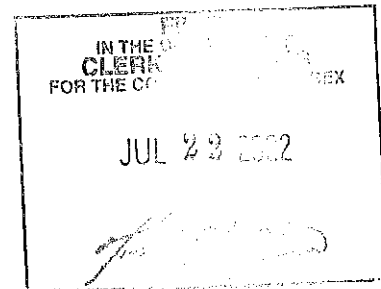

## MEMORANDUM

On December 6, 2021, you, Laurence D. Pierce, Shannon Frison, James Budreau, Michael A. Sullivan, Christopher Mason, Marian T. Ryan, and Graham Van Epps (hereinafter “defendants”) were duly served with process at their mailing address (either directly or by their agent) with the Affidavit of Fact: Writ of Quo Warranto [Exhibit: A1] from Quinn Khabir El (hereinafter “complainant”) which was entered in the records of case number 2181-CR-0362 of the private foreign de facto corporation named MIDDLESEX COUNTY SUPERIOR COURT (Inc.). The defendants were given three (3) days from their receipt of the Writ of Quo Warranto to answer and prove jurisdiction. The defendants failed to answer and prove jurisdiction which constitutes default.

On January 28, 2022, the defendants were duly served with process at their mailing address (either directly or by their agent) with the Affidavit of Fact: Default Judgment [Exhibit: D1] and the Affidavit of Fact: Writ of Error [Exhibit: C1] from the complainant which was entered in the records of case number 2181-CR-0362, and which ordered for the defendants to dismiss case number 2181-CR-0362 and any other attachments associated thereto for lack of jurisdiction and fraud. There was no cause to the contrary made thereto, however, the defendants failed to execute their duty which constitutes wanton negligence and breach of duty.

On January 31, 2022, the defendants were duly served with process at their mailing address (either directly or by their agent) with the Writ of Habeas Corpus Ad Subjiciendum issued from this Morocco Consular Court by Consul General Lamont Maurice El for the immediate release of Quinn Khabir El [detained ex rel. QUINN CUMBERLANDER, ID #0711662] from unlawful

imprisonment. There was no cause to the contrary made thereto, however, the defendants failed to execute their duty which constitutes further wanton negligence and breach of duty.

On May 27, 2022, the defendants, James Budreau, Michael A. Sullivan, issued a misrepresented instrument – bill of attainder / foreign bill of exchange titled ORDER dated April 7, 2022, against the fictitious corporate person / nom de guerre QUINN CUMBERLANDER (race: Black) during a de facto administrative hearing held on that date for the ‘collusive action’ in the records of case number 2181-CR-0362 under color of law within purview of the unconstitutional 14<sup>th</sup> Amendment which constitutes fraud in the inducement. See **United States v. Throckmorton**, 98 U.S. 61, 25 L.Ed. 93 (“*Fraud vitiates the most solemn contracts, documents, and even judgments.*”).

Wherefore, it is this 20<sup>th</sup> day in the month of July, 2022, in the Morocco Consular Court at the Maryland state republic,

**ORDERED AND ADJUDGED** that a writ of error be and the same is hereby entered against you, Laurence D. Pierce, Shannon Frison, James Budreau, Michael A. Sullivan, Christopher Mason, Marian T. Ryan, and Graham Van Epps;

It is further **ORDERED AND ADJUDGED** that you, Laurence D. Pierce, Shannon Frison, James Budreau, Michael A. Sullivan, Christopher Mason, Marian T. Ryan, and Graham Van Epps are guilty of TREASON and MISPRISON OF TREASON for attempting to overthrow the supreme Law of the Land for that of color of law by color of authority;

It is further **ORDERED AND ADJUDGED** that the misrepresented instrument – bill of attainder / foreign bill of exchange titled ORDER dated April 7, 2022, and any other attachments

associated thereto are UNCONSTITUTIONAL, NOTWITHSTANDING, NULL and VOID AB INITIO and are UNENFORCEABLE for lack of jurisdiction and fraud;

It is further **ORDERED AND ADJUDGED** that the collusive action and de facto administrative proceedings under color of law in case number 2181-CR-0362 in the records of the foreign MIDDLESEX COUNTY SUPERIOR COURT (Inc.), including the de facto administrative hearing held on April 7, 2022, and any other attachments associated thereto are UNCONSTITUTIONAL, NOTWITHSTANDING, NULL and VOID AB INITIO and are UNENFORCEABLE and CLOSED for lack of jurisdiction and fraud;


It is further **ORDERED AND ADJUDGED** that the Writ of Habeas Corpus Ad Subjiendum issued from this Morocco Consular Court and entered in case number 2181-CR-0362 on January 31, 2022, for the immediate release of Quinn Khabir El [ex rel. QUINN CUMBERLANDER, ID #0711662] is still VALID and ENFORCEABLE per the 'Full Faith and Credit clause' in the Constitution for the United States of North America under Article 4, section 1.



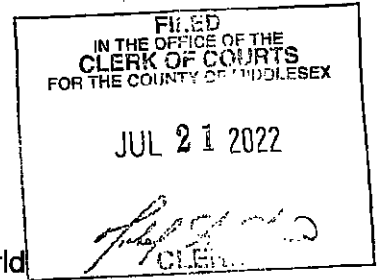
## Stare Decisis Law

See **Kolovrat v. Oregon**, 366 U. S. 187, 194, 81 S.Ct. 922 (1961) (“*A state cannot refuse to give foreign nationals their treaty rights because of fear that valid international agreements may possibly not work completely to the satisfaction of state authorities. Under the supremacy clause of the United States Constitution Art. VI, clause 2, state policies....must give way to overriding federal treaties and conflicting arrangements.*”).

For the record, I am Quinn Khabir El, a natural person, in full life, in propria persona, sui juris, de jure. I come now making special appearance under duress as authorized representative, ex rel. QUINN CUMBERLANDER.

I hereby rescind *nunc pro tunc* and hold as null and void ab initio my autograph / signature on the instrument titled ORDER OF PRETRIAL CONDITIONS OF RELEASE dated May 10, 2022, which was addressed to the fictitious corporate person / nom de guerre: QUINN CUMBERLANDER (race: Black) on the grounds of me signing such instrument “Under Duress and Protest” which constitutes fraud in the inducement.
