Stare Decisis Law

See Elliot v. Peirsol, 26 U.S. 328, 340 (1828), ("Courts are constituted by authority and they cannot act beyond the power delegated to them. If a court acts without authority, its judgments and orders are regarded as nullities. They are not voidable, but simply void; and form no bar to a remedy sought in opposition to them, even prior to a reversal. They constitute no justification; and all persons concerned in executing such judgments, or sentences, are considered, in law, as trespassers.").

On April 7, 2022, the foreign hybrid European male James Budreau, who was acting in collusion with the several other foreign hybrid Europeans name Kristen Buxton, Laurence D. Pierce, Shannon Frison, Michael A. Sullivan, [Lt. Colonel] Christopher Mason, Marian T. Ryan, and Graham Van Epps filed in the records of case number 2181-CR-00362 a misrepresented instrument - bill of attainder / foreign bill of exchange titled ORDER dated April 7, 2022, which was addressed to the fictitious corporate person / nom de guerre QUINN CUMBERLANDER (race: black) under color of law by color of authority within purview of the unconstitutional 14th amendment with the intent to misrepresent my several international documents, i.e., the Affidavit of Fact: Writ of Quo Warranto [Exhibit: A1] entered on December 6, 2021; the Affidavit of Fact: Writ of Error [Exhibit: C1] entered on January 28, 2022; and the Affidavit of Fact: Default Judgment [Exhibit: D1] entered on January 28, 2022, to be "motions" which constitutes altering evidence by fraudulent misrepresentation.

On July 14, 2022, the foreign hybrid European male Laurence D. Pierce, who was acting in collusion with the several other foreign hybrid Europeans name James Budreau, Kristen Buxton, Shannon Frison, Michael A. Sullivan, [Lt. Colonel] Christopher Mason, Marian T. Ryan, and Graham Van Epps filed in the records of case number 2181-CR-00362 a misrepresented instrument - bill of attainder / foreign bill of exchange titled NOTICE TO APPEAR FOR MOTION HEARING dated July 14, 2022, which was addressed to the fictitious corporate person / nom de guerre QUINN CUMBERLANDER (race: black) under color of law by color of authority within purview of the unconstitutional 14th amendment, which constitutes fraud in the inducement.

On July 15, 2022, the foreign hybrid European male Laurence D. Pierce, who was acting in collusion with the several other foreign hybrid Europeans name James Budreau, Kristen Buxton, Shannon Frison, Michael A. Sullivan, [Lt. Colenel] Christopher Mason, Marian T. Ryan, and Graham Van Epps filed in the records of case number 2181-CR-00362 a misrepresented instrument - bill of attainder / foreign bill of exchange titled NOTICE TO APPEAR FOR FINAL TRIAL CONFERENCE dated July 15, 2022, which was addressed to the fictitious corporate person / nom de guerre QUINN CUMBERLANDER (race: black) under color of law by color of authority within purview of the unconstitutional 14th amendment, which constitutes fraud in the inducement.

On July 22, 2022, the foreign hybrid European female Kristen Buxton, who was acting in collusion with Laurence D. Pierce, James Budreau, Shannon Frison, Michael A. Sullivan, [Lt. Colonel] Christopher Mason, Marian T. Ryan, and Graham Van Epps filed in the records of case number 2181-CR-00362 a misrepresented instrument - bill of attainder / foreign bill of exchange styled as a de facto administrative bench warrant dated July 22, 2022, against the fictitious corporate person / nom de guerre QUINN CUMBERLANDER (race: black) under color of law by color of authority within purview of the unconstitutional 14th amendment with the intent to denationalize and have me kidnapped and held hostage for profit in unlawful imprisonment as surety for QUINN CUMBERLANDER (race: black) against my consent which constitutes fraud in the inducement, collusion, conspiracy to kidnap and treason. See United States v.

Throckmorton, 98 U.S. 61, 25 L.Ed. 93 ("Fraud vitiates the most solemn contracts, documents, and even judgments.").

WHEREFORE, it is hereby **ORDERED AND ADJUDGED** that a Writ of Error be and the same is hereby entered against you, Kristen Buxton, Laurence D. Pierce, James Budreau, Shannon Frison, Michael A. Sullivan, [Lt. Colonel] Christopher Mason, Marian T. Ryan, and Graham Van Epps;

It is further **ORDERED AND ADJUDGED** that you, Kristen Buxton, Laurence D. Pierce, James Budreau, Shannon Frison, Michael A. Sullivan, [Lt. Colonel] Christopher Mason, Marian T. Ryan, and Graham Van Epps, are guilty of **TREASON** and **MISPRISION OF TREASON** by your overt acts in case number 2181-CR-00362 of attempting to overthrow the sovereign people and supreme Law of the Land under color of law by color of authority within purview of the unconstitutional 14th Amendment;

It is further **ORDERED AND ADJUDGED** that the misrepresented instruments – bills of attainder / foreign bills of exchange styled as a de facto ORDER dated April 7, 2022; the instrument titled NOTICE TO APPEAR FOR MOTION HEARING dated July 14, 2022; the instrument titled NOTICE TO APPEAR FOR FINAL TRIAL CONFERENCE dated July 15, 2022; and the de facto administrative bench warrant instrument dated July 22, 2022, which were all addressed to the fictitious corporate person / nom de guerre QUINN CUMBERLANDER (race: black), and any other attachments associated thereto are **NULL and VOID AB INITIO** and are **UNENFORCEABLE** for lack of jurisdiction and fraud.
