Greetings from the Moorish Nation,
The Aboriginal Natural People of the Land:

This 'International Proclamation' is made on behalf of all the aboriginal Moorish-American nationals dwelling on the inherited terrestrial Lands of our Fore-Mothers and Fore-Fathers within the dominions of the Moroccan Empire - specifically Northwest Amexem / Northwest Africa / North America / 'The North Gate', also referred to as the 'Continental United States of North America'; and is made subsequent to the previous 'International Proclamation' dated August 4, 2011, addressed to the past President Barack Obama from our Public Minister Taj Tarik Bey and Dominus Nobilis El-Bey, a copy is enclosed herewith. This international proclamation also serves as a formal notice of the historical and ongoing grievances faced by Moorish-American nationals, emphasizing the need to address the colonialism, feudal law practices, genocide, peonage and war crimes that have been perpetuated against our people under the 'Black Code' color of law due to perverse 'European Colonial Occupation' in the name of Unam Sanctam Hegemony practices since the abolition of slavery by the last republican President Abraham Lincoln and from time immemorial.

It is imperative to bring to your attention that ever since the United States Consular Courts in Morocco were abolished in 1956, there has been no lawful consular court and venue available to settle diversity of citizenship cases between aboriginal Moorish-American nationals of the land and the descendants of the occupying foreign occidental European colonists and their subjects being referred to as "citizens of the United States" under the plausible 14th Amendment. This is pursuant to Article III, Section 2 of the Constitution for the United States of America, which outlines the judicial powers and responsibilities in cases of diversity of citizenship.

Furthermore, the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire, specifically Articles 20 and 21, stipulates the role of the Consul in resolving disputes. Article 20 states:

Article 20. If any of the Citizens of the United States, or any Persons under their Protection, shall have any disputes with each other, the Consul shall decide between the Parties and whenever the Consul shall require any Aid or Assistance from our Government to enforce his decisions it shall be immediately granted to him.

Due to the relinquishment of the extraterritorial jurisdiction of the United States in the Moorish Empire by past President Dwight D. Eisenhower with a Memorandum dated September 15, 1956, and the abolishment of the United States consular courts in Morocco by the Act of August 1, 1956 – Public Law 856, the treaty provisions have not been upheld. As a result, Moorish-American people have been subject to colonialism which includes feudal law operations and collusive actions under color of law, exploitation of our lands and resources, kidnapping, human and child trafficking, peonage, physical and civil death, and genocide via unconstitutional bills of attainder under the ‘Black code’ color of law used for slavery (connotatively speaking) and involuntary servitude. The absence of a lawfully sanctioned consular court with competent jurisdiction and venue to address disputes between Moorish-American nationals and citizens of the United States under international treaty law compromises their treaty rights and contravenes the Treaty of Peace and Friendship of 1836 which is the supreme Law of the Land under Article VI, clause 2 of the Constitution for the United States of North America.

Pursuant to the stare decisis law in the case **Clearfield Trust Co. vs United States**, 318 U. S. 363 – 371 (1942), the United States of North America lost its sovereignty status as a government, and has been operating rouge as a private de facto democracy corporation by the use of “private commercial paper” (Federal Reserve Notes) and securities (Checks), which are unconstitutional and constitutes a blatant overthrow of the ‘Gold and Silver clause’ under Article I, section 10 clause 1 of the Constitution for the United States of North America, and such acts constitutes treason, misprision of treason, and a breach of commercial trust of all representatives of the United States (Inc.) / UNITED STATES (Inc.) / UNITED STATES OF AMERICA (Inc.), etc.

Pursuant to the Decolonization Resolution 1514 passed by the United Nations General Assembly on December 14, 1960, immediate steps were to be taken to transfer all powers to the aboriginal Moorish-American peoples of those territories, without any conditions or reservations, in order to put an end to colonialism and the reversion of our lands and resources under the practice of feudalism, color of law, color of authority, color of title, and color of office.

I recall back in 2020, when you told "Fox & Friends" co-host Brian Kilmeade in a Sunday evening special that your message to [the so-called] “Black Americans” who demanded the removal of monuments that honored confederate slave owners was this: *"You have to learn" about "your history."* You also added: *"We have a great country. We have the greatest country on Earth. We have a heritage; we have a history, and we should learn from the history. And if you don't understand your history, you will go back to it again. You will go right back to it. You have to learn. Think of it, you take away that whole era, and you're going to go back to it sometime. People won't know about it. They're going to forget about it. Now, what I do like? I like the idea of building new statues to people – to great people. People that have done something. And I think that's Ok."*

I speak on behalf of all erudite aboriginal Moorish-Americans that have successfully learned about our omitted history and culture when I say you are correct, and this is our answer to your profound message: We Moorish-Americans are First Nation – being the posterity of We the People of the United States, i.e., the Haudenosaunee / Ongweh'onweh Confederacy of Nations by *jus sanguinis*.

On July 2012, I was commissioned to the Office of Consul of Morocco at the Maryland state by the Moorish-American people of the Piscataway and Nacotchtank (Anacostan) Lands near the foreign Maryland state and District of Columbia to answer the ‘Divine Warning by the Prophet for the Nations’, where Prophet El Hajj Sheikh Sharif Abdul Ali (Noble Drew Ali) called on all true American citizens that stand for a Free National Government, and the enforcement of the constitution to help him in his great missionary work in saving our people who have fallen from the constitutional laws of the government, to get them back to the constitutional fold again, that they will learn to love instead of hate, and will live according to Love, Truth, Peace, Freedom and Justice, supporting our free national Constitution for the United States of America. Because day by day they have been violating the national and constitutional laws of their government by claiming names and principles that are unconstitutional.

On October 2020, I was elected by the Moorish-American people to the Office of the Consul General of Morocco for the restoration of consular jurisdiction and venue at North America. As you say, “Let’s Make America Great Again”, I shall support your statement in my great missionary work of

enforcing the constitution and treaty with the help of all other true American citizens that stand for a Free National Government; and through my connection with the Moorish Divine and National Movement and the reuniting of Asia, we can begin the process of decolonization for the restoration, restitution, and reversion of our ancestral estates back to the true and rightful aboriginal Moorish-American heirs apparent of the land under consular jurisdiction and venue.

WHEREFORE, this international declaration is made to announce my authority as Consul General of Morocco at North America and other parts of the American continent and islands within the dominions of the Moroccan Empire in accordance with the provisions of the Treaty of Peace and Friendship of 1836. All qualified Moorish-American nationals that have undergone a nationalization process and have successfully passed a security clearance screening and background check under the authority of my office or any other consul / minister officer under my chain of command are under our consular jurisdiction and protection pursuant to their treaty rights secured by the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire; and pursuant to the case *Kolovrat v. Oregon*, 366 U. S. 187, 194, 81 S.Ct. 922 (1961) where the Supreme Court of the United States rendered the following stare decisis law:

"A state cannot refuse to give foreign nationals their treaty rights because of fear that valid international agreements may possibly not work completely to the satisfaction of state authorities."

"Under the supremacy clause of the United States Constitution Art. VI, clause 2, state policies as to the rights of aliens to inherit must give way to overriding federal treaties and conflicting arrangements."

This International Proclamation and Restoration of Consular Jurisdiction and Venue at North America is a Declaration of National Standing, and a Published Reclamation of Estate at Law
