- I, Lamont Maurice El ("Affiant"), being of lawful age, and being first duly sworn upon affirmation, depose and say:
 - 1. I am a Moorish American national of the Moroccan Empire at Maghrib al Aqṣá, North-West Amexem / North America, being an aboriginal and indigenous free Moor / Muur and rightful heir to the land by jus sanguinis. My nationality / citizenship and political status is recognized under copyright registration number AA 222141 with our Clock of Destiny Moorish American National Identification Card and Zodiac Constitution in the Library of Congress Copyright Office, Washington, District of Columbia.
 - 2. I am a foreign national inhabitant at the Maryland state republic near the District of Columbia republic territory, and my treaty rights are secured under the provisions of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire, and the 'Supremacy Clause' of the Constitution for the United States of North America Article VI, clause 2.
 - 3. I am presently being arbitrarily denationalized and deprived of my liberty while being held hostage for profit as surety for the fictitious corporate person / nom de guerre LAMONT BUTLER, DOB: 05/15/1984, DPP#: 0416500A, SID: 3849414, DOC: 424942 (Race: black) under color of state and involuntary servitude (parole) within purview of the unconstitutional 14th Amendment under the custody of the foreign occidental European male name David R. Blumberg, (acting as) Commissioner and Chairman of the MARYLAND PAROLE COMMISSION (Inc.), who has the following address:

MARYLAND PAROLE COMMISSION (Inc.) 300 East Joppa Road, Suite 1000 Towson, Maryland republic

- 4. I further assert that my unlawful imprisonment includes the following circumstances:
 - On March 13, 2014, near corporate LA PLATE, Maryland state republic, I made a special appearance before the foreign occidental European female name Amy J. Bragunier, (acting as) Chief Administrative clerk of the private foreign for-profit corporate entity CIRCUIT COURT FOR CHARLES COUNTY (Inc.) for case number 08-K-13-000884 as authorized rep., ex rel. (nom de guerre) LAMONT MAURICE BUTLER under duress and protest, only to object to the foreign jurisdiction and improper venue of the CIRCUIT COURT FOR CHARLES COUNTY (Inc.). Amy J. Bragunier then acted under color of authority by issuing a void misrepresented instrument - bill of attainder / foreign bill of exchange titled Judgment dated March 13, 2014, against the nom de guerre LAMONT MAURICE BUTLER (race: black) in want of jurisdiction; and on a later date, Amy J. Bragunier issued another void misrepresented instrument - bill of attainder / foreign bill of exchange titled ORDER dated April 9, 2014, against the nom de guerre LAMONT MAURICE BUTLER (race: black) in want of jurisdiction. I was then arbitrarily kidnapped, denationalized, and held hostage for profit as surety for LAMONT MAURICE BUTLER (race: black) against my consent in involuntary servitude under color of state law within purview of the unconstitutional 14th Amendment. Both instruments (judgment and order) are null and void ab initio for lack of jurisdiction and fraud. See Elliot v. Peirsol, 26 U.S. 328, 340 (1828), ("Courts are constituted by authority and they cannot act beyond the power delegated to them. If a court acts without authority, its judgments and orders are regarded as nullities. They are not voidable, but simply void; and form no bar to a remedy sought in opposition to them, even prior to a reversal. They constitute no justification; and all persons concerned in executing such judgments, or sentences, are considered, in law, as trespassers.").

- b. On April 9, 2014, I was arbitrarily transferred to the physical custody of the 14th Amendment corporate person acting as Commissioner of the private foreign de facto for-profit corporate entity DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES (Inc.).
- c. On July 11, 2019, near corporate BALTIMORE CITY, Maryland state republic, I was arbitrarily transferred to the custody of the foreign occidental European male name David R. Blumberg, (acting as) Commissioner and Chairman of the private foreign de facto for-profit corporate entity MARYLAND PAROLE COMMISSION (Inc.), a subsidiary of DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES (Inc.), in accordance with the spurious misrepresented instrument - bill of attainder / foreign bill of exchange titled Order for Release on Parole dated July 11, 2019, which was addressed to the fictitious corporate stateless person / nom de guerre LAMONT BUTLER (race: black) under color of law within purview of the plausible 14th Amendment. I signed the words "Under Protest" and "Without Prejudice" on the spurious Order for Release on Parole instrument dated July 11, 2019, to declare the act against my will, and to affirm the reservation of all my rights, and to exonerate myself from any obligations set forth therein. Thus, the Order for Release on Parole instrument dated July 11, 2019, is null and void ab initio and unenforceable for fraud in the inducement. See attachment EXHIBIT: A2 - copy of "pages 1 - 3" of the Order for Release on Parole dated July 11, 2019. Also see United States v. Throckmorton, 98 U.S. 61, 25 L.Ed. 93 ("Fraud vitiates the most solemn contracts, documents, and even judgments.").
- d. On January 31, 2020, I executed an Affidavit of Rescission of Signature [Exhibit: J] with attachments Exhibits: B1, B2, B3, F1, F2, K, K1, and K2, which were entered in the records of case number 08-K-13-000884 of the CIRCUIT COURT FOR CHARLES COUNTY (Inc.), and which served as my signature being rescinded on the Order for Release on Parole instrument dated July 11, 2019. On February 3, 2020, David R. Blumberg was duly served

with the Affidavit of Rescission of Signature [Exhibit: J] at his address by and through the 14th Amendment U.S. citizen – subject female Susan Howe Baron, (acting as) assistant attorney general for the DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES (Inc.), via United States Postmaster – certified mail with return receipt (article no.: 7019 0160 0000 9724 8604). There was no answer/response or cause made to the contrary by David R. Blumberg and Susan Howe Baron, which constitutes their default and their admission by silence to the assertions made in the Affidavit of Rescission of Signature [Exhibit: J]. Thus, the Affidavit of Rescission of Signature [Exhibit: J] stands as prima facie evidence and conclusive proof of my signature being rescinded, and the Order for Release on Parole instrument dated July 11, 2019, being void ab initio and unenforceable. See attachment EXHIBIT: A1 – copy of United States Postmaster Certified Mail Receipt and Return Receipt.

5. This case is a 'diversity of nationality / citizenship' issue between I, Lamont Maurice El, an aboriginal and indigenous Moorish American national of the Moroccan Empire, and David R. Blumberg, a foreign occidental European male U.S. corporate citizen – subject under the plausible 14th Amendment. Thus, in accordance with federal common law this case arises under Article III, section 2 of the Constitution for the United States of North America, and the provisions of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire. The Morocco Consular Court at the Maryland state republic has the proper consular jurisdiction and venue to enforce my treaty rights for my immediate release from the unlawful custody of David R. Blumberg and the MARYLAND PAROLE COMMISSION (Inc.) pursuant to Articles 6 and 20 of the said treaty, which aver the following:

Article 6. (in relevant part) ...if any Moor, not a subject of these dominions, shall make prize of any of the citizens of America, or their effects, and bring them into any of the ports of his Majesty, they shall be immediately released, as they will then be considered as under his Majesty's protection.

Article 20. If any of the citizens of the United States, or any persons under their protection, shall have any disputes with each other, the <u>Consul shall decide between</u>

the parties, and whenever the Consul shall require any aid or assistance from our government, to enforce his decisions, it shall be immediately granted to him.

6. In support of my treaty rights, the Supreme Court of the United States issued the following stare decisis law in the case *Kolovrat v. Oregon, 366 U. S. 187, 194, 81 S.Ct. 922 (1961)*:

"A state cannot refuse to give foreign nationals their treaty rights because of fear that valid international agreements may possibly not work completely to the satisfaction of state authorities. Under the supremacy clause of the United States Constitution Art. VI, clause 2, state policies...must give way to overriding federal treaties and conflicting arrangements."







- 8. You shall conduct yourself as not to present a danger to yourself or others
- 9. Special conditions: See page 1 of this agreement.

NOTE: Conditions 10 and 11 apply to parolees whose term of confinement resulted from a crime or crimes committed on or after May 1, 1991.

- 10. You must pay a monthly supervision fee as required by law unless the Parole Commission exempts you wholly or partly from payment of the fee.
- 11. If ordered by the Parole Commission to undergo drug or alcohol abuse testing, you must pay for the testing if required to do so by the Division of Parole and Probation.

I have read, or have had read to me, the foregoing conditions of parole and any special conditions. I fully understand them and I agree, in consideration of granting of parole to observe and abide by such conditions of parole. Further, I hereby waive extradition to the state of Maryland and expressly agree that I will not contest any effort to return to the State of Maryland in consequence of my violating and of the terms and conditions of this parole.
