

In January of 2013, Lamont Maurice Butler (aka Lamont Fl. Lamont Maurice El, Lamont Butler El) attempted to seize possession of a residential property located at the second of the residence using various fraudulent Moorish American national." He gamed entry to the residence using various fraudulent Moorish documents which made claims that Butler was the rightful owner of the property. He was ultimately convicted of First-Degree Burglary, Conspiracy to Commit First-Degree Burglary, Attempt Theft Over \$100,000.00, and Fraud for the incident in Montgomery County Circuit Court (Case Number 123483C).

On September 23, 2020, Lamont Butler showed up at the Central Files Department in the Montgomery County Circuit Court to review case files. The documents which he sought to review were related to, and catalogued under, Case Numbers 123483C and 122514C. The documents were Moorish National documents which had been submitted in the Butler completed a Health Screening Questionnaire during his visit and signed the form, "Lamont Maurice El under Protest; All Rights Reserved."

On November 12, 2020, the Office of the Clerk of the Circuit Court for Montgomery County stamped a package received from " Lamont Maurice Butler-El", Re: Case Number 123483C and 122514C, titled "Default Judgement." The following individuals, who are known to your applicant, were named as "judgement debtors" in the document:

Ten (10) Montgomery County Court Officials (Victims 1-3, 5-11) Fifteen (15) Montgomery County Police Officers, active and retired (Victims 4, 12-25) The former Director of the Montgomery County Detention Center (Victim 26) The "authorized representatives" of the property at

An "Affidavit of Fact: Allodial Invoice Charge Sheet" was also included in the package which sought ordered liens against the " judgement debtors" to be paid in "lawful money .9999 fine gold bullion coins or bars" in the amount of One Hundred Ninety Million, Four Hundred Twenty Thousand dollars (\$194,420,000.00) to the "judgement creditor", Lamont Maurice Butler-El.

On November 13, 2020, a subject matching Butler's physical description showed up at LLC." The subject asked the worker if one of the workers at the property. The residence is the property of the he was the owner of the property. The worker replied that the property was owned by his employers. The subject told the worker that his employers did not own the home. He claimed the property was being disputed and fell under "treaty law" and it belonged to Morocco. He suggested the worker search "Lamont El" in the matter. A query of the Maryland Department of Assessments and Taxation (SDAT) Real Property Data search lists the value of the property at more than seven million dollars (\$7,000,000.00).

On December 29, 2020, your applicant became aware of UCC lien filings which were made by "Lamont Maurice Butler El" on the SDAT database. Your applicant queried the database and located a UCC-1 Financing Statement (filing number filed by "Lamont El." The filing address was The UCC statement listed Victims 1, 2 and 4 as "debtors" and sought collateral to pay an alleged \$194,420,000.00 debt. The UCC statement listed Victims 1, 2 and 4 27, 2020.

Your applicant located a second UCC-1 Finance Statement (Filing Number 201228-0455000) filed by "Lamont Maurice Butler El of the Consulate General of Morocco at Maryland republic." The filing address was also listed as 20013. The UCC statement listed Victims 1, 2, 3 and 4 as "debtors" and sought collateral to pay an alleged \$194,420,000.00 debt. The UCC statement was electronically filed on December 28, 2020.

A UCC-1 is a Uniform Commercial Code filing that is a public notice of a secured transaction. The notice (UCC-1) is a financing statement which indicates a commercial agreement between debtor and a secured party. It is filed by creditors to publicly declare their rights to potentially obtain the personal properties of debtors who default on business loans that they extend. The filing of UCC liens against government officials is a common tactic used by sovereign citizens who believe that no court can lawfully rule on the fact or existence of the filing itself because they believe the filing is legal fact.

On January 8, 2021, Butler arrived at the Montgomery County Circuit Court and hand-delivered a Moorish "Writ of Possession" re: case number 123483C package to the Sheriff's Office. The package contained the name "Lamont Maurice Butler-El and was directly addressed to Sheriff Popkin. The package contained a seal of the "Vizir for Morocco_Consular Court at the Maryland state republic." The "Writ of Possession" document instructed the Sheriff to place the property at into the custody of "Lamont Maurice Butler-El."

The Moorish nation and their beliefs are closely associated with the sovereign citizen movement which is considered domestic extremism by the FBI, Anti-Defamation League, and the Southern Poverty Law Center. Self-declared Moorish Nationals have been involved in crimes involving the use of fraudulent deeds, liens and other documents while claiming exemption from United States law. They have used "paper terrorism" tactics to retaliate against government authorities by placing false liens and judgements against officials. They have made criminally fraudulent attempts to take ownership of homes in many states throughout the Southeast Region of the U.S.

Butler attempted a similar residential takeover in Charles County in 2013, using fraudulent means. He was convicted of First-Degree Burglary, Theft Over \$100,000, and Conspiracies to Commit the burglary and theft. He received a prison sentence. He is currently on parole under the supervision of the Maryland Department of Public Safety and Correctional Services for that incident.

Your applicant has gained experience with sovereign citizens while working as a Vice & Intelligence detective for more than 10 years. Your applicant has participated in numerous training courses involving sovereign citizens since 2011. Butler 's identity has been confirmed through his most recent District of Columbia Identification Card.
