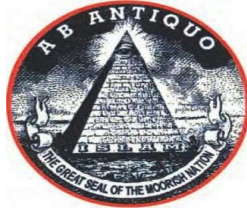

Subject: Official announcement of the operations of the Office of Consul General

The Office of the Consul General of Morocco, under the leadership of Lamont Maurice El, issues this official announcement to clarify the role, duties, and responsibilities of the Office of the Consul General of Morocco to qualified Moorish-American nationals under consular jurisdiction and protection, at the de facto corporate jurisdiction of the foreign United States of North America in accordance with established international treaty law, including the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire, and the supremacy clause of the Constitution for the United States of North America under Article VI, clause 2.

Duties and Responsibilities of the Consul General

Consul General Lamont Maurice El serves as the highest diplomatic representative of the Moorish Nation at North America when engaging in foreign treaty relations and intercourse with the de facto United States of North America, with duties and responsibilities including:

Treaty Enforcement

- Ensuring the consular jurisdiction and protection for the qualified Moorish American nationals domiciled at North America and other parts of the world that have

undergone a security clearance screening, background check, and has completed the traditional 'rite of passage' process for nationalization as established by the Enforce the Constitution © civic organization

- Serving as a liaison between the Moorish Nation and the de facto United States of North America on international treaty law issues
- Adjudicate cases between qualified Moorish-American nationals in disputes with de facto citizens of the United States and undesirable (stateless) persons when presented before the Morocco Consular Court at the de facto state where the incident or injury occurred

Judicial and Administrative Oversight

- Assisting in legal and lawful matters involving Moorish American nationals and their property
- Monitoring fraternal order contractors posing as de facto law enforcement agencies and de facto judicial authorities to ensure compliance with international treaty obligations and conflicting arrangements
- Providing consular assistance and immunity protections for qualified Moorish-American nationals where applicable
- Establishing consulates and training consular officers (et al.), supervising consular staff, and ensuring security protocols are followed

Trade and International Relations

- Establishing economic and business relations for the Moorish Nation
- Ensuring that trade agreements and diplomatic policies are upheld according to international law

Consular Protection and Assistance

- Assist with the protection of the treaty rights of qualified Moorish American nationals under consular jurisdiction
- Issuance of national identification cards and visas
- Assist with the established nationalization process for Moorish-American nationals on the public record, which includes the publication of one's free national name and nationality, and the issuance of the 'Record of Life' for children

- Training, coaching and instructing Moorish-American nationals and supporters on civics and jurisprudence using the literature and instructions from the Holy Prophet El Hajj Sheikh Sharif Abdul Ali – Noble Drew Ali, Charles Mosley Bey, Taj Tarik Bey, and Dr. Hannibal Bey for the enforcement of the Constitution for the United States of America in order to save themselves from the genocide operations and crimes against humanity caused by the present colonial occupation of the foreign occidental Europeans and subjects of the de facto United States of North America which has been committed on our lands within the dominions of the Moroccan Empire for the past centuries

Lawful Jurisdictional Notice

This notice serves as a formal declaration of authority of the Office of the Consul General in accordance with recognized international treaty law and diplomatic agreements. All fraternal order contractors, et alia, posing as de facto law enforcement agencies, de facto judicial officers, and de facto government officials (federal, state, and local) are required to acknowledge and respect the above duties and protections of this Office of the Consul General of Morocco as mandated by international treaty law and the supremacy clause of the Constitution for the United States of America under Article VI, clause 2. Any attempts to obstruct or disregard these lawful obligations and responsibilities are considered to be a breach of trust and violation of your treaty obligations and international law.
