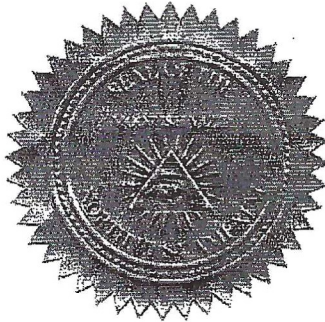

Upon the verbal testimony made on the record by the Plaintiff Quinn Khabir El during an emergency ex parte hearing held before this Morocco Consular Court on Saturday August 7, 2021, at 9pm, and the Affidavit of Evidence and Information [Exhibit: B] being attached hereto and having been affirmed to by our Vizir / Vice Consul Adeel Zakat Saeed Bey,

It is this 13th day of August, 2021, hereby ORDERED that the Plaintiff Quinn Khabir El being held hostage for profit under your custody on the information of QUINN CUMBERLANDER, ID #0711662, DOB: 04/15/1980, shall be forthwith RELEASED without condition or delay;

It is further ORDERED that the Plaintiff Quinn Khabir El makes no claim with respect to the title and misrepresented name / man-of-straw and nom de guerre: QUINN CUMBERLANDER, and the spurious creations of the foreign, de facto Corporate UNITED STATES operators, actors, and owners; and the Plaintiff Quinn Khabir El surrenders and assign any and all 'reversionary interest' to the foreign UNITED STATES (Inc.) and its subsidiaries for full acquittance and discharge and closure of misrepresented instrument - bill of exchange / bill of attainder / case number 2150-CR-001097 pursuant to and in reliance on Title 12 USC 95a (2); and the Plaintiff Quinn Khabir El assumes no liabilities or debts however contrived; and the Plaintiff Quinn Khabir El does not stand as 'Surety' for the foreign, private, and for-profit UNITED STATES INCORPORATED / U. S. Corporation Company entity owners, directors or their administrators; nor does the Plaintiff Quinn Khabir El stand as 'Surety' for its subsidiaries or its associates including the fictitious corporate person QUINN CUMBERLANDER at any point, or moment in time;



So ORDERED, sui juris.



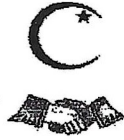

I, Adeel Zakat Saeed Bey ("Affiant"), being of lawful age, and being first duly sworn upon affirmation, depose and say:

1. I am a Moorish American national of the Moroccan Empire at Maghrib al Aqsa, North-West Amexem / North America, being an aboriginal and indigenous free Moor / Muur and rightful heir to the land by *jus sanguinis*. My nationality / citizenship and political status is recognized under copyright registration number AA 222141 with our Clock of Destiny Moorish American National Identification Card and Zodiac Constitution in the Library of Congress Copyright Office, Washington, District of Columbia.

2. I am a foreign national inhabitant at the Maryland state republic, and my treaty rights are secured under the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire, which is the Supreme Law of the Land under Article VI, clause 2 of the Constitution for the United States of North America.
3. I was appointed to the office of Vizir and Vice Consul by Lamont Maurice El, Consul General of Morocco, in accordance with the laws and customs of our Moroccan Empire and Zodiac Constitution.
4. I have first-hand knowledge of our Moorish American national Quinn Khabir El (hereinafter "Plaintiff") being presently kidnapped, denationalized and deprived of his liberty in involuntary servitude while being held hostage for profit as surety for the fictitious corporate person / nom de guerre QUINN CUMBERLANDER, ID #0711662, DOB: 04/15/1980 under the physical custody of the Defendants, Lewis G. Evangelidis and Fulton Holland, at a private foreign corporate prison camp known as:

WORCESTER COUNTY JAIL AND HOUSE OF CORRECTIONS (Inc.)

5. I further assert that the unlawful imprisonment of the Plaintiff includes the following circumstances:
 - a. On July 3, 2021, around 11:00 a.m. at route 128 North I-95 near corporate WAKEFIELD, Massachusetts, the Plaintiff was traveling in convoy with several other Moorish Americans in two (2) private automobiles, and eventually pulled over along the side of the road due to low fuel.
 - b. The armed Defendant Ryan F. Casey #4266 pulled up directly behind the Plaintiff and began to arbitrarily video record the Plaintiff (et al.) via a body camera, absent of a lawful search warrant and in violation of the Plaintiff's right of privacy which is guaranteed to be secured under the 4th Amendment of the

Constitution for the United States of North America. See EXHIBIT: B1 in the records of this case.

- c. The Defendants, Emily A. Karstetter, Marybeth Brady, Fulton Holland, Lewis G. Evangelidis, Marian T. Ryan, Brian O'Neill #2908, Matthew M. McDevitt #3474, and Christopher S. Mason, along with several other unidentified armed highwaymen acting as policemen / employees for the private foreign corporate entity MASSECHUSETTS STATE POLICE (Inc.) conspired with the Defendant Ryan F. Casey #4266 to kidnap, denationalized and deprived the Plaintiff of his liberty in involuntary servitude while being held hostage for profit as surety for the fictitious corporate person / nom de guerre QUINN CUMBERLANDER, ID #0711662, DOB: 04/15/1980, under color of law at the private foreign corporate entity WORCESTER COUNTY JAIL AND HOUSE OF CORRECTIONS (Inc.) via the unconstitutional bill of attainder / case number 2150-CR-001097 in the records of the private foreign corporate entity MALDEN DISTRICT COURT (Inc.).
- d. The Plaintiff is being deprived of his liberty and property under color of law, absent of a lawful warrant and without due process of law in violation of Article III section 2, Article VI clause 2, and Amendments 4, 5, 9, 10, and the organic 13th Amendment (section 12 of 20) of the Constitution for the United States of North America; and in violation of the Plaintiff's treaty rights under Articles 6, 20 and 21 of the Treaty of Peace and Friendship of 1836 between the United States and the Moroccan Empire.
- e. On or about August 5, 2021, the Plaintiff invoked his treaty rights to consular jurisdiction under Articles 20 and 21 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire, and challenged the jurisdiction of the private foreign corporate entity MALDEN DISTRICT COURT (Inc.) by executing an Affidavit of Fact: Writ of Quo Warranto [Exhibit: A] which was authenticated with the autograph and official seal of Lamont Maurice El, Consul General of Morocco, and recorded in case number 2150-CR-001097 in the records of the private foreign corporate

7. In support of the foregoing, the Supreme Court of the United States issued the following stare decisis law in the case *Kalovrat v. Oregon*, 366 U. S. 187, 194, 81 S.Ct. 922 (1961):

"A state cannot refuse to give foreign nationals their treaty rights because of fear that valid international agreements may possibly not work completely to the satisfaction of state authorities. Under the supremacy clause of the United States Constitution Art. VI, clause 2, state policies...must give way to overriding federal treaties and conflicting arrangements."

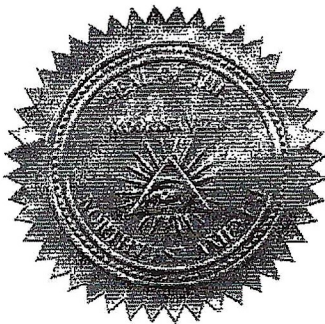


