WHEREFORE, it is hereby **ORDERED AND ADJUDGED** that a Writ of Error be and the same is hereby entered against you, Laurence D. Pierce, Heidi E. Brieger, Kristen Buxton, James Budreau, Shannon Frison, Michael A. Sullivan, [Lt. Colonel] Christopher Mason, Marian T. Ryan, and Graham Van Epps;

It is further **ORDERED AND ADJUDGED** that you, Laurence D. Pierce, Heidi E. Brieger, Kristen Buxton, James Budreau, Shannon Frison, Michael A. Sullivan, [Lt. Colonel] Christopher Mason, Marian T. Ryan, and Graham Van Epps, are guilty of **TREASON** and **MISPRISION OF TREASON** by your overt acts in case number 2181-CR-00362 of attempting to overthrow the sovereign people and supreme Law of the Land under color of law by color of authority within purview of the unconstitutional 14th Amendment;

It is further ORDERED AND ADJUDGED that the misrepresented instruments — bills of attainder / foreign bills of exchange styled as a de facto ORDER OF ENDORSEMENT ON MOTION TO FORFEIT BAIL dated August 18, 2022; and the de facto administrative bench warrant instrument dated July 22, 2022, which were all addressed to the fictitious corporate person / nom de guerre QUINN CUMBERLANDER (race: black), and any other attachments associated thereto are NULL and VOID AB INITIO and are UNENFORCEABLE for lack of jurisdiction and fraud;

Stare Decisis Law

See Elliot v. Peirsol, 26 U.S. 328, 340 (1828), ("Courts are constituted by authority and they cannot act beyond the power delegated to them. If a court acts without authority, its judgments and orders are regarded as nullities. They are not voidable, but simply void; and form no bar to a remedy sought in opposition to them, even prior to a reversal. They constitute no justification; and all persons concerned in executing such judgments, or sentences, are considered, in law, as trespassers.").

On August 18, 2022, the foreign hybrid European male Laurence D. Pierce, who was acting in collusion with the several others named James Budreau, Kristen Buxton, Heidi E. Brieger, Shannon Frison, Michael A. Sullivan, [Lt. Colonel] Christopher Mason, Marian T. Ryan, and Graham Van Epps filed in the records of case number 2181-CR-00362 a misrepresented instrument - bill of attainder / foreign bill of exchange titled ORDER OF ENDORSEMENT ON MOTION TO FORFEIT BAIL dated August 18, 2022, which was addressed to the fictitious corporate person / nom de guerre QUINN CUMBERLANDER (race: black) under color of law by color of authority within purview of the unconstitutional 14th amendment, which constitutes fraud in the inducement.

On July 22, 2022, the foreign hybrid European female Kristen Buxton, who was acting in collusion with Laurence D. Pierce, James Budreau, Shannon Frison, Michael A. Sullivan, [Lt. Colonel] Christopher Mason, Marian T. Ryan, and Graham Van Epps filed in the records of case number 2181-CR-00362 a misrepresented instrument - bill of attainder / foreign bill of exchange styled as a de facto administrative bench warrant dated July 22, 2022, against the fictitious corporate person / nom de guerre QUINN CUMBERLANDER (race: black) under color of law by color of authority within purview of the unconstitutional 14th amendment with the intent to denationalize and have me kidnapped and held hostage for profit in unlawful imprisonment as surety for QUINN CUMBERLANDER (race: black) against my consent which constitutes fraud in the inducement, collusion, conspiracy to kidnap and treason.
