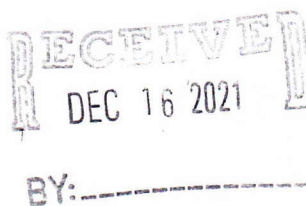
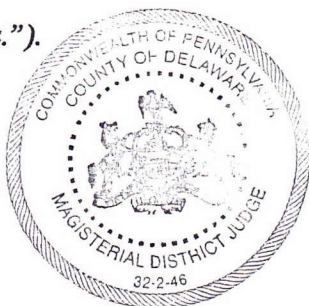

## MEMORANDUM

On or about December 10, 2021, you, Andrew Goldberg and Jack Stollsteimer, were served with process at your present addresses with the Affidavit of Fact: Writ of Quo Warranto [Exhibit: A], and the same was entered into case number MJ-32246-NT-0000234-2021 in the records of the foreign MAGISTERIAL DISTRICT COURT (Inc.), and there being no answer or cause to the contrary made by you which constitutes default. See **Old Wayne Mut. L Assoc. v. McDonough**, 204 U.S. 8, 27 S.Ct. 236 (1907) (*"A court cannot confer jurisdiction where none existed and cannot make a void proceeding valid. It is clear and well-established law that a void order can be challenged in any court."*).

Therefore, your several misrepresented instruments titled ORDER IMPOSING SENTENCE dated December 3, 2021, and NOTICE OF IMPENDING BENCH WARRANT dated December 6, 2021, which you issued under color of law against the fictitious corporate person / nom de guerre BREDIA NEWBOLT-WILLIAMS within purview of the unconstitutional 14<sup>th</sup> Amendment are void ab initio for lack of jurisdiction and constitute fraud in the inducement. See **EXHIBITS: C1 and C2** attached hereto; and see **United States v. Throckmorton**, 98 U.S. 61, 25 L.Ed. 93 (*"Fraud vitiates the most solemn contracts, documents, and even judgments."*); and see **Elliot v. Peirsol**, 26 U.S. 328, 340 (1828) (*"Courts are constituted by authority, and they cannot act beyond the power delegated to them. If a court acts without authority, its judgments and orders are regarded as nullities. They are not voidable, but simply void; and form no bar to a remedy sought in opposition to them, even prior to a reversal. They constitute no justification; and all persons concerned in executing such judgments, or sentences, are considered, in law, as trespassers."*).



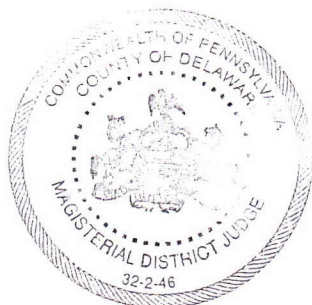
## ORDER

**WHEREFORE**, it is hereby **ORDERED AND ADJUDGED** that a writ of error be and the same is hereby entered against you, Andrew Goldberg and Jack Stollsteimer;

It is further **ORDERED AND ADJUDGED** that the several misrepresented instruments – bills of attainder / foreign bills of exchange styled as ORDER IMPOSING SENTENCE dated December 3, 2021, and NOTICE OF IMPENDING BENCH WARRANT dated December 6, 2021, and any attachments associated thereto are NULL and VOID AB INITIO and are UNENFORCEABLE for lack of jurisdiction and fraud;

It is further **ORDERED AND ADJUDGED** that the collusive action and de facto administrative proceedings under color of law in case number MJ-32246-NT-0000234-2021 in the records of the foreign MAGISTERIAL DISTRICT COURT (Inc.) are UNCONSTITUTIONAL, NOTWITHSTANDING, NULL and VOID AB INITIO and are UNENFORCEABLE for lack of jurisdiction and fraud;
