PETITION FOR CHANGE OF NAME IS HELD IN ABEYANCE PENDING THE FILING OF COMPLETE DOCUMENTATION AND/OR INFORMATION AS INDICATED BELOW

- Petition is not signed (Md. Rule 1-311(a)). **Party must file Amended Petition with signature.**
- Petition does not contain the following: (Md. Rule 15-901(c)(1)): **Party must file Amended Petition containing the missing information.**
 - Name, address, date of birth, place of birth of the person whose name is sought to be changed.
 - Why venue is proper in Baltimore County.
 - Whether the person whose name is sought to be change has ever been known by any other names, and if so, the names and circumstances under which they are used.
 - The change of name desired and reasons for requested change.
 - A certification that the petitioner is not requesting a name change for any illegal or fraudulent purposes.
 - Whether the person whose name is sought to be changed has ever registered as a sex offender.
- A copy of ~~birth certificate and/or~~ **documents to show the current name** of the person whose name is sought to be changed not attached to request. (Md. Rule 15-901(b)).
- Documents not attached to show previous name changes.
- The person whose name is sought to be changed is a minor and request does not:

State why the petitioner believes that the name change is in the best interest of the minor. (Md. Rule 15-901(c)(1)(G)).
PETITIONER SHOULD FILE AN AMENDED PETITION USING FORM CC-DR-062, REVISED 1/2023, AVAILABLE AT MDCOURTS.GOV

State the names and addresses of the minor's parents and/or guardians or custodians and whether they consent to the name change. (Md. Rule 15-901(c)(1)(G)).

Provide consent of each parent, guardian, and custodian or explain why the consent is not attached (Md. Rule 15-901(c)(2)(B)).

Provide written consent of the minor, if the minor is at least 10 years old (Md Rule 15-901(c)(2)(B)). **HAVE MINOR COMPLETE FORM CC-DR-119, AVAILABLE AT MDCOURTS.GOV**

Include an Affidavit of Service showing that the non-consenting parent was served with the Petition, each attachment to the petition, and the Notice issued by the Clerk. See Maryland Rule 15-901(d)(3) and Maryland Rule 2-201.

THIS ORDER TO HOLD IN ABEYANCE SHALL NOT TOLY OR SUSPEND STATUTORY DEADLINES PURSUANT TO MARYLAND RULE 2-507.
