*Understanding **Adverse Claim**: Purpose, Function, and Usage*

What is Adverse Claim?

An Adverse Claim is a birthright claim by an inheritor, challenging another person's adverse possession or assumption of ownership or right to a particular asset such as Land, property, or an automobile. The term adverse means "opposed; contrary; in resistance or opposition to a claim, application, or proceeding" Black's Law Dictionary, 4th Edition ; the claim typically arises when the claimant, in relation to the asset, "... demand[s] as one's own" in conflict with another's assumption of rights to an asset.

Purpose of an Adverse Claim

The primary purpose of an adverse claim is to protect the claimant's rights and prevent the transfer, sale, possession, or misuse of the asset in question until the dispute is resolved.

Adverse claims serve as a mechanism to ensure Due Process:

By asserting an adverse claim, the claimant ensures that their rights are considered before any further action is taken regarding the asset. This ensures proper enforcement of the 5th Amendment of the Constitution for the United States of America, and prevents violation of the 4th Amendment (unreasonable searches and seizures).

Dispute Resolution: Adverse claims bring issues of controversy such as ownership disputes into the appropriate venue (determined by the status of parties involved), and establishes a hierarchy to facilitate the settlement of said dispute.

Preservation of Rights: Recording an adverse claim can prevent unlawful actions (like sales, possessions, dispositions, or transfers) that may harm the claimant's lawful position in the asset.

Function of an Adverse Claim Notification: When an adverse claim is made, it acts as a formal notice to all parties, including de facto courts, registries, or financial institutions, that there is a competing interest in the asset. Restricting Actions: The filing of an adverse claim, along with a Writ of Quo Warranto (challenging personam jurisdiction) by a declared Moorish American National can halt actions like asset transfers, sales, dispositions, or attempted repossessions. Legal Consideration: The claim initiates a legal process whereby de facto courts or adjudicating bodies must certify the true and correct copy of the claimant's assertion and give it Full Faith and Credit on the record.





Adverse Claim Process Basis for the Claim

The claimant must provide evidence and reasoning for their adverse claim, such as an Affidavit and demonstration of competency in inheritance and birthright claims.

Notice to Interested Parties: Adverse claims often require formal notification to the current adverse possessor, or any individual or entity attempting to bring suit against the claimant—including but not limited to third party interlopers (no contractual claims to the asset), registrar, clerk of the court [de facto] or financial institutions.

Resolution Process: The claim must be resolved through a lawful and competent court of jurisdiction as required in Article III, Sections 1 and 2 of the Constitution for the United States of America.

Use of Adverse Claim

Adverse claim is an essential part of Moorish American Nationals reclamation of their birthright as heirs to their vast Estate (all corporeal and incorporeal hereditaments or assets). As decided in the landmark de facto case STATE OF MARYLAND Vs LAMONT MAURICE BUTLER, only Nationals have the right to make heirship claim to an estate in accordance with Article 22 of the Treaty of Peace and Friendship of 1836 between the United States of America and the Moroccan Empire.

“A state cannot refuse to give foreign nationals their treaty rights because of fear that valid international agreements may possibly not work completely to the satisfaction of state authorities. Under the supremacy clause of the United States Constitution Art. VI, clause 2, state policies as to the rights of aliens to inherit must give way to overriding federal treaties and conflicting arrangements.” ~ Kolovrat v. Oregon, 366 U. S. 187, 194, 81 S.Ct. 922 (1961)

Article VI, Section 2 of the Constitution for the United States of America binds all colorable authorities to the Supreme Law of the Land, including “all Treaties made, or which shall be made, under the authority of the United States [Republic]”.

Components of an Adverse Claim

1. **Jus Sanguinis:** Declaration of ancestral dominion, proclamation of Nationality through consanguinity (birthright through bloodline), and demonstration of competency by age and ability to manage one's own affairs
2. **Nationality and Citizenship:** Political status and citizenship in relation to the jurisdiction being addressed (propria persona or proper person)
3. **Proof of Protection:** Reference to Treaty protected right to inherit per the Treaty of Peace and Friendship and right to a Nationality per United Nations Declaration on the Rights of Indigenous Peoples
4. **Proof of Title:** Declaration of Adverse Claim by way of Aboriginal title to your ancestral estate in reversion (return of the interest in the Land to the true owner, the inheritor). *Note that aboriginal title is not a paper title but the birthright claim through your Title of Nobility (Bey, El, Ali, Al), which cannot be granted by any State (Article I, Sections 9 and 10 of the Constitution)*
5. **Asset Attributes:** Latitude and Longitude coordinates of the Land being claimed or the physical description of the asset claimed if not Land/property (including any unique identifiers)
6. **Rebuttal:** of any alleged mortgage, hypothecation, lien, encumbrance, or fee simple deed (certificate of title) asserted or held by feudal practice of 14th amendment persons.

When Adverse Claims Came Into Use

The concept of adverse claims dates back to early legal systems where property rights were a cornerstone of governance and societal structure. In English Common Law, for example, adverse claims emerged as a way to address disputes over land. Over time, this principle expanded to cover other classes of assets, legal processes (such as Adverse Possession), and financial instruments.

Conclusion

An adverse claim serves as a crucial mechanism in law to definitively address and resolve ownership disputes. Whether involving land or other assets, adverse claim upholds the principles of due process, security of asset, and inheritance rights protected under the Constitution for the United States of America and associated Treaties. Understanding the purpose, function, components, and use of adverse claims equips Moorish American Nationals with the knowledge to navigate disputes effectively, ensuring their rights are protected within a de facto legal framework.

It was in this article, written by a colonizer, Dan Morse, that Moorish American National, Lamont Maurice El, was vehemently and publicly slandered, having been erroneously referred to as a "sovereign citizen" and accused of "breaking the law". This landmark case has left an imprint on the minds of many Nationals who have been waking up from the deepest spell of colonial indoctrination and illusion ever to take place on this earth. What appeared to be a foolish attempt to burglarize a luxury property was actually the marking of the awakening of a noble. Let us take the time to witness another historical milestone, here, in this interview with the honorable Consul General, Lamont Maurice El, as he talks about what really happened with this de facto case and what Moorish Americans can learn from his experience of operating in a lawful capacity and reclaiming birthrights.

Empress Salome: Consul General Lamont Maurice El, it's a pleasure to have you with us today. Your involvement in the Bethesda Mansion case has become a significant example of the larger struggles many Moorish Americans face when it comes to asserting their ancestral rights to their inheritance. Can you tell us about what led you to claim the Bethesda Mansion as part of your ancestral estate?

Consul General Lamont Maurice El: Thank you for having me. The journey to claim the Bethesda Mansion was not just about the property itself—it's about reclaiming what is historically ours. As a Moorish American, we have a deep connection to the land and our heritage. For years, we have faced systemic challenges that have disconnected us from our inheritance. The mansion was simply a piece of that puzzle—a property that I made an adverse claim to, based on the historical entitlements passed down through our ancestors. This wasn't just about ownership of a domicile; it was about restoring our place within the broader framework of legal rights and sovereignty.

Empress Salome: That's powerful. Now, you mentioned the term "adverse claim." Could you explain what that means in the context of the Bethesda Mansion case, and why it's so important for Moorish Americans?

Consul General Lamont Maurice El: An "adverse claim" is essentially a legal claim to property that challenges existing ownership, often on the grounds of historical rights, inheritance,

or entitlement. In the case of the Bethesda Mansion, I made an adverse claim based on the ancestral rights that an indigenous holds to lands that were taken or misappropriated over time. This is an important aspect of our struggle, as many Moorish Americans are unaware of their legal standing to assert these types of claims. It's about recognizing that these lands were once ours, and we have the right to claim them. The concept is deeply tied to our efforts to nationalize and decolonize, to reconnect with the land and our identity.

Empress Salome: It sounds like understanding jurisdiction is a key part of this process. In your case, the charges of breaking into the mansion were eventually dismissed due to a lack of jurisdiction and evidence. How does jurisdiction play a role in cases like this, particularly for Moorish Americans?

Consul General Lamont Maurice El: Jurisdiction is crucial, and it's often the battleground in these cases. When a legal dispute arises—especially one involving ancestral claims—the question becomes: Which legal system has the authority to adjudicate the case? Also known as **Quo Warranto** which is a legal term referring to a writ or action used to challenge someone's right to hold a public office or authority, questioning "by what authority" they are exercising their power. It is typically used to remove someone from office if they are deemed to be occupying it without legal justification. Moorish Americans often find themselves in complex jurisdictional conflicts because many courts don't recognize our legal standing. Our unique status challenges the traditional legal frameworks that were set up during colonization. In my case, the charges were dismissed because it became clear that the court didn't have proper jurisdiction over the matter. The term on the record was **Nolle Prosequi** which is a Latin legal term meaning "unwilling to prosecute." It is used when a prosecutor decides to drop or discontinue a criminal case, usually before a trial, indicating they will no longer pursue charges against the defendant. This happens a lot in these kinds of cases, and it's a reminder of how important it is to understand where we stand legally.

Empress Salome: That's fascinating. So, your case also highlights the potential misuse of legal systems, particularly in cases involving indigenous people and property rights. How does this affect Moorish Americans who are trying to assert their sovereignty?

Consul General Lamont Maurice El: It's a major issue. The legal system can sometimes be weaponized to undermine the rights of

indigenous peoples or those asserting sovereignty. In many cases, people are wrongfully accused or charged because the legal system doesn't recognize their claims to land or heritage. In my case, the charge of breaking and entering was completely false. It was part of a larger pattern of error and misrepresentation that surrounds sovereign rights and property claims for Moorish Americans. It's not just about one case; it's about the system as a whole, and how it can sometimes be used to disempower people who are fighting for their rightful place in the world.

Empress Salome: It's clear that this struggle is not just a personal one but part of a much larger movement for Moorish American rights. Could you talk about how the Bethesda Mansion case fits into the broader movement for recognition, sovereignty, and self-determination?

Consul General Lamont Maurice El: Absolutely. While the Bethesda Mansion case was a personal victory for me, it became a broader teaching moment for the Moorish American community. This case illustrates that asserting ancestral rights and sovereignty is an ongoing challenge. It is not just about reclaiming one piece of land—it's about the larger struggle to restore our identity, our legal standing, and our place in society. Sovereignty, heritage, and legal rights are interconnected. The decolonization movement is about more than just taking back land; it's about reclaiming our rightful position in the world, recognizing our status, and breaking free from systems that have historically marginalized us.

Empress Salome: So, in a way, this case became a symbol for the entire community?

Consul General Lamont Maurice El: Exactly. The Bethesda Mansion case is not just about the mansion itself—it's about the larger narrative of restoration and sovereignty. It's about reclaiming our place in the legal and historical landscape. The case demonstrates that, even when facing legal obstacles, Moorish Americans can defend and assert their rights. It's a collective challenge, and it is one that requires knowledge, mastery, competency, erudition, and a unified effort. We've been educated to believe that we don't have a place in the legal system, but the truth is, we have always had a place—we just need to claim it.

Empress Salome: You've spoken a lot about erudition and how important it is for Moorish Americans to understand the law, their rights, and their heritage. What resources would you recommend for anyone looking to learn more and possibly make similar claims?

Consul General Lamont Maurice El: There are several resources available to help people empower themselves. I strongly encourage people to check out our website, EnforceTheConstitution.org, where we offer study groups, classes, and resources that focus on constitutional law, history, and nationalization. We also have a YouTube channel, EnforceTheConstitution, where we share erudite videos on various legal concepts, including how to assert sovereign rights and challenge jurisdiction. It's all about equipping people with the knowledge and tools they need to navigate the legal system effectively.

Empress Salome: It's clear that your work goes beyond just legal defense; it's about erudition and empowering your community. Looking ahead, what's your vision for the future of the Moorish American movement?

Consul General Lamont Maurice El: My vision is one of unity, self-determination, decolonization, and validation. The fight for justice is not just about winning individual cases—it's about creating a movement that empowers people to claim their ancestral estate and their indigenous rights. We need to build a sanctuary for Moorish Americans, where we can live in equality, free from the systems of oppression that have existed for centuries. It's a long road ahead, but I believe that through erudition, perseverance, and strategic action, we can create real change. The Bethesda Mansion case was just one step in that journey.

Empress Salome: Thank you so much, Consul General Lamont Maurice El, for sharing your story and insights. Your work is truly inspiring, and it's clear that the fight for Moorish American rights is far from over.

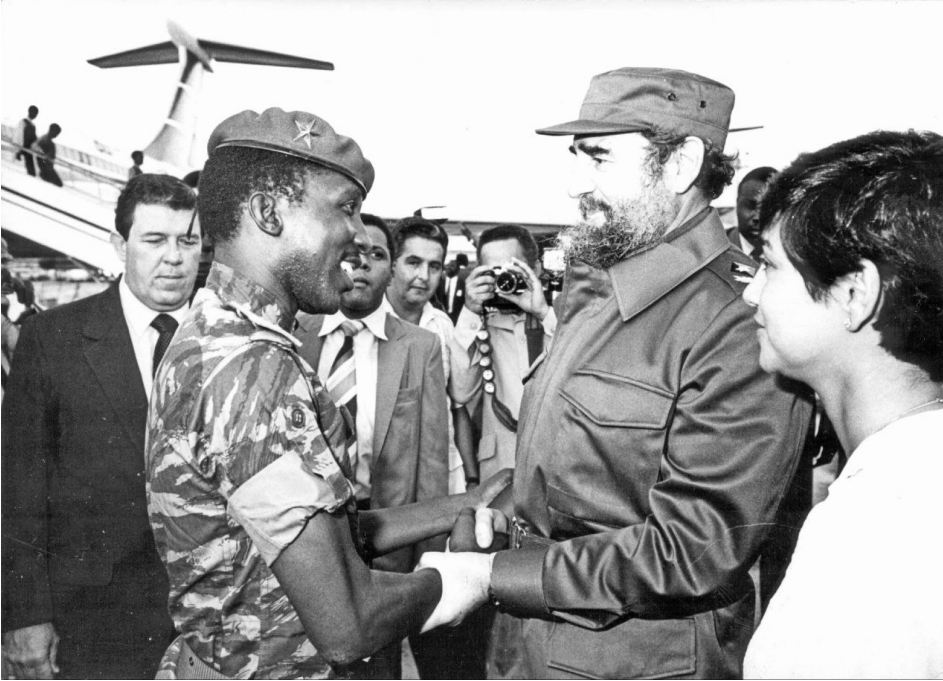

Though often used interchangeably, legal and lawful have distinct meanings. Legal refers to what is permitted by statutes, codes, ordinances, and regulations. In contrast, lawful pertains to actions aligned with broader principles of justice and ethics, such as those outlined in the Constitution. Something can be legal without being lawful, highlighting the difference between statutory regulations and fundamental fairness.

The concept of contracts is not new and finds its roots in ancient covenants. In religious texts, covenants are solemn agreements or promises, emphasizing the seriousness and binding nature of such commitments.

For instance, the Bible states, Proverbs 20:25: *"It is a trap to dedicate something*

rashly and only later to consider one's vows."

Similarly, the Quran states, Surah Al-Isra (17:34): *"And fulfill every commitment. Indeed, the commitment is ever that about which one will be questioned."*

The term contract is derived from the Old Moorish Latin word, *contrahere* [con + trahere] and means to draw; to agree upon to establish by agreement; to enter upon; and to undertake, mutually.

A contract is defined as an agreement, upon sufficient consideration, to do or not to do a particular thing. "

Black's Law Dictionary, 4th Edition.

Essential Elements of a Valid Contract

A legally enforceable contract must contain several critical components, each serving a specific purpose in establishing the agreement's legitimacy:

- **Offer:** One party proposes terms to another.
- **Acceptance:** The other party agrees to the proposed terms.
- **Consideration:** Something of value is exchanged between the parties.

- **Capacity:** Parties must have the legal ability to enter into a contract.
- **Legality:** The contract's purpose must be lawful.

Factors That Invalidate Contracts

Contract Termination

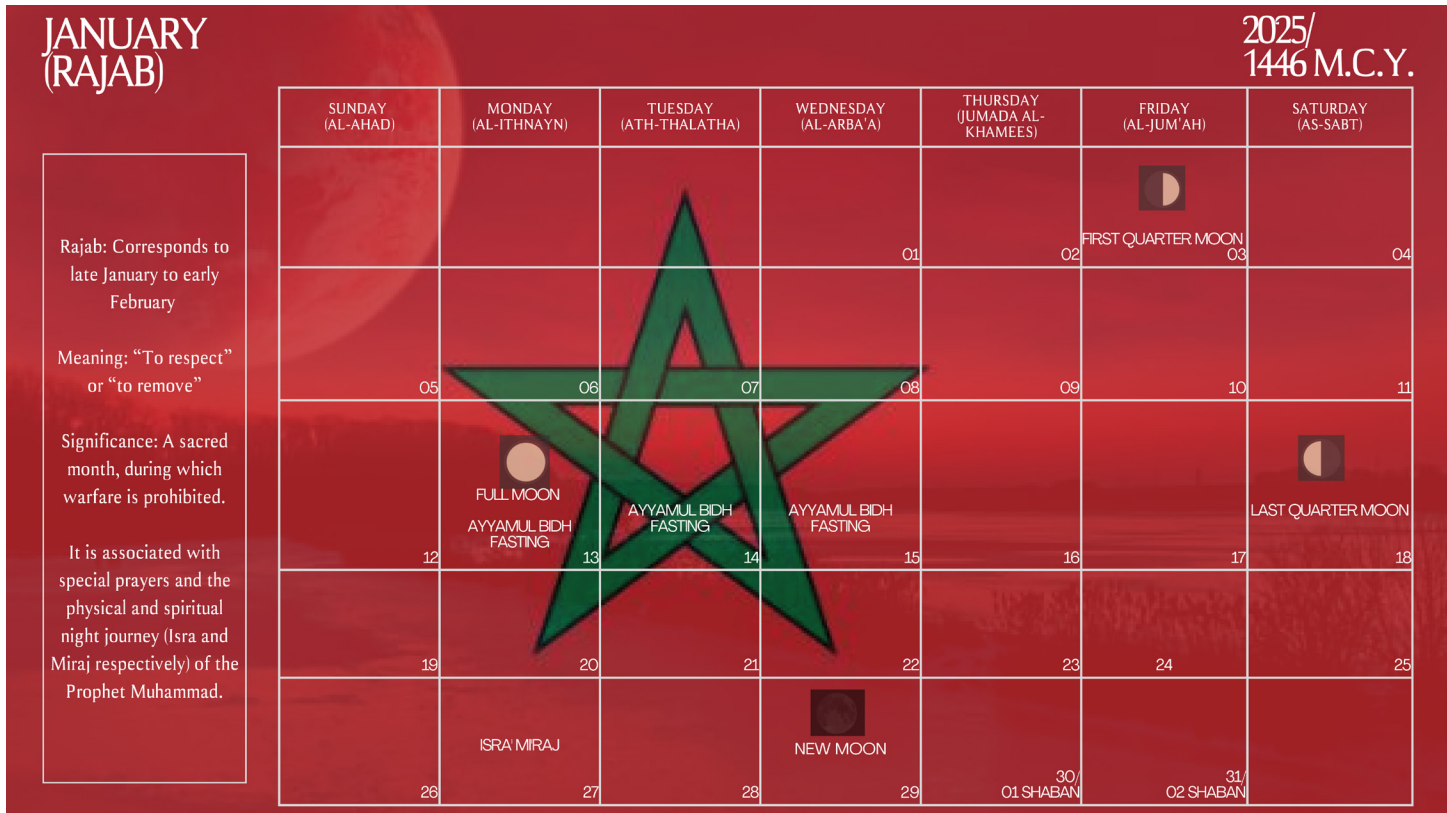

The Aquarian Age is a spiritual age that some believe is associated with Jesus and the teachings of the development of human society, including art, technology, and intellectual growth.

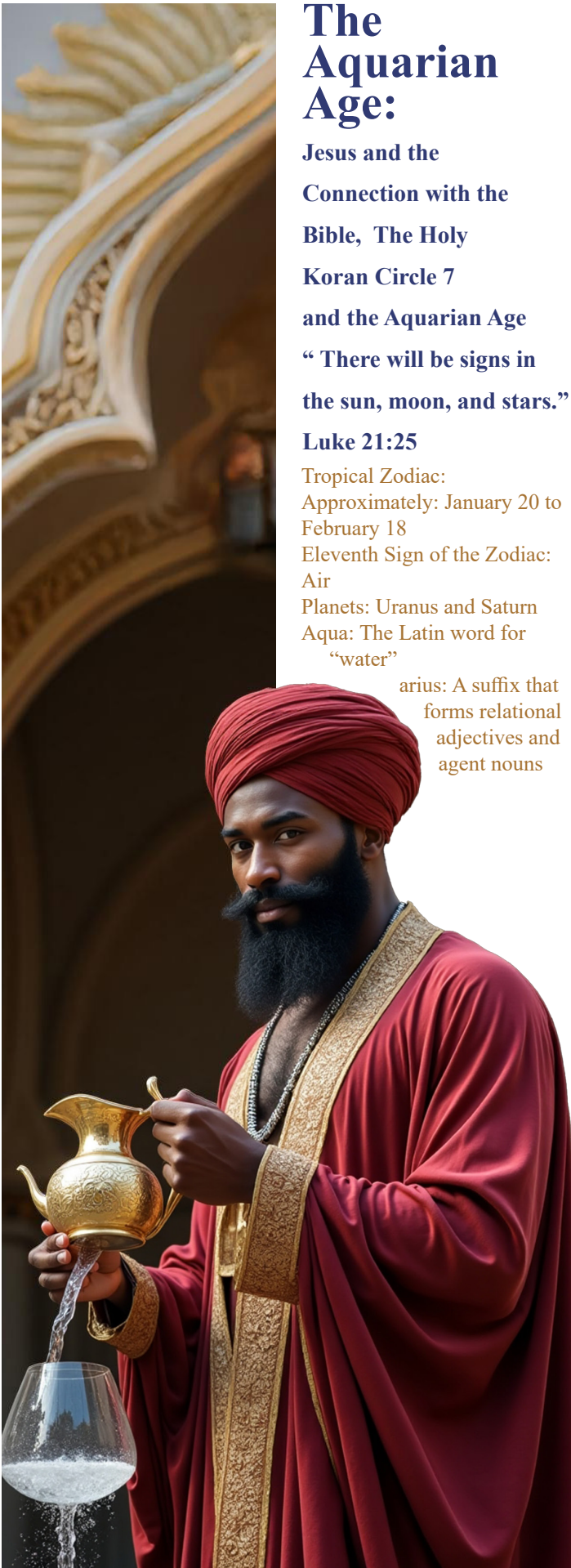
The Aquarian Age is also an astrological age that is said to begin when the sun is in the Aquarius constellation during the spring equinox.

The Holy Breath

Pranayama, (expansion of individual energy into cosmic energy) Inhale through your nose the sustaining force of life (prana) breath, and exhale through your nose the life force energy.

Breath of Fire is a type of pranayama, which is breath control in yoga. It involves specific breathing exercises where you inhale, exhale, and hold your breath in a certain way. Pranayama is a key part of yoga practice, since it's a dynamic form of breath control.

In Breath of Fire, you inhale through your nose passively and exhale forcefully out your nose, focusing on contracting your abdominal muscles during the exhale.

The inhale and exhale should be of equal length, without pauses in between, unlike slower breathing exercises.

The rhythm of the breath is more important than the speed, so if you're new, start slow and increase the pace as you become more comfortable.

Breath of Fire is typically done seated and can last anywhere from 30 seconds to 10 minutes, depending on your experience and preference. Start with 60 repetitions for seven days.

Safety tips

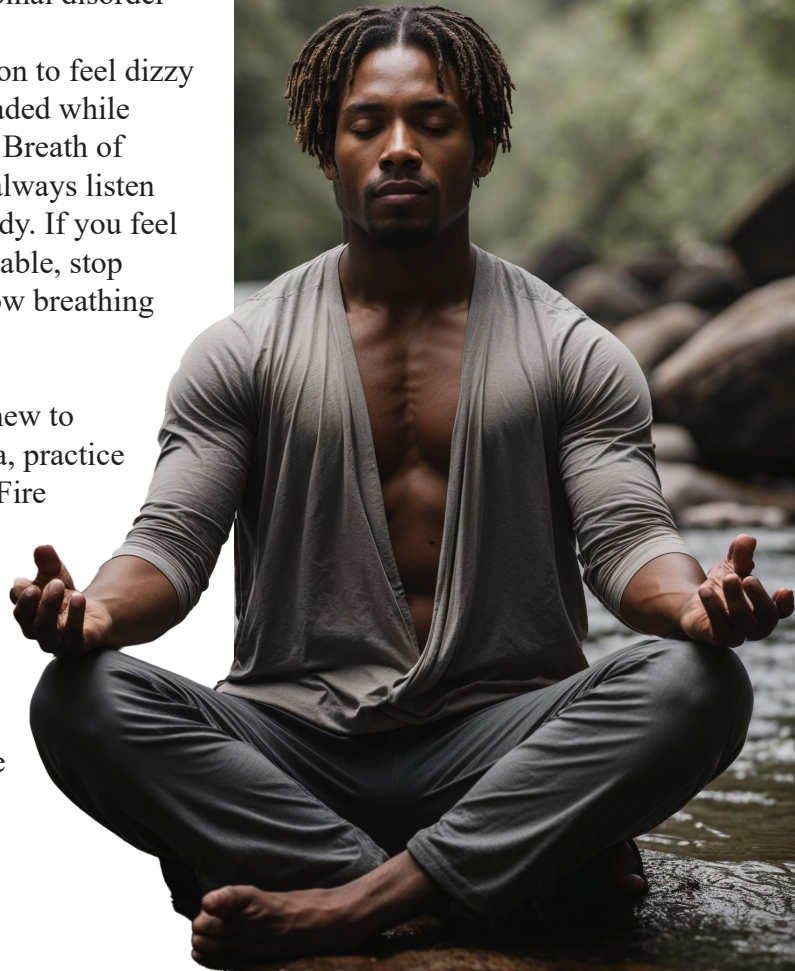
This breathing technique may be unsafe for some people. You should avoid it if you:

It's common to feel dizzy or lightheaded while practicing Breath of Fire. But always listen to your body. If you feel uncomfortable, stop and try slow breathing instead.

If you're new to pranayama, practice Breath of Fire slowly.

This will give your body time to get used to the exercise.

Quo jure /Kwòw jùriy / Lat. In Old English practice, a writ which lay for one that had land in which another claimed common, to compel the latter to show by what title he claimed it.

The land-related form of the interrogative pronoun “**quis**” (“**who?**”) is **quō**, meaning “**by whom,**” “**with whom,**” or “**from whom,**” depending on the context.

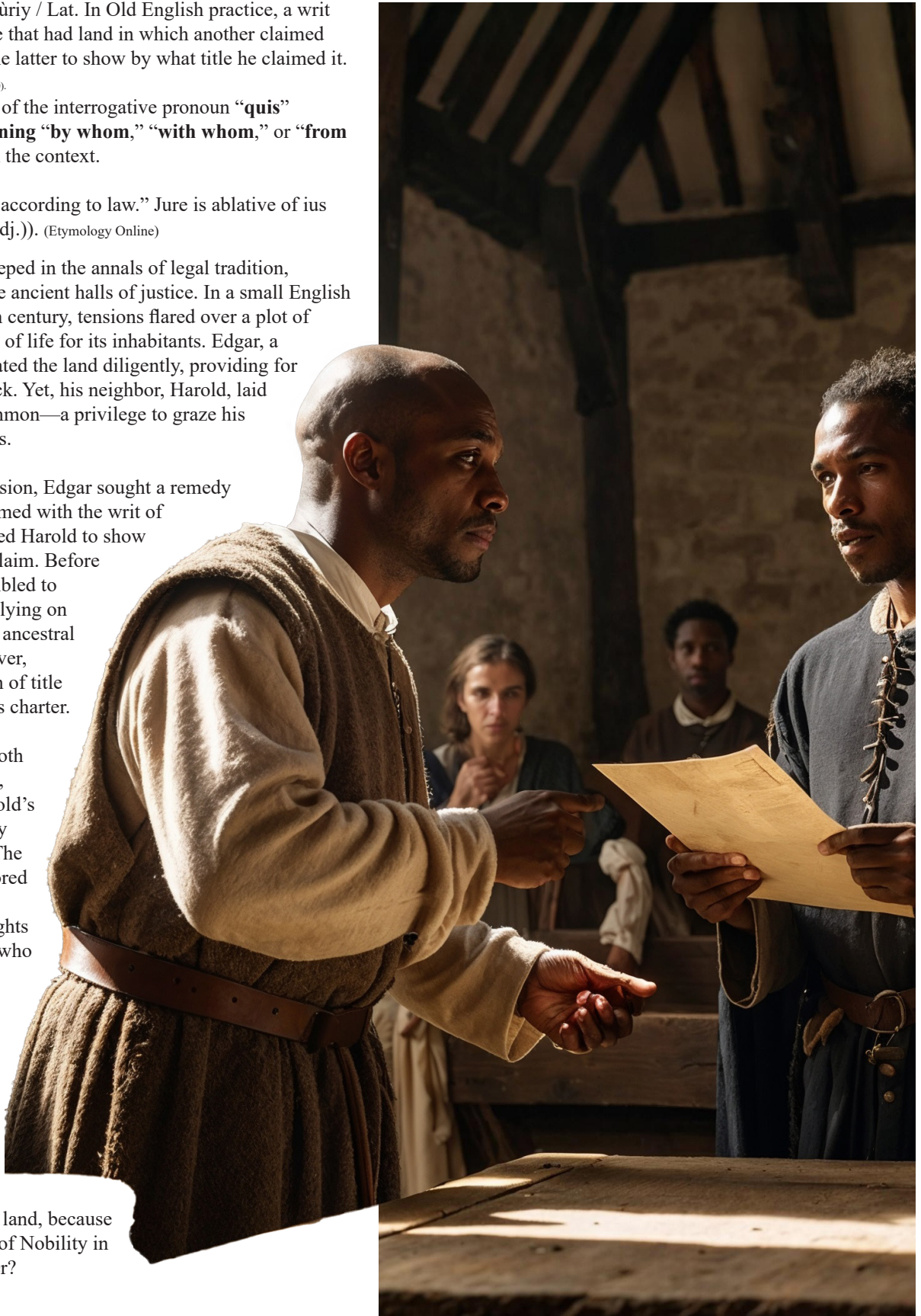
Jure: By right of law, according to law.” Jure is ablative of ius “law” (see de + just (adj.)). (Etymology Online)

Quo Jure, a phrase steeped in the annals of legal tradition, resonated deeply in the ancient halls of justice. In a small English village during the 13th century, tensions flared over a plot of fertile land, the source of life for its inhabitants. Edgar, a humble farmer, cultivated the land diligently, providing for his family and livestock. Yet, his neighbor, Harold, laid claim to a right of common—a privilege to graze his sheep on Edgar’s fields.

Frustrated by the intrusion, Edgar sought a remedy through the courts. Armed with the writ of Quo Jure, he summoned Harold to show the legal basis of his claim. Before the court, Harold stumbled to articulate his rights, relying on vague recollections of ancestral customs. Edgar, however, presented a clear chain of title supported by the lord’s charter.

The court, weighing both evidence and tradition, sided with Edgar. Harold’s claims, unsupported by law, were dismissed. The writ of Quo Jure restored order, affirming the sanctity of property rights and compelling those who claimed otherwise to justify their assertions by the law. Thus, it stood as a timeless guardian of justice.

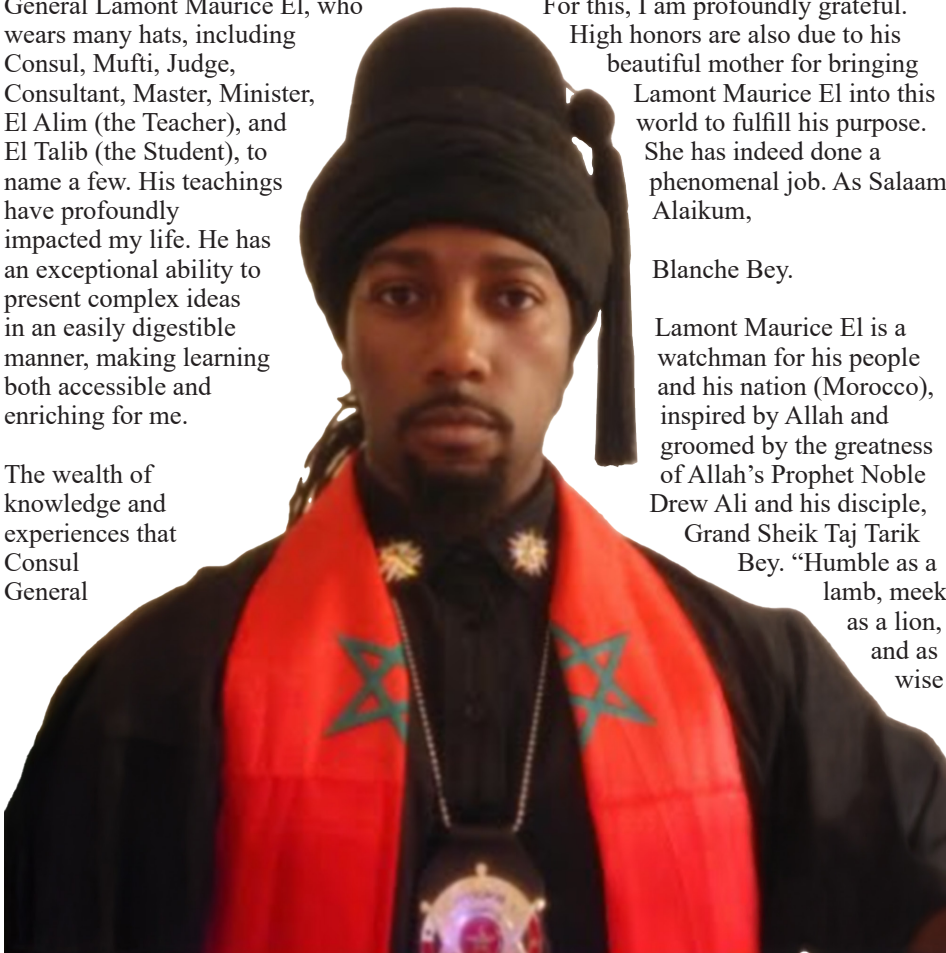

7. From the largeness of his mind, he comprehendeth in his wishes the happiness of all men; and from the generosity of his heart, he endeavoreth to promote it.



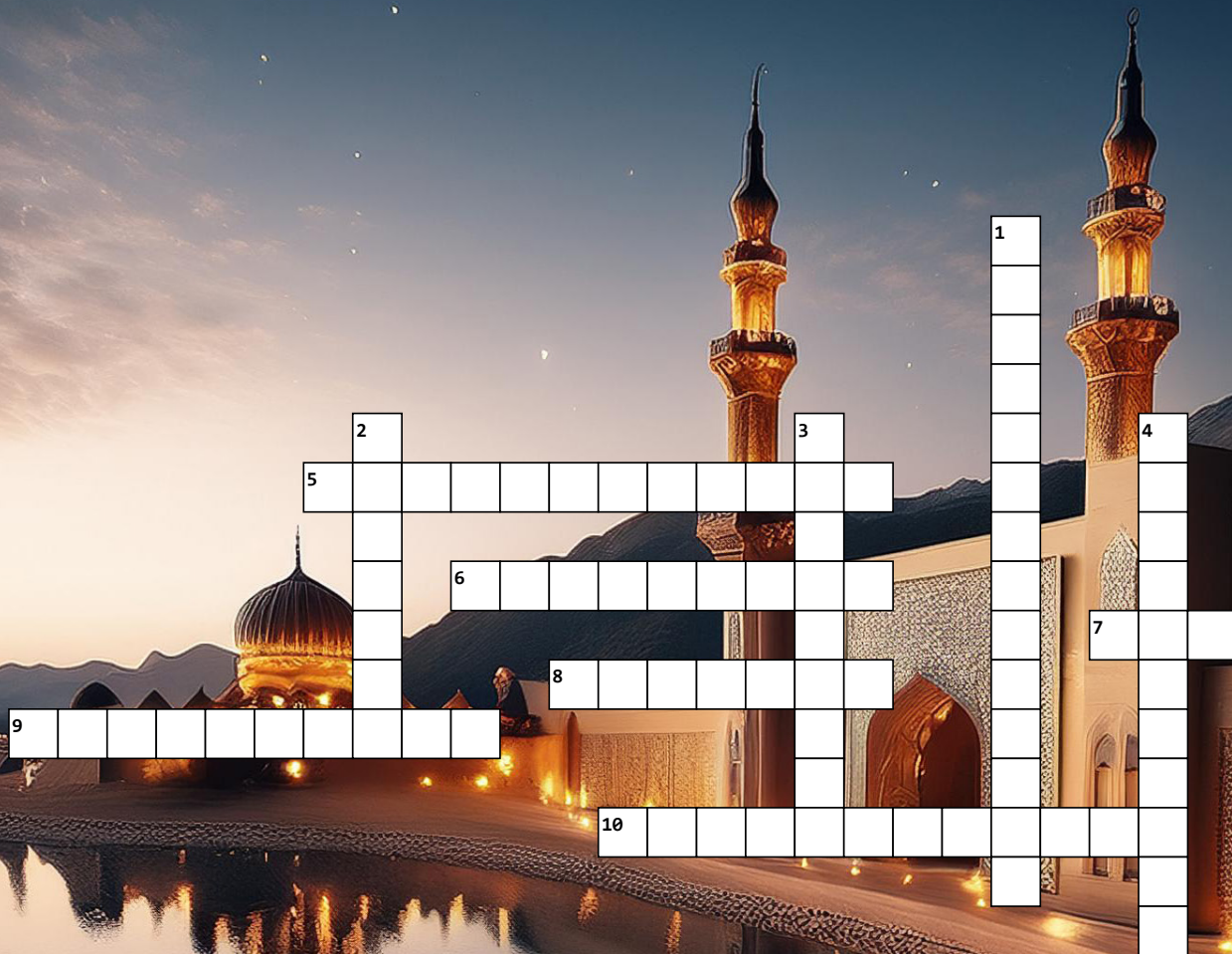


Chapter XXV
