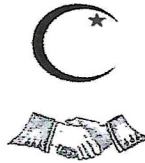

MEMORANDUM

On July 3, 2021, near corporate WAKEFIELD, Massachusetts, Quinn Khabir El (hereinafter "Plaintiff") was kidnapped, held hostage for profit, and denationalized under color of law on the information of the fictitious corporate name / nom de guerre inscribed in ALL CAPS, i.e., QUINN CUMBERLANDER (Race: Black via the 'Black Code') as a 'stateless person' within purview of the plausible 14th Amendment under the custody of Emily A. Karstetter (a foreign hybrid European colonist male), Marybeth Brady (a foreign hybrid European colonist female), Lewis G. Evangelidis (a foreign hybrid European colonist male), and Fulton Holland (a foreign hybrid

European colonist male) (hereinafter “Defendants”), absent of a lawful 4th Amendment arrest warrant and without due process of law. See *Kent v. Dulles*, 357 U.S. 116 (1958) (“*The right to travel is part of the Liberty of which a citizen cannot be deprived without “due process of law” under the Fifth Amendment. This right was emerging as early as the Magna Carta.*”); and see *McNalley v. United State*, 483 U.S. 350, 371-378, quoting *United States v. Holzer*, 861 F.2d. 304, 307 (“*Fraud in its elementary common law sense of deceit...includes the deliberate concealment of material information in a setting of fiduciary obligation. A public official is a fiduciary toward the public,...and if he deliberately conceals material information from them he is guilty of fraud.*”).

On August 13, 2021, this Morocco Consular Court issued a Writ of Habeas Corpous Ad Subjiciendum for the immediate release of the Plaintiff from the custody of the said Defendants bases upon the facts shown in the Affidavit of Evidence and Information [Exhibit: A] presented to this Consular Court on August 13, 2021, by our Vizir and Vice Consul Adeel Zakat Saeed Bey. The Writ of Habeas Corpus was issued under consular jurisdiction in accordance with the treaty rights of the Plaintiff, which include the Plaintiff’s treaty right to consular jurisdiction and to be immediately released from being held hostage for profit (prize) which are guaranteed to be secured under Articles 6 and 20 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire; and under Article 6, clause 2 of the Constitution for the United States of North America. See *Kolovrat v. Oregon*, 366 U. S. 187, 194, 81 S.Ct. 922 (1961) (“*A state cannot refuse to give foreign nationals their treaty rights because of fear that valid international agreements may possibly not work completely to the satisfaction of state authorities. Under the supremacy clause of the United States Constitution Art. VI, clause 2, state policies as to the rights of aliens to inherit must give way to overriding federal treaties and conflicting arrangements.*”).

On or about August 18, 2021, Defendants Emily A. Karstetter, Marybeth Brady was served at their present addresses (either personally or through their agent) with the Writ of Habeas Corpus Ad Subjiciendum and the Affidavit of Evidence and Information [Exhibit: A].

As of this date, the Defendants have failed to execute their obligation in the Writ of Habeas Corpus Ad Subjiciendum, and there was no cause to the contrary made thereto by the Defendants which constitutes default and breach of duty.

Wherefore, the Defendants are in violation of Articles 6, 20 and 21 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire; and Article III, section 2, and Article VI, clause 2, and Amendments 1, 4, 5, and the organic 13th Amendment (section 12) of the Constitution for the United States of North America.

ORDER

It is therefore considered ORDERED AND ADJUDGED that an Order of Default be and the same is hereby entered against the Defendants;

It is further ORDERED AND ADJUDGED that the Defendants are in breach of their duty by failing to execute their treaty obligations under Articles 6 and 20 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire, and the 'Supremacy Clause' of the Constitution for the United States of North America under Article VI, clause, and the Defendants have therefore forfeited any and all alleged public service and / or office of trust, oaths of office and surety bonds under color of any law;

It is further ORDERED AND ADJUDGED that a Writ of Quo Warranto will be issued by this Morocco Consular Court in accordance with Articles 20 and 24 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire in

order to inquire into the color of authority exercised by the Defendants holding the body and estate of the Plaintiff hostage for profit [ex rel. the fictitious corporate person / nom de guerre QUINN CUMBERLANDER], and to prevent the Defendants and any other natural person acting as employee / contractor / representative of the private foreign corporate entities MALDEN DISTRICT COURT (Inc.), WORCHESTER COUNTY SHERIFF'S DEPARTMENT (Inc.), WORCESTER COUNTY JAIL AND HOUSE OF CORRECTIONS (Inc.), MASSECHUSETTS STATE POLICE (Inc.), and OFFICE OF THE DISTRICT'S ATTORNEY FOR MIDDLESEX COUNTY (Inc.) from exercising any power not conferred by the supreme law of the land in order to protect the interest of the people as a whole and guard the public welfare;

It is further ORDERED AND ADJUDGED that the colorable administrative hearing set for September 8, 2021, in case number 2150-CR-001097 in the records of the foreign MALDEN DISTRICT COURT (Inc.) and any attachments associated thereto are NULL and VOID AB INITIO and are UNNFORCEABLE for lack of jurisdiction and fraud until the Writ of Quo Warranto is answered by the Defendants and jurisdiction is proved to exist.
