The specter of mortgage fraud and fraudulent evictions casts a long shadow over communities across North America, disproportionately impacting Aboriginal people. These practices not only violate the fundamental principles of justice but also infringe upon the treaty rights and ancestral sovereignty of Moorish Americans—heirs to the lands of North America.

#### *The System of Mortgage Fraud*

Mortgage fraud encompasses a range of deceptive practices perpetrated by individuals, mortgage companies, and financial institutions seeking financial gain at the expense of rightful property owners. This typically involves fraudulent loan applications, inflated appraisals, or predatory lending practices targeting vulnerable individuals. One of the most egregious manifestations is the fraudulent foreclosure process. In most cases, mortgage companies or financial institutions fail to produce the original “wet-ink” promissory note—the critical document proving the legitimacy of a debt claim. Without this evidence, any attempt to foreclose on a property is legally void under contract law.

#### *Fraudulent Evictions: A Weapon Against the Vulnerable*

Fraudulent evictions often stem from these questionable foreclosures. Families are forcibly removed from their homes (domiciles) based on incomplete or fraudulent documentation. This practice not only devastates lives but also contributes to a broader cycle of disenfranchisement and economic instability.

For Moorish Americans, these actions are particularly harmful as they undermine ancestral claims to land that predate colonial constructs. Evictions often occur in direct violation of treaty

protections, such as the Treaty of Peace and Friendship of 1836, which affirms the sovereignty and rights of Moorish Americans on their own land.

#### *Legal Context: Title 18 USC 1341*

The United States Code Title 18, Section 1341, known as “Fraud and Swindles,” provides a critical framework for addressing these injustices. This statute criminalizes the use of mail or wire communications to execute schemes intended to defraud individuals of money or property.

#### *Key Provisions of Title 18 USC 1341:*

The statute criminalizes the use of mail, courier services, or electronic communications to further such schemes. This law is particularly relevant in cases of mortgage fraud, as many fraudulent practices involve electronic communications, forged documents (including copies of original signed documentation), and misleading/deceptive correspondence designed to deceive homeowners.

#### *A Call to Action for Moorish Americans*

As Moorish Americans, it is imperative to assert our rights and challenge fraudulent practices that threaten our communities. Here are actionable steps to combat mortgage fraud and fraudulent evictions:

- 1. Demand Proper Documentation:** Always request the original promissory note or loan agreement with your wet ink signature when facing foreclosure or eviction proceedings. You should also request all bookkeeping entries and records associated with the alleged promissory note or loan agreement.
- 2. Demand Evidence of Title:** Request evidence of any ‘allodial’ or ‘aboriginal’ title which proves superior rights to the Land upon which your property is situated. “
- 3. Demand Evidence of Money Borrowed:** Request verification of the specie in which the ‘promissory note’ or ‘loan agreement’ is based in; Article I, Section 10, Clause 1 of the Constitution for the United States of America notes that only “gold or silver coin” to be a “tender in Payment of debts”.
- 4. Invoke Treaty Protections:** Reaffirm the applicability of the Treaty of Peace and Friendship to assert adverse claim to ancestral land rights and demand that de facto courts honor these lawful and legal frameworks.
- 5. Educate the Community:** Share knowledge about mortgage fraud and lawful protections to empower others in defending their homes and properties.

6. **File Complaints and Claims:** Report fraudulent activities to commercial consumer protection authorities and pursue lawful recourse within your local Consular Court.

7. **Organize and Advocate:** Build coalitions within the Moorish American and broader communities to push for systemic reforms that address predatory lending and eviction practices.

### **Conclusion**

Mortgage fraud and fraudulent evictions are not just lawful and legal violations—they are assaults on the dignity, sovereignty, and economic stability of our human families and communities. For Moorish Americans, these injustices resonate deeply, challenging our historical and lawful ties to the land.

### **Allodial Title vs. Mortgages and Deeds: Understanding the Key Differences and the Impact of the 1933 Gold Clause**

Property ownership has long been a cornerstone of economic and personal freedom. However, the concepts of allodial title, mortgages, and deeds represent different frameworks for property rights, each with unique implications. This article explores these distinctions and examines the critical role the 1933 Gold Clause played in the evolution of property ownership through mortgages and deeds.

#### **What is Aboriginal Title?**

Aboriginal: First, earliest, existing from the beginning  
Title: As applied to title to land, an exclusive title, or at least a title which excludes all others not compatible with it; an absolute title to land cannot exist at the same time in different persons or in different governments. *Black's Law Dictionary, 4th Edition.*  
Aboriginal titles for Moorish Americans are El, Bey and Ali and must be proclaimed on the public record.

#### **What is Allodial Title?**

Allodial title represents the absolute and sovereign form of property ownership. Under an allodial system, the owner holds the property outright, free from any obligations, liens, taxes, or superior claims from the government or any other authority.

#### **Key Characteristics:**

Absolute Ownership: The property owner has full control without interference. **No Liens or Taxes:** Allodial title exempts the property from property taxes or the risk of foreclosure. **Rare in Modern Systems:** True allodial ownership is uncommon in most jurisdictions today, as most countries have removed the Gold Standard and as de facto governments typically retain a form of sovereignty over land.

#### **Historical Context:**

Allodial title traces back to Europe, where certain properties were granted outright to nobles or freemen without obligations to a lord. In the United States, remnants of allodial title exist in



certain states, but most property today is held under a system that allows for taxation and other claims by the de facto government.

#### **Mortgages and Deeds:**

A Modern Framework in contrast to allodial title, mortgages and deeds represent a feudal system where property “ownership” is intertwined with obligations to third parties.

**Color of Title:** “The appearance, semblance, or simulacrum of title... Any instrument having a grantor and grantee, and containing a description of the lands intended to be conveyed... Such an instrument purports to be a conveyance of the title, and because it does not, for some reason, have that effect, it passes only color or the semblance of a title. To constitute “color of title” there must be a paper title to give color to the adverse possession, whereas, a “claim of title” may be shown wholly by parol [word, speech].” *Black's Law Dictionary, 4th Edition.*

By the definition above, all deeds and any “paper title” (such as a certificate of title) are examples of color of title and do not represent a lawful claim. A deed cannot and does not transfer title nor indicate ownership. The only way to make claim is by proclamation of Nationality and birthright.

**Fee Simple/Feudal:** “Pertaining to feuds or fees...having the quality of a feud, as distinguished from allodial.” *Black's Law Dictionary, 4th Edition.*

**Dead Pledge:** “A mortgage” *Black's Law Dictionary, 4th Edition.*  
Deeds and mortgages subjugate the alleged borrower to the feudal system of registration fees, taxes, and liens which the borrower “pays” for either indirectly with their energy (in exchange for debt notes under the misnomer “money”); or directly by putting up their home as collateral “in exchange for a promise of greater wealth” (Silent Weapons for Quiet Wars). That promise of greater wealth is the alleged “loan” granted via the mortgage, which upon further investigation, is proven not to exist.

### ***Key Differences from Allodial Title:***

**Conditional “Ownership”:** Under the feudal system, “ownership” via a mortgage is contingent upon fulfilling certain terms and obligations. This is a feudal/tenancy structure which allows possession without true ownership.

**Tax Obligations:** All mortgages are registered within the feudal record keeping system known as the recorder of deeds and subjected to taxes (fees) in perpetuity.

**Government Oversight:** Property rights under deeds and mortgages are subject to de facto government regulations and liens.

### ***The Role of the 1933 Gold Clause in Shaping Modern Property Ownership:***

The transition from more sovereign forms of property ownership to the current system of mortgages and deeds was heavily influenced by the economic changes of the early 20th century, particularly the 1933 Gold Clause.

### ***What Was the Gold Clause?***

Before 1933, contracts and debts in the United States often included a “gold clause,” requiring repayment in gold or a specific value equivalent in gold. This clause provided stability and value assurance in financial transactions.

### ***The 1933 Gold Standard Abandonment:***

In response to the Great Depression, President Franklin D. Roosevelt’s administration: ***Suspended the Gold Standard:*** The U.S. abandoned the gold-backed currency, making the dollar a fiat currency.

***Invalidated Gold Clauses:*** All contracts requiring repayment in gold were nullified, forcing creditors to accept repayment in paper currency instead.

### ***Impact on Property Ownership:***

The shift to fiat currency and the invalidation of the gold clause had profound implications:

***Increased Use of Mortgages:*** The devaluation of the dollar and lack of gold-backed security made borrowing (mortgages) more attractive and necessary for property transactions.

### ***Government Oversight:***

Property ownership became increasingly regulated, as the fiat system enabled taxation and other governmental claims on property.

### ***Conclusion***

The concept of property ownership has changed significantly over time. While allodial title represents absolute ownership free from external obligations, modern systems like mortgages and deeds tie property rights to financial and governmental structures. The 1933 Gold Clause’s invalidation marked a turning point, embedding fiat currency into property transactions and solidifying the dominance of mortgages and deeds over sovereign ownership.

Understanding these distinctions allows individuals to navigate the complexities of property ownership and recognize how historical events shape modern systems.

### ***Article I, Section 10, Clause 1 of the United States Constitution of North America***

This clause ensures that individual states cannot engage in certain activities that would conflict with federal authority or undermine the structure of the Union. The text reads:

*“No State shall enter into any Treaty, Alliance, or Confederation; grant Letters of Marque and Reprisal; coin Money; emit Bills of Credit; make any Thing but gold and silver Coin a Tender in Payment of Debts; pass any Bill of Attainder, ex post facto Law, or Law impairing the Obligation of Contracts, or grant any Title of Nobility.”*

Countrywide Bank (2003-2008): Wennes served in leadership capacities, further honing his expertise in retail financing and mortgage lending. MUFG Union Bank (2008-2019): As West Coast President and Head of the Regional Bank, he oversaw multiple financing sectors.

In September 2019, Wennes joined Santander as President and CEO of Santander Bank, N.A., and by December 2019, he was appointed Santander US CEO and Country Head. Monday January 06, 2025 G.C.Y, Empress Salome and Goddess Bey prepare for a conversational interview about Goddess Bey's successful mortgage dispute against SANTANDER (Inc.), brought to you by Maghrib Times podcast. In this interview, Goddess Bey expresses her feelings of peace and amazement after successfully gaining control of her ancestral estate without the burden of a mortgage. Empress Salome asks how Goddess Bey achieved this peaceful state and what the first step was. The conversation opens with a Moorish American prayer led by Empress Salome. Before starting, the production team lead the hostess and interviewee with a guided group visualization exercise to center everyone's energy and to connect to their higher power.

Goddess and Empress discussed the process of nationalizing and disputing a mortgage. Goddess Bey explained that nationalizing involves decolonizing, enforcing birthrights, and disputing de facto corporations. She shared her experience of disputing a mortgage, which involved studying, taking action, and standing on principles and truth. Goddess Bey also mentioned her decision to make a formal complaint to the FTC and CFPB. Empress Salome asked about the significance of these organizations, and Goddess explained that they hold registered companies accountable for fraudulent activities.

The conversation ended with Goddess Bey stating that she is not expecting any further responses from SANTANDER (Inc.), and Empress Salome asked her to summarize her experience for which others could learn. As the conversation continues, Goddess Bey and Empress Salome discussed their experiences with nationalization and the importance of leading the next generation. Empress Salome asked Goddess Bey to elaborate on the nature of the affidavit of dispute she sent via certified mail to which Goddess Bey responded that it is due process of law and should be based on truth. Goddess Bey also mentioned that she is unsure about her next steps but will continue to push forward in love, truth, peace, freedom, and justice.

As stated in Black's Law Dictionary, 5th Edition, nationality is the official connection or belonging a person has to a specific country or nation. It shows where you are recognized as a member and is tied to the rights, responsibilities, and protections you receive from that nation.

*Nationality and status are closely linked: status refers to your recognized position or rank within a system or society, and nationality plays a pivotal role in defining that position.*

### Nationality and Leadership: Lessons from Captain Ibrahim Traoré

Captain Ibrahim Traoré of Burkina Faso exemplifies the power of nationality as a unifying force. His leadership emphasizes the importance of national identity in resisting external exploitation. By asserting the sovereignty of Burkina Faso and prioritizing the well-being of its indigenous people, Traoré demonstrates how understanding and embracing nationality can empower a nation to resist geopolitical pressures. His actions remind us that a strong sense of national identity is not just symbolic but a practical tool for self-determination.

### Nationalization vs. Naturalization: What's the Difference?

The terms **nationality**, **nationalization**, and **naturalization** are often confused. Here's how they differ:

- Origin:** Nationality is inherent, usually determined by birth or lineage. Naturalization is a legal process where an individual acquires citizenship in another country. Nationalization is simply another word for decolonization which is a process where a National acquires standing in law to defend and reclaim his/her birthright.
- Purpose:** As stated in the **Moorish literature**, individuals that fail to recognize their free national name are considered as "**undesirables**", and are subject to all abuses and mistreatments that citizens care to place upon them. In simpler terms, without you proclaiming your true identity you render yourself powerless as it pertains to global affairs and your posterity. **Naturalization** grants legal privileges and burdens as a citizen. Nationalization focuses on

the economic or strategic interests of a nation.

- Process:** Naturalization involves integration into a jurisdiction via application, like residency and exams. Nationality is typically automatic, tied to birth or ancestry. Also known as Jus Sanguinis (right of blood). Often Recognized globally providing protection of inalienable rights. Understanding these distinctions highlights the multifaceted importance of nationality in both individual and national contexts.

### Why "Black" is Not a National Identity

The term "Black" (or black codes) is a racial classification and does not constitute a national identity. This distinction is crucial for reclaiming authentic ties to heritage and ancestry. Historical frameworks like the **1724 Louisiana Code Noir**, also known as the "Christian Black Codes," illustrate how labels were used to strip individuals of their true national connections.

#### Three key facts about the Code Noir:

- It mandated the conversion of enslaved Asiatics (negroes) to Christianity, disconnecting them from their cultural and national identities.
- The codes categorized individuals solely by race, severing their ties to their ancestral nations.
- It reinforced systemic control by denying enslaved Moorish subjects the legal recognition of their heritage, reducing them to property under colonial rule.

These laws demonstrate the deliberate erasure of national identity, making it essential for individuals today to understand and reclaim their true nationality.

### In Closing

To be nationalized means to claim your birthright. To declare our ancestral identity is declaring our nationality which was a requirement for u.s. citizenship.

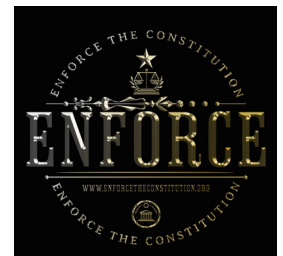
Religious practices and behavior is how to be one with Allah. All humanity is divided into nations, and each nation has its own religion and culture we must follow.

# Burkina Faso Sets a Nationalization Pattern to Follow, Starting with Gold Mines

Have you heard about what is taking place across the Atlantic Ocean right now? The West African country, Burkina Faso, and president, Ibrahim Traore, have been all the talk amongst international media outlets since the nationalization of two major gold mines took place in August of 2024. Burkina Faso, which translates to “land of upright people”, has taken a stand against colonization in many ways, one being that the nation has reclaimed control over its most lucrative natural resource, gold. Having previously been a land of people that appeared to be anything but upright, Burkina Faso had been subjected to the fate of foreign military occupation, greedy politicians, and constant exploitation from foreign corporations. So how did a supposed “3rd world country” get the audacity to stand on its feet, reclaim its independence and speak so loudly about it? Let’s peep the pattern.

## ***Colonization***

Colonialism has done a number on the Asiatic nations across the earth. Burkina Faso was a part of France’s imperial expansion in the late 19th and early 20th centuries, being 1 of 8 colonial territories that came to be known as “French West Africa”. It was under the influence of rapacious French colonizers and corrupt politicians that a painful and permanent scar was left on Burkinabe society. Under French rule, traditional political systems were dismantled. The natural resources of the land were exploited. The local populace faced economic negligence and escheatment. Sound familiar?

## ***Enough is Enough***

Ibrahim Traore, a former military captain now occupying the seat of president since September of 2022 by way of coup d’etat, has been a trailblazer in paint-

ing a new face of sovereignty and economic autonomy for Burkina Faso. The spirit of former revolutionaries and countries who have fought to put an end to colonialism rings alarms in our ears, and we hear the battle cries of nations like Burkina Faso ever so clearly.

“Homeland or death, we will prevail,” president Traore announced in July 2023 at the Russia-Africa summit. These were the very same words spoken by Cuban revolutionary, Che Guevara, back in his 1964 United Nations speech. These words lead to what eventually became the nationalization of Cuba.

Now President Traore is leading Burkina Faso down the same path as Guevara, as well as many more who have risked their lives fighting to decolonize the people and the resources of the land.



## ***What’s to Come***

By making claim to the gold mines, as well as relinquishing reliance on foreign labor, Burkina Faso’s economy will benefit greatly from the wealth of the gold reserves. A gold refinery has even been established, which is bound to increase national revenue and will open doors to establishing funding for public services, infrastructure, and social programs. The possibilities are endless!

Burkina Faso has given us a preview of what nationalization will look like here in North America. While there is much to be gained, we must consider that with great power comes even greater responsibility. When making claim to our estate, whether that be a house, a natural resource, the titles of ‘El’ or ‘Bey’, it would be to our greatest benefit to study the pattern of Burkina Faso. We, too, have the power and audacity to rise and stand upright with our brothers and sisters across the Atlantic Ocean.

4. “Watch the newspaper and listen to the radio, I am going to make the European tell the truth.”

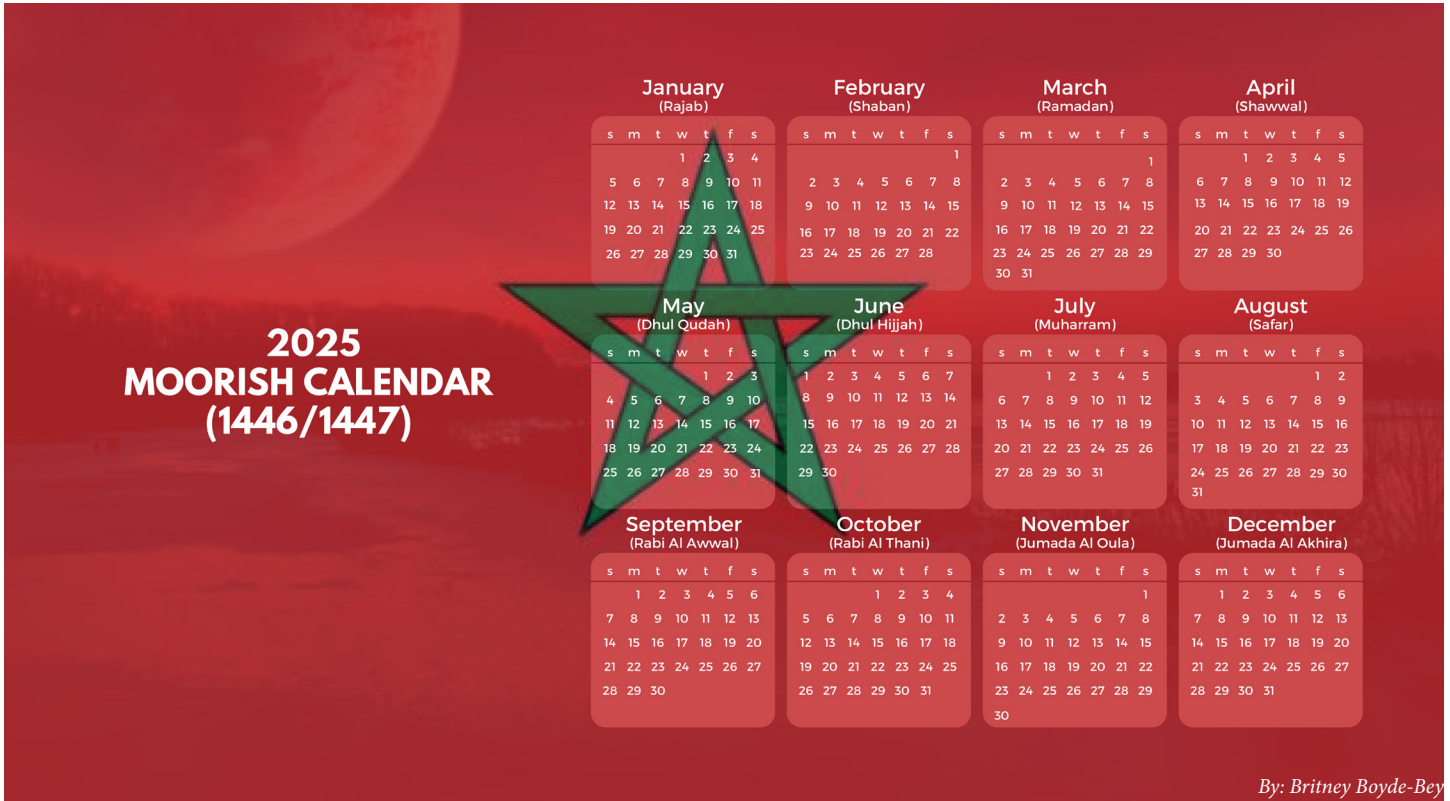

## The Evolution of the Calendar: Unveiling Time and Its Discrepancies

“Time never was, when man was not.” These profound words serve as a cornerstone for understanding humanity’s relationship with time, a construct shaped by both celestial observation and cultural adaptation. The calendar, humanity’s tool for measuring time, has undergone significant transformations over millennia, shaped by astronomical events, religious influences, and political agendas. However, few recognize the depth of its evolution and the discrepancies that challenge its integrity—especially within the

context of the Moorish legacy and the so-called “Gregorian reforms.”

### The Origins of the Calendar

The earliest calendars were based on lunar and solar cycles, reflecting the intimate relationship ancient civilizations had with celestial bodies. In Kemet (ancient Egypt), the solar calendar was divided into 12 months of 30 days, with five additional days, aligning closely with the Earth’s rotation around the sun. Similarly, ancient Sumerians and Mayans demonstrated

sophisticated astronomical knowledge, creating systems that mirrored the natural rhythms of the cosmos. The Romans later introduced the Julian calendar, named after Julius Caesar in 45 BCE. This calendar attempted to correct discrepancies caused by earlier systems by instituting a 365-day year with a leap year every four years. However, inaccuracies persisted, leading to the Gregorian calendar reform in 1582, commissioned by Pope Gregory XIII. This reform, which remains in use today, adjusted

the leap year system and realigned the calendar with the equinoxes.

### Timeline of when the Gregorian calendar was introduced

The Gregorian calendar was introduced into Moorish American consciousness in 1752 (M.C.Y. 1172) and removed eleven days from September 1752. It also established January 1 as the start of the new year. For example, the Moorish Calendar Year of 1025 was translated into the Gregorian calendar year of 1605 after adoption in 1752.

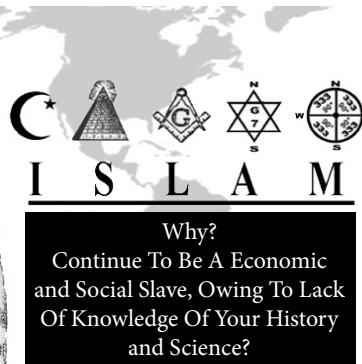

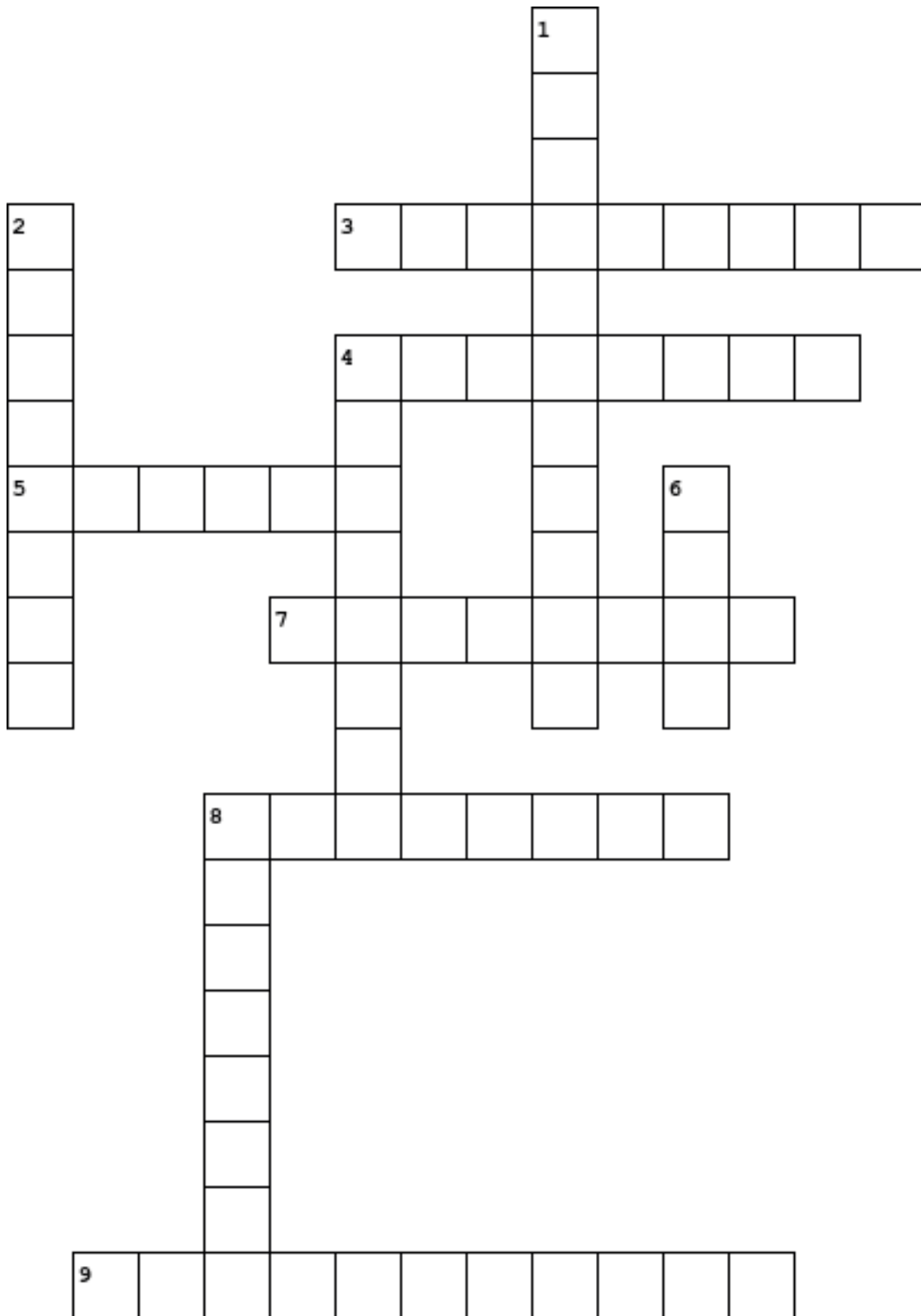
