COMES NOW I, Lamont Maurice Butler-El (also known as Lamont Maurice El,) being
of legal age, and being duly affirmed according to law, hereby execute this Writ of Quo Warranto

as an objection to the release of information related to my Google email account enforcetheconstitution@gmail.com by Pichai Sundararajan (also known as Sundar Pichai) (the “Third Party”) or by his agent and / or assign, and to inquire into the color of authority and jurisdiction of Marcus G. Jones, Kevin G. Hessler, John J. McCarthy, the foreign corporate MONTGOMERY COUNTY POLICE DEPARTMENT (Inc.), and the foreign corporate CIRCUIT COURT FOR MONTGOMERY COUNTY (Inc.) (the “Defendants”). In support thereof, I assert the following:

PARTIES

1. Plaintiff Lamont Maurice Butler-El (also known as Lamont Maurice El), a natural person, in full life, in propria persona, sui juris, aboriginal and indigenous Moorish American national of the Moroccan Empire at Maghrib Al-Aqṣá, North-West Amexem / North America by *jus sanguinis* (right of blood), having a mailing location of C/o P.O. Box 2281, Washington, District of Columbia republic. I am the elected Consul General of the Consulate General of Morocco at the Maryland state republic. I am properly identified by my Allodial National Identification Card, which is registered under certification number AA 222141, Class A, with the Zodiac Constitution in the Library of Congress Copyright Office at Washington, District of Columbia, and the United States Department of Justice.
2. Defendant Marcus G. Jones is a stateless person subject male under the unconstitutional 14th Amendment U.S. corporate citizenship clause, and a resident of Maryland having a mailing address known as 100 Edison Park Drive, 3rd floor, Gaithersburg, Maryland republic [near. 20878]. Defendant Marcus G. Jones is also an employee / contractor acting as Chief of Police of the private foreign for-profit corporate entity MONTGOMERY COUNTY POLICE DEPARTMENT (Inc.) within purview of the unconstitutional 14th Amendment. The MONTGOMERY COUNTY POLICE DEPARTMENT (Inc.) is a private foreign for-profit

religious corporation established under the unconstitutional 14th Amendment U.S. corporate citizenship clause and is entirely separate from the de jure Maryland state republican government sanctioned under Article IV, section 4 of the Constitution for the United States of North America.

3. Defendant Kevin G. Hessler is a foreign occidental European subject male under the unconstitutional 14th Amendment U.S. corporate citizenship clause, and a resident of Maryland having a mailing address known as 50 Maryland Avenue, Rockville, Maryland republic [near. 20850]. Defendant Kevin G. Hessler is also an employee / contractor acting as Associate Administrative clerk of the private foreign corporate entity CIRCUIT COURT FOR MONTGOMERY COUNTY (Inc.) within purview of the unconstitutional 14th Amendment. The CIRCUIT COURT FOR MONTGOMERY COUNTY (Inc.) is a private foreign for-profit religious corporation established under the unconstitutional 14th Amendment U.S. corporate citizenship clause and is entirely separate from the de jure Maryland state republican government sanctioned under Article IV, section 4 of the Constitution for the United States of North America.
4. Defendant John J. McCarthy is a foreign occidental European subject male under the unconstitutional 14th Amendment U.S. corporate citizenship clause, and a resident of Maryland having a mailing address known as 50 Maryland Avenue, 5th floor, Rockville, Maryland republic [near. 20850]. Defendant John J. McCarthy is also an employee / contractor acting as State's Attorney for the OFFICE OF STATES ATTORNEY FOR MONTGOMERY COUNTY within purview of the plausible 14th Amendment.
5. Third Party Pichai Sundararajan (also known as Sundar Pichai) is a stateless person subject male under the unconstitutional 14th Amendment U.S. corporate citizenship clause, and a resident of California having a mailing address known as 1600 Amphitheatre Pkwy, Mountain

View, California republic [near. 94043]. Third Party Pichai Sundararajan is also an employee / contractor acting as Chief Executive Officer of the foreign corporate entity GOOGLE LLC. / GOOGLE Inc. within purview of the plausible 14th Amendment.

JURISDICTION AND VENUE

1. Jurisdiction in this case is based on diversity of nationality and consular jurisdiction.
2. I am an aboriginal and indigenous Moorish American national of the Moroccan Empire at Maghrib Al-Aqşá, North-West Amexem / North America by *jus sanguinis*, and an inhabitant at the Maryland state republic under the consular jurisdiction of the Consulate General of Morocco at the Maryland state republic. As such, I am classified as a “foreign national” as that term is used for the purposes of consular notification and the instructions in the United States Department of State Consular Notification and Access manual 5th Edition 2018.
3. The Defendants, Marcus G. Jones, Kevin G. Hessler, and John J. McCarthy, are U.S. corporate citizens under the unconstitutional 14th Amendment U.S. corporate citizenship clause and are residents at the Maryland state.
4. The Third Party Pichai Sundararajan is a U.S. corporate citizen under the unconstitutional 14th Amendment U.S. corporate citizenship clause and a resident at the California state.
5. This Morocco Consular Court at the Maryland state republic has competent jurisdiction and proper venue to hear and decide this case under consular jurisdiction at the Maryland state republic by authority of Articles 20 and 21 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire, and Article III, section 2, and Article VI, section 2 of the Constitution for the United States of North America.

STATEMENT OF FACTS

6. On Wednesday February 3, 2021, at 4:58 PM (Eastern Standard Time) I received an email from the Third Party by and through his agent / unidentified employee - contractor of

GOOGLE LLC. / GOOGLE Inc. (Legal Investigations Support) regarding an alleged legal process (reference or case number 200051000) being sent from an undisclosed employee / contractor of the MONTGOMERY COUNTY POLICE DEPARTMENT (Inc.) compelling the release of information related to the Google email account enforcetheconstitution@gmail.com which contains my private and personal information. See attachment EXHIBIT: A1.

7. On Wednesday February 3, 2021, at 8:37 PM (Eastern Standard Time) I sent an email response to the Third Party by and through his agent / unidentified employee - contractor requesting for the alleged legal process (reference or case number 200051000) to be forwarded to me for full disclosure purposes. See attachment EXHIBIT: A1.
8. On Monday February 8, 2021, at 2:49 PM (Eastern Standard Time) I received another email response from the Third Party by and through his agent / unidentified employee - contractor which asserted that the copy of the alleged legal process was attached to the email. The attachment was a one (1) page unsigned misrepresented instrument titled SEARCH AND SEIZURE WARRANT IN MONTGOMERY COUNTY, MARYLAND dated January 26, 2021, with the typed name on the signature line of the Defendant, "Kevin Hessler". Some of the information on the instrument was blacked out. However, I was never given proper service of process of any physical written proof of a valid and verifiable 4th Amendment search and seizure warrant being signed and issued by an actual Article III Court of competent jurisdiction for the search and seizure of the information related to the Google email account enforcetheconstitution@gmail.com; nor was I given proof of a written accusation being signed under oath or affirmation asserting probable cause of an alleged injury caused by me. See attachment EXHIBIT: A2.

QUO WARRANTO

9. THE DEFENDANTS AND THIRD PARTY ARE HEREBY COMMANDED to produce the following as proof of jurisdiction and lawful authorization for the release of my private and personal information related to my Google email account enforcetheconstitution@gmail.com:
- a. A certified copy of an alleged lawful search warrant signed and issued by an Article III Court of competent jurisdiction with the attached written accusation in support being signed under oath or affirmation by an alleged injured party pursuant to the 4th Amendment of the Constitution for the United States of North America.

DAYS OF GRACE TO ANSWER

10. The Defendants and Third Party has seven (7) days from the receipt of this Affidavit of Fact: Writ of Quo Warranto to answer and produce the above evidence.

DEFAULT

11. Failure to answer and rebut the above information, point-by-point, on an affidavit signed under oath or affirmation constitutes default, and served as conclusive proof of the Defendants conspiring to deprive me of my 4th Amendment secured right of privacy under color of law via the unsigned misrepresented instrument titled SEARCH AND SEIZURE WARRANT IN MONTGOMERY COUNTY, MARYLAND dated January 26, 2021, which is invalid, unconstitutional, notwithstanding, null and void ab initio, and unenforceable for lack of jurisdiction and fraud. See **United States v. Throckmorton**, 98 U.S. 61, 25 L.Ed. 93 (*"Fraud vitiates the most solemn contracts, documents, and even judgments."*); and see **Morison v. Coddington**, 662 F.2d. 155, 135 Ariz, 480 (1983) (*"Fraud and deceit may arise from silence where there is a duty to speak the truth, as well as from speaking an untruth."*).
