Memorandum

On or about January 10, 2024, the Affidavit of Fact: Writ of Quo Warranto [Exhibit: A], Affidavit of Fact: Adverse Claim of Title and Reversion of Ancestral Estate, and the Memorandum of Trust were entered in the records of the misrepresented instrument – bill of attainder / foreign bill of exchange titled case number C-16-CV-23-002644, and the same were duly served upon you at your present mailing address, and you were given three (3) days from that date to answer and prove your jurisdiction. You failed to answer and prove jurisdiction which constitutes default.

The misrepresented instrument – bill of attainder / foreign bill of exchange titled case number C-16-CV-23-002644 is a collusive action within purview of the unconstitutional 14th Amendment for the purpose of you (in collusion with others) attempting to deprive me of my property by way of fraud and under color of law; and the CIRCUIT COURT FOR PRINCE GEORGES COUNTY (Inc.) is not an Article III court of competent jurisdiction, and was not lawfully delegated judicial authorization from Congress to hear and decide “cases and controversies” under Article III section 1 and 2 of the Constitution for the United States of North America. See *Elliot v. Peirsol*, 26 U.S. 328, 340 (1828) (“*Courts are constituted by authority and they cannot act beyond the power delegated to them. If a court acts without authority, its judgments and orders are regarded as nullities. They are not voidable, but simply void; and form no bar to a remedy sought in opposition to them, even prior to a reversal. They constitute no justification; and all persons concerned in executing such judgments, or sentences, are considered, in law, as trespassers.*”); and see *United States v. Throckmorton*, 98 U.S. 61, 25 L.Ed. 93 (“*Fraud vitiates the most solemn contracts, documents, and even judgments.*”).

Wherefore, it is hereby **ORDERED AND ADJUDGED** that a writ of error be and the same is hereby entered against you, Mahasin El Amin, Jeffrey Nadel, Scott Nadel, and Daniel Menchel;

It is further **ORDERED AND ADJUDGED** that the collusive action and de facto administrative proceedings under color of law in case number C-16-CV-23-002644 in the records of the foreign CIRCUIT COURT FOR PRINCE GEORGES COUNTY (Inc.), including any scheduled de facto administrative hearing and alleged "foreclosure sale", and any other attachments associated thereto are UNCONSTITUTIONAL, NOTWITHSTANDING, NULL and VOID AB INITIO, and are UNENFORCEABLE for lack of jurisdiction and fraud.
