In order to be free from incarceration pending final disposition of the charges against me, I, the Defendant, agree as follows:

1. To personally appear, whenever and wherever required, in the Circuit Court in which the charges may be pending, or in any Court in which a charging document may be filed based on the same acts or transactions, or to which the cause may be transferred, removed, or, if from the Circuit Court, appealed.
2. To keep the peace and be of good behavior in the meantime.
3. To abide by the following special conditions checked below:
 - To not change residence or leave the State of Maryland without first securing the permission of the Court in which the charges are pending. If granted permission to leave the State of Maryland, that I hereby waive extradition to the state of Maryland and agree not to contest any effort to return me to the State of Maryland.
 - To be released into the custody of and be subject to the supervision of pending disposition of the charges.
 - To be placed under the supervision of _____.
 - Other: Defendant to be released on electronic monitoring, to a company licensed in Maryland, not to be supervised by Diego Bonds; EM must be in place prior to release; no contact with victims.

NOTICE

I, the undersigned Defendant, do hereby acknowledge that I have been advised of the above conditions of my release and received a copy thereof, and I understand that if the recognizance is forfeited and I willfully fail to surrender myself within 30 days following the date of forfeiture, in addition to any sentence which I might receive for any offense with which I am now charged, I may be sentenced as follows:

- a. If given in connection with a charge of felony or pending an appeal, certiorari or habeas corpus proceeding, I may be fined not more than \$5,000 or imprisoned for not more than 5 years or both.
- b. If given in connection with a charge of committing a misdemeanor, I may be fined not more than \$1,000 or imprisoned for not more than 1 year or both.

I further acknowledge that, in addition, the Court may at any time revoke the order of release or amend it to impose additional or different conditions of release and issue a warrant for my arrest immediately upon violation of the conditions of my release.

And, finally, I acknowledge that I have been initially directed and do agree to appear:
