Your claim of an alleged debt associated with account / folio number: 56826 is hereby disputed in accordance with my prerequisite 'due process rights' secured under Article III section 2, and the Amendment 5 of the Constitution for the United States of North America.

Declaration of Nationality - Citizenship and Status

For the record, I am Lamont Maurice El, a natural person, in full life, in propria persona, sui juris, in solo proprio. I am first nation, and my nationality / citizenship is Moorish American, being an aboriginal and indigenous heir apparent and national of the Moroccan Empire at North-West Amexem / North America. I am a foreign national inhabitant near the foreign corporate ALEXANDRIA, Virginia commonwealth republic, and authorized representative, ex rel. LAMONT BUTLER-EL (a transmitting utility).

Jurisdiction and Venue

I hereby invoke my treaty rights to consular jurisdiction in this dispute under Articles 20 and 21 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire, which aver the following:

Article 20. If any of the citizens of the United States, or any persons under their protection, shall have any dispute with each other, the Consul shall decide between the parties; and whenever the Consul shall require any aid, or assistance from our government, to enforce his decisions, it shall be immediately granted to him.

Article 21. If a citizen of the United States should kill or wound a Moor, or, on the contrary, if a Moor shall kill or wound a citizen of the United States, the law of the Country shall take place, and equal justice shall be rendered, the Consul assisting at the trial; and if any delinquent shall make his escape, the Consul shall not be answerable for him in any manner whatever.

Discovery and Disclosure

You are hereby commanded to produce proof of the following via certified mail:

1. Produce evidence of an alleged 'Allodial title' or 'Aboriginal title' to my inherited ancestral estate in reversion known as 2345 Mill Road, ALEXANDRIA, Virginia, which would prove beyond reasonable doubt that you and / or your foreign de facto corporate entity known as CORPORATION SERVICE COMPANY (Inc.) / MHF ALEXANDRIA V LLC to be the absolute owner of the said estate in reversion; and
2. Produce on an affidavit signed under penalty of perjury the specific specie that you are accepting as "payment" for the satisfaction of the alleged debt associated with account / folio number 56826:
 - a. gold and silver coins which is the lawful money (dollars) used to pay all debts per Article 1 Section 10, Clause 1 of the Constitution for the United States of North America; or
 - b. private corporate commercial paper (Federal Reserve Notes) and securities (Checks) which are unconstitutional counterfeit coins and do not constitute payment of any debt.

Counter Claim

Your claim of an alleged debt associated with account / folio number: 56826 is unconstitutional, notwithstanding, null and void ab initio for fraud in the inducement on the following grounds:

1. You and your foreign de facto company, CORPORATION SERVICE COMPANY (Inc.) / MHF ALEXANDRIA V LLC, do not hold or possess 'Aboriginal title' or 'Allodial title' to my ancestral estate in reversion known as 2345 Mill Road, ALEXANDRIA, Virginia commonwealth republic.
2. (See attached documents titled Affidavit of Fact: Adverse Claim of Title and Reversion of Ancestral Estate [Exhibit: B] and Memorandum of Trust).
3. From February 24, 2021, until about August 27, 2022, I was coerced by the several agents / employees / contractors of your foreign company, CORPORATION SERVICE COMPANY (Inc.) / MHF ALEXANDRIA V LLC, to tender 57,715 in fiat / credit via credit card(s) ex rel. LAMONT BUTLER-EL under color of law regarding the alleged debt associated with account / folio number: 56826 which constitutes fraud in the inducement. See **EXHIBITS: A1 and A2** attached hereto; and see **United States v. Throckmorton, 98 U.S. 61, 25 L.Ed. 93** ("*Fraud vitiates the most solemn contracts, documents, and even judgments.*").

4. The alleged debt associated with account / folio number 56826 and any other attachments associated thereto are acquitted and discharged in accordance with and in reliance on Title 12 USC §95a (2):

Title 12 U.S. Code § 95a-Regulation of transactions in foreign exchange of gold and silver; property transfers; vested interests, enforcement and penalties.

(2) Any payment conveyance, transfer, assignment, or delivery of property or interest therein, made to or for the account of the United States, or as otherwise directed, pursuant to this section or any rule, regulation, instruction, or direction issued hereunder shall to the extent thereof be a **full acquittance and discharge for all purposes of the obligation of the person making the same**; and no person shall be held liable in any court for or in respect to anything done or omitted in good faith in connection with the administration of or in pursuance of and in reliance on, this section, or any rule, regulation, instruction, or direction issued hereunder.

attempt to clear up any misrepresentations or confusion concerning your claim of an alleged debt in account / folio number 56826.



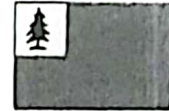

Stare Decisis Law

"A state cannot refuse to give foreign nationals their treaty rights because of fear that valid international agreements may possibly not work completely to the satisfaction of state authorities. Under the supremacy clause of the United States Constitution Art. VI, clause 2, state policies as to the rights of aliens to inherit must give way to overriding federal treaties and conflicting arrangements." See *Kolovrat v. Oregon*, 366 U. S. 187, 194, 81 S.Ct. 922 (1961)

I, Lamont Maurice El, sui juris, an aboriginal and indigenous Moorish American sovereign national of the Moroccan Empire at Maghrib al Aqṣá, North-West Amexem / North America, being of legal age, after being duly affirmed according to law, hereby depose and state the following:

1. I am first nation, being a surviving *consanguinity* heir apparent of the late ancient Moabites (modernly known as Moroccans) from the land of Moab who received permission from the Pharaohs of Kemet to settle and inhabit North-West Africa (Amexem); they were the founders and are the true possessors of the present Moroccan Empire, with their Canaanite, Hittite, and Amorite brethren who sojourned from the land of Canaan seeking new homes. Their dominion and inhabitation extended from North-East and South-West Africa, across the great Atlantis even unto the present North, South, and Central America and also Mexico and the Atlantis Islands, before the great earthquake, which caused the great Atlantic Ocean.
2. My nationality / citizenship and political status as an aboriginal indigenous Moorish American sovereign national of the Moroccan Empire and direct descendant of the ancient Moabites (Moroccans) by *jus sanguinis*, is recognized under registration number ©AA 222141, Class A, with the Clock of Destiny Moorish American National Identification Card and Zodiac Constitution recorded by Charles Mosley Bey, a Moorish

American and my kin by consanguine, on September 10, 1952, in the Library of Congress Copyright Office, Washington, District of Columbia, and the United States Department of Justice.

3. My Moabite ancestors died intestate, and was vested with reversionary interest in the lands and resources of the Moroccan Empire at North America, which is in de facto occupational use, in usufruct, by the foreign hybrid European colonists exercising feudal law practices under color of law as citizens / members / beneficiaries of the UNITED STATES (Inc.) under the expired fifty (50) year mandate, i.e., the Treaty of Peace and Friendship of 1836 (in force 1837) between the United States of North America and the Moroccan Empire; which superseded the Treaty of Peace and Friendship of 1787 between the United States of America, and his Imperial Majesty the Emperor of Morocco. This treaty is the supreme Law of the Land under the 'Supremacy Clause' of the Constitution for the United States of North America Article VI, clause 2. Article 25 of the aforesaid Treaty of 1836 avers the expiration term as follows:

Article 25. This Treaty shall continue in force, with the help of God, for fifty years; after the expiration of which term, the Treaty shall continue to be binding on both parties, until the one shall give twelve months' notice to the other of an intention to abandon it; in which case, its operations shall cease at the end of the twelve months."

4. Per my treaty right to inherit under Article 22 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire, and in accordance with the international law provisions of the United Nations Declaration on the Rights of Indigenous Peoples, I am competent to make claim to my inherited

ancestral estate in reversion as a surviving rightful heir apparent, which is being held in trust de facto by the foreign corporate COMMONWEALTH OF VIRGINIA (Inc.) and subsidiaries (feoffors) as escheated fee simple property under color of law within purview of the unconstitutional 14th Amendment to the United States Constitution. Per the stare decisis law in the *Kolovrat* case mentioned above, my treaty right to inherit property under Article 22 of the said Peace Treaty of 1836 overrides all state policies that are made to the contrary, which aver the following:

Article 22. If an American citizen shall die in our country and no will shall appear, the Consul shall take possession of his effects, and if there shall be no Consul, the effects shall be deposited in the hands of some Person worthy of Trust, until the Party shall appear who has a right to demand them, but if the Heir to the Person deceased be present, the property shall be delivered to him without interruption; and if a will shall appear, the property shall descend agreeable to that will, as soon as the Consul shall declare the validity thereof.

5. I hereby make an adverse claim of aboriginal title to my ancestral estate in reversion as described below, to wit:

ALL that certain plot, piece or parcel of land with resources, buildings and improvement thereon erected, situated, lying and being, known to be located near corporate WELCOME, Maryland republic, known by the street address of 2345 Mill Road, Alexandria, Virginia, at Maghrib al Aqşá, North-West Amexem, and geographically located on the North American continent within the dominions of the Moroccan Empire at Maghrib al Aqşá, North-West Amexem, Latitude

38.802780, Longitude -77.067510, GPS (Global Positioning System) coordinates
38° 48' 10.008" North; and 77° 4' 3.036" West;

6. This claim is made pursuant to the aboriginal land tenure systems, traditions, and customs of my ancient Moabite Foremothers and Forefathers in accordance with international law under Articles 26, 27, 28, 29, 30, and 37 of the United Nations Declaration on the Rights of Indigenous Peoples.
7. The above-described property is registered in a private allodial trust titled: Allodial Irrevocable Private Living Trust of Lamont Maurice El dated June 1, 2020, which I am the Trustee of; and the document titled Memorandum of Trust shall serve as proof of such trust.
8. 


