Re: Misrepresented instrument – bills of attainder / foreign bills of exchange (no title) dated June 14, 2022.

I am in receipt of your spurious misrepresented instrument (untitled) dated June 14, 2022 and addressed to the fictitious person / nom de-guerre GEORGE EDWARD NEAL BEY (race: Black) under color of law within purview of the unconstitutional 14th Amendment. Your instrument does not constitute an answer or response to anything in accordance with due process of law, and constitutes fraud in the inducement. See **Exhibit C1** attached hereto; and see **United States v. Throckmorton**, 98 U.S. 61, 25 L.Ed. 93 (*"Fraud vitiates the most solemn contracts, documents, and even judgments."*); and also see **Penhallow v. Doan's Administrator's**, 3 U.S. 54, 1 L.Ed 57 (*"inasmuch as every government is an artificial person, an abstraction, and a creature of the mind only, a government can interface only with other artificial persons. The imaginary, having neither actually nor substance, is foreclosed from creating and attempting parity with the tangible. The legal manifestation of this is that no government, as well as any law, agency aspect court, etc. can concern itself with anything other than corporate, artificial persons and the contracts between them."*); and also see **Old Wayne Mut. L Assoc. v. McDonough**, 204 U.S. 8, 27 S.Ct. 236 (1907) (*A court cannot confer jurisdiction where none existed and cannot make a void proceeding valid. It is clear and well-established law that a void order can be challenged in any court"*).

On May 13, 2022, you were served with process at your current address via hand delivery and United States Postmaster Certified Mail with the Affidavit of Fact: Writ of Error [Exhibit A], which stands in the record as conclusive evidence of the misrepresented instruments styled as citation numbers 0CZ0TWL, 0D00TWL, 0D20TWL, 0D30TWL, 0D40TWL, 0D50TWL, 0D60TWL, 0D70TWL and 0D80TWL; and NOTICE TO APPEAR FOR PRELIMINARY INQUIRY dated May 9, 2022, being unconstitutional, notwithstanding, null and void ab initio for lack of jurisdiction and fraud.

On June 13, 2022, you were served with process at your current address via hand delivery and United States Postmaster Certified Mail with the Affidavit of Face: Writ of Error [Exhibit B], which stands in the record as conclusive evidence of the misrepresented instruments, styled as Denial Order dated May 18, 2022, and NOTICE OF TRIAL DATE on June 23, 2022, dated May 16, 2022, in reference to citation numbers: 0CZ0TWL, 0D00TWL, 0D20TWL, 0D30TWL, 0D40TWL, 0D50TWL, 0D60TWL, 0D70TWL and 0D80TWL.
