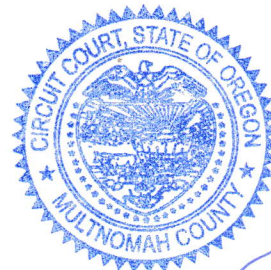

Stare Decisis Law

"If any tribunal finds absence of proof of jurisdiction over a person and subject-matter, the case must be dismissed." See **Louisville v. Motley, 211 U.S. 149, 29 S.Ct. 42.**

On or about October 19, 2020, you were served with process at your current address via certified mail the Affidavit of Fact: Writ of Quo Warranto [Exhibit: A] and the Affidavit of Fact: Rescission of Signature [Exhibit: B]. On or about November 13, 2020, you were served with process at your current address via certified mail the Affidavit of Fact: Adverse Claim of Title and Reversion of Ancestral Estate [Exhibit: C], and the Owner's Aboriginal Title to Allodium [Exhibit: C1]. On or about November 17, 2020, you were served with process at your current address via certified mail the Memorandum of Trust. As of this date, you have failed to answer and have waive your due process right to be heard which constitutes default. Your default constitutes your admission by silence to the validity of the facts and claims made in Exhibits: A, B, C, C1 and the Memorandum of Trust, which includes your indebtedness to me; and such prima facie evidence stands as conclusive proof that the foreign private corporate entity CIRCUIT COURT FOR MULTNOMAH COUNTY (Inc.) lack's jurisdiction, and the collusive

actions in case number 17CV51832 and related case number 20LT04736 and any attachments associated thereto under color of law are null and void ab initio. It is therefore considered:

ORDERED AND ADJUDGED that a default judgment be and the same is hereby entered against you, Leslie M. Roberts, Barbara B. Marcille, John Thomas OSB No. 024691 of MCCARTHY & HOLTHUS, LLP; Kelly D. Sutherland #87357 and James A. Craft #090146 of JANEWAY LAW FIRM, LLC; Mark G. Passannante #944035, of VANTAGE HOMES, LLC, AND RAIN CITY CAPITAL OF OREGON, LLC and Christopher M. Gorman, of KEYBANK NATIONAL ASSOCIATION (hereinafter "Judgment Debtors"), for the following judgment to be recovered by I, Brenulla White-Bey (hereinafter "Judgment Creditor"):

i. The immediate dismissal with prejudice of case number 17CV51832 and related case no. 20LT04736 and any other attachments associated thereto for lack of jurisdiction and fraud;

to, any and all automobiles, boats, aircrafts, real estate, real property, hereditaments, personal property, common property / community property, intellectual property, corporeal property, incorporeal property, bank accounts, future earnings, wages, and pensions in order to secure the performance and payment of this judgment, and to levy upon such property and assets for the satisfaction of this judgment if payment cannot be made;

It is further ORDERED AND ADJUDGED that judgment for possession of the ancestral estate in reversion known as 405 N Lombard Street, Portland, Oregon republic (and more fully described in the Affidavit of Fact: Adverse Claim of Title and Reversion of Ancestral Estate [Exhibit: C]) is granted to the Judgment Creditor, in allodium, as rightful heiress and absolute owner by *jus sanguinis* and Aboriginal title;

In accordance with the 'Full Faith and Credit Clause' of the Constitution for the United States of North America Article IV, section 4, this judgment, and the writ of possession are considered to be made domestic for enforcement in the Oregon state from the file date in case number 17CV51832/ 20LT04736 in the records of the CIRCUIT COURT FOR MULTNOMAH COUNTY (Inc.).
