It is this ___5th ___ day of ____March____, 2021, hereby **ORDERED** that Jafar Abdul Adl El (ex rel. JAFAR ABDUL ADL EL, DOB: 07/02/1982, Race: Black) be forthwith RELEASED without condition or delay;

It is further **ORDERED** that our Sharif and his convoy shall serve and enforce this writ, and the Sheriff for CHARLES COUNTY, Maryland, shall give aid or assistance to our Sharif and his convoy for the enforcement of this writ under consular jurisdiction pursuant to the treaty obligations set forth under Articles 4, 6, 20 and 24 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire;

It is further **ORDERED** that there shall be no cause for the delay in the execution of this writ.



- I, Plaintiff Eric Khalil Bey ("Affiant") ex rel. Jafar Abdul Adl El, being of lawful age, and being first duly sworn upon affirmation, depose and say:
 - 1. I am a Moorish American national of the Moroccan Empire at Maghrib al Aqṣá, North-West Amexem / North America, being an aboriginal and indigenous free Moor / Muur and rightful heir to the land by *jus sanguinis*. My nationality / citizenship and political status is recognized under copyright registration number AA 222141 with our Clock of Destiny Moorish American National Identification Card and Zodiac Constitution in the Library of Congress Copyright Office, Washington, District of Columbia.
 - 2. I am a foreign national inhabitant at the Maryland state republic, and my treaty rights are secured under the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire, which is part of the Supreme Law of the Land under Article VI, clause 2 of the Constitution for the United States of North America.
 - 3. I was delegated to the office of Sharif under consular jurisdiction at the Maryland state republic by the Consul General of Morocco Lamont Maurice El in accordance with the laws and customs of the Moroccan Empire and Zodiac Constitution.
 - 4. I have first-hand knowledge of our Moorish American national Jafar Abdul Adl El being presently kidnapped, denationalized and deprived of his liberty in involuntary servitude while being held hostage for profit as surety for the fictitious corporate person / nom de guerre JAFAR ABDUL ADL EL, DOB: 07/02/1982, (race: black) against his consent under color of state law within purview of the unconstitutional 14th Amendment

under the custody of the Defendant, W. Louis Hennessy, and physical custody of Defendants, Troy D. Berry, and Brandon Foster, at the following location known as:

CHARLES COUNTY DETENTION CENTER (Inc.)
6905 Crain Highway
La Plata, Maryland

- 5. Such first-hand knowledge was provided to me via the verbal testimony and video recording from Brenda El, the mother of Jafar Abdul Adl El who was a witness of the events that took place.
- 6. I further assert that the unlawful imprisonment of Jafar Abdul Adl El includes the following circumstances:
 - a. On February 14, 2021, around 11:30 p.m. at Old Branch Avenue and Allentown Road near corporate CAMP SPRINGS, Maryland, Jafar Abdul Adl El was traveling in his private automobile and was arbitrarily signaled to pull to the side of the road for a commercial (traffic) stop under color of law by three (3) armed highwaymen doing business as employees / contractors of the foreign corporate entity MARYLAND DEPARTMENT OF STATE POLICE (Inc.).
 - b. Jafar Abdul Adl El acted under duress and identified himself with his Moorish American national identification card to the (3) armed highwaymen. The three (3) highwaymen showed wanton disregard of Jafar Abdul Adl El's foreign national standing and committed ultra vires act by compelling Jafar Abdul Adl El to park his automobile and to have someone come to pick it up. T
 - c. The (3) armed highwaymen began to arbitrarily search the person of Jafar Abdul Adl El and seized several of his private and personal property, which included his national identity card, against his free consent and absent of a lawful search and seizure warrant. Eventually Jafar Abdul Adl El's mother arrived on the scene and witness the events that took place via video recording:

- d. Jafar Abdul Adl El was eventually kidnapped by the (3) armed highwaymen and transported to the prison camp facility of the private foreign corporate entity known as CHARLES COUNTY DETENTION CENTER (Inc.), where Jafar Abdul Adl El is presently being held hostage for profit and denationalized under the Black Codes (race: black) under color of law by color of authority within purview of the unconstitutional 14th Amendment. The (3) armed highwaymen acted in collusion with the Defendants, W. Louis Hennessy, Troy D. Berry, Brandon Foster, Patrick H. Loveless and Anthony B. Covington, absent of a lawful arrest warrant and without due process of law in violation of the 4th Amendment 5th Amendments of the Constitution for the United States of North America; and in violation of Jafar Abdul Adl El's secured treaty rights to consular jurisdiction under Articles 20 and 21 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire. See attachment EXHIBIT: A1 in support.
- 7. This Morocco Consular Court at the Maryland state republic has competent jurisdiction under Article III, section 2 of the Constitution for the United States of North America to issue a Writ of Habeas Corpus Ad Subjiciandum for the release of our Moorish American national Jafar Abdul Adl El from the unlawful custody of the Defendants pursuant to the following provisions of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire:

Article 6. (in relevant part) ...if any Moor, not a subject of these dominions, shall make prize of any of the citizens of America, or their effects, and bring them into any of the ports of his Majesty, they shall be immediately released, as they will then be considered as under his Majesty's protection.

Article 20. If any of the citizens of the United States, or any persons under their protection, shall have any disputes with each other, the Consul shall decide between the parties, and whenever the Consul shall require any aid or assistance from our government, to enforce his decisions, it shall be immediately granted to him.

Article 24. If any differences shall arise by either Party infringing on any of the Articles of this Treaty, Peace and Harmony shall remain notwithstanding in the fullest force, until a friendly Application shall be made for an Arrangement, and until that Application shall be rejected, no appeal shall be made to Arms. And if a War shall break out between the Parties, Nine Months shall be granted to all the Subjects of both Parties, to dispose of their Effects and retire with their Property. And it is further declared that whatever indulgences in Trade or otherwise shall be granted to any of the Christian Powers, the Citizens of the United States shall be equally entitled to them.

8. In support of the above treaty rights of Jafar Abdul Adl El, the Supreme Court of the United States issued the following stare decisis law in the case *Kolovrat v. Oregon, 366 U. S. 187, 194, 81 S.Ct. 922 (1961)*:

"A state cannot refuse to give foreign nationals their treaty rights because of fear that valid international agreements may possibly not work completely to the satisfaction of state authorities. Under the supremacy clause of the United States Constitution Art. VI, clause 2, state policies...must give way to overriding federal treaties and conflicting arrangements."


