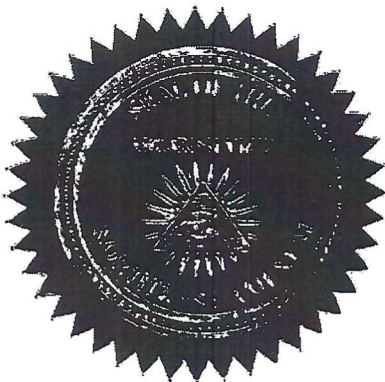

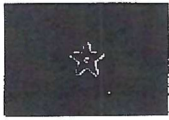

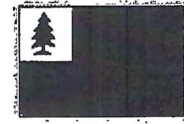

MEMORANDUM

On or about December 29, 2021, the defendants, H. James West, Sharon L. Hancock, Troy D. Berry, Brandon Foster, Anthony B. Covington, and Constance Beatty Kopelman (hereinafter "Defendants") were duly served with process at their mailing address (either directly or by their agent) the Affidavit of Fact: Writ of Quo Warranto [Exhibit: A] from the complainant, Jermain Tyrone Bolden-Bey (hereinafter "Complainant") which was entered in the records of case number C-08-CR-21-000334. The Defendants were given three (3) days from their receipt of the

Writ of Quo Warranto to answer and prove jurisdiction. The Defendants failed to answer and prove jurisdiction which constitutes default.

On or about January 5, 2022, the Defendants were duly served with process at their mailing address (either directly or by their agent) the Affidavit of Fact: Default Judgment [Exhibit: B] from the Complainant which was entered in the records of related case number C-08-CR-21-000334 and ordered for the Defendants to dismiss the case and any other attachments associated thereto for lack of jurisdiction and fraud. There was no cause to the contrary made thereto, however, the Defendants failed to execute their duty which constitutes wanton negligence and breach of duty.

On January 6, 2022, the Defendant, Sharon L. Hancock (et al.), issued a misrepresented instrument - bill of attainder / foreign bill of exchange styled as an Administrative Bench Warrant dated January 6, 2022, being addressed for the fictitious corporate person / nom de guerre JERMAINE TYRONE BOLDEN, Race: Black, under color of law within purview of the unconstitutional 14th Amendment with the intent to kidnap, denationalize, and hold the Complainant hostage for profit as surety for JERMAINE TYRONE BOLDEN (Race: Black) in unlawful imprisonment, absent of a lawful warrant and without due process of law in violation of Article III, section 2, and the 4th, 5th, and organic 13th Amendment (section 12) of the Constitution for the United States of North America; and in violation of Articles 20 and 21 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire.

On or about January 10, 2022, the Defendants were duly served with process at their mailing address (either directly or by their agent) the Affidavit of Fact: Writ of Error [Exhibit: C] from the Complainant which was entered in the records of related case number C-08-CR-21-000334 and which stands as conclusive evidence of the proceedings in the case, including the instrument styled as an Administrative Bench Warrant dated January 6, 2022, and any attachments associated thereto

being unconstitutional, notwithstanding, null and void ab initio, and unenforceable for lack of jurisdiction and fraud.

Since then the Defendants, H. James West and Sharon L. Hancock, scheduled another de facto administrative hearing for July 14, 2022, for the fictitious corporate person / nom de guerre JERMAINE TYRONE BOLDEN (Race: Black) in want of jurisdiction under color of law and by color of authority within purview of the unconstitutional 14th Amendment.


Wherefore, it is this 17th day in the month of June, 2022, in the Morocco Consular Court at the Virginia commonwealth republic,

ORDERED AND ADJUDGED that a writ of error be and the same is hereby entered against you, H. James West, Sharon L. Hancock, Troy D. Berry, Brandon Foster, Anthony B. Covington, and Constance Beatty Kopelman;

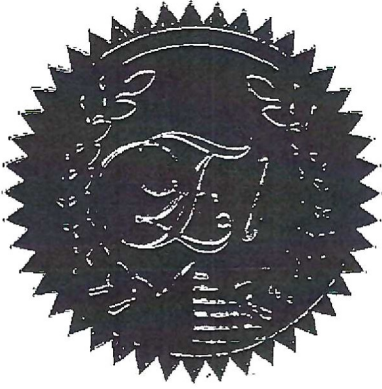
It is further **ORDERED AND ADJUDGED** that the collusive action and de facto administrative proceedings under color of law in case number C-08-CR-21-000334, in the records of the foreign DISTRICT COURT FOR CHARLES COUNTY (Inc.), including the de facto administrative hearing scheduled for July 14, 2022, and any other attachments associated thereto are **UNCONSTITUTIONAL, NOTWITHSTANDING, NULL and VOID AB INTTIO** and are **UNENFORCEABLE** for lack of jurisdiction and fraud.
