Memorandum

On or about January 6, 2023, you (et al.) were duly served  
with lawful notice at your mailing address, either directly or by your

agent, the Affidavit of Fact: Writ of Quo Warranto [Exhibit: D] from me, which was entered in the records of the related case no. C-08-CR-22-000652 and stand as my special appearance therein, in full life, in propria persona, sui juris, authorized representative, ex rel. LAMONT MAURICE BUTLER; and my jurisdictional challenge commanding you (et al.) to produce evidence of your alleged lawful jurisdiction and Article III judicial authorization from Congress for the record, and you were given three (3) days from the date above to answer and prove jurisdiction.

Since then you have failed to answer and prove jurisdiction which constitutes your default, and your admission by silence to your lack of jurisdiction and fraud.

On or about January 17, 2023, you (et al.) were duly served with lawful notice of your mailing address, either directly or by your agent, the Affidavit of Fact: Default Judgment [Exhibit: E] from me, which was entered in the records of the related case no. C-08-CR-22-000652 and ordered you to dismiss the said case with prejudice along with any other attachments associated thereto for lack of jurisdiction and fraud. There was no cause to the contrary made thereto by you, however, you are in breach of such duty.

The Affidavit of Fact: Default Judgment [Exhibit: E] stands as conclusive evidence of your obligation to dismiss the related case no. C-08-CR-22-000652 with prejudice along with any other attachments associated thereto for lack of jurisdiction and fraud (among other obligations listed therein), and the same obligations apply to you in this misrepresented instrument - bill of attainder / foreign bill of exchange / case no. C-08-CR-23-



000122 for the same reasons mentioned therein pursuant to stare decisis law, e.g., see *Melo v. United States*, 505 F.2d 1026 ("Once jurisdiction is challenged, the court cannot proceed when it clearly appears that the court lacks jurisdiction, the court has no authority to reach merits, but, rather, should dismiss the action.").

WHEREFORE, it is hereby ORDERED and ADJUDGED that a default judgment be and the same is hereby entered against you, Monise A. Brown, James West, Lisa E. Yates, Jonathan Patrick Beattie, Tiffany L. Campbell, Michael Brown, and Anthony B. Covington, and including Troy D. Berry, Brandon Foster, Brian Moore #512, Garner #545, C. Cooley #710, Morrison #615, McPherson #331, Hawkins #408, Halterman #732, Michael Almassy, Kenneth A. Tally, Karen Mitchell, and Markisha Gross (hereinafter "judgment debtors"), for the following judgment to be recovered by I, Lamont Maurice El (authorized representative, ex rel. LAMONT MAURICE BUTLER):

i. the immediate dismissal with prejudice and closure of case number C-08-CR-23-000122 and any other attachments associated thereto, as well as related case number C-08-CR-22-000652 and any other attachments associated thereto for lack of jurisdiction and fraud;

ii. the immediate and unconditional return of the private and personal property/effects of I, Lamont Maurice El, which was unlawfully seized under color of law by the judgment debtors (et al.) via the misrepresented instrument - bill of attainder / foreign bill of exchange / case number C-08-CR-23-000122 and related case number C-08-CR-22-000652;

iii. the total amount of two hundred fifty-five million and 00/100 (\$255,000,000) Dollars in lawful money, 9999 fine silver bullion coins or bars due immediately;

It is further ORDERED and ADJUDGED that a judgment lien be and the same is hereby entered against the oath of office, surety bond, property (real and personal; corporeal and incorporeal) and asset(s) belonging to or in the name of the judgment debtors and their spouse, their heir(s), successor(s) and assign(s), and belonging to or in the name of the STATE OF MARYLAND (Inc.), and DISTRICT COURT FOR CHARLES COUNTY (Inc.), and CIRCUIT COURT FOR CHARLES COUNTY (Inc.), and CHARLES COUNTY SHERIFFS DEPARTMENT (Inc.), and OFFICE OF THE SHERIFF FOR CHARLES COUNTY (Inc.), and CHARLES COUNTY DETENTION CENTER (Inc.), and their subsidiaries (if any) to secure the performance and payment of this judgment, and to levy such property and asset(s) if payment cannot be made by the judgment debtors no later than thirty (30) days from the date of this judgment unless settlement can be made before that date.

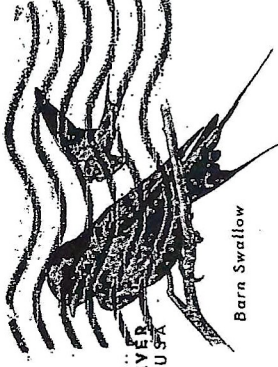

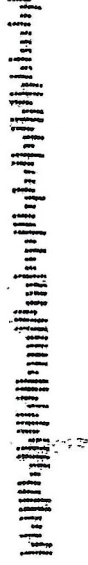
