Stare Decisis Law

Elliot v. Peirsol, 26 U.S. 328, 340 (1828) (“Courts are constituted by authority, and they cannot act beyond the power delegated to them. If a court acts without authority, its judgments and orders are regarded as nullities. They are not voidable, but simply void; and form no bar to a remedy sought in opposition to them, even prior to a reversal. They constitute no justification; and all persons concerned in executing such judgments, or sentences, are considered, in law, as trespassers.”).

MEMORANDUM

On or about June 18th 2022, you, Tiffany Moore Russell and you, Keith F. White were served with process at your mailing address via certified mail (article number: 7020240000075195401) the Affidavit of Fact: Writ of Quo Warranto [Exhibit: A] which was entered in the records of docket number 2020-DR-011435-O, as conclusive evidence of your lack of jurisdiction and fraud due to your failure to prove jurisdiction See *Louisville v. Motley, 211 U.S. 149, 29 S.Ct. 42* (“If any tribunal finds absence of proof of jurisdiction over a person and subject-matter, the case must be dismissed. The accuser bears the burden of proof beyond a reasonable doubt.”).

You both failed to answer lawful demands, which constitutes default. Wherefore, it is hereby **ORDERED AND ADJUDGED** that a Writ of Error be and the same is hereby entered against you, Tiffany Moore Russell and Keith F. White.

It is further **ORDERED AND ADJUDGED** that the misrepresented instrument – bill of attainder / foreign bill of exchange styled as case number: 2020-DR-011435-O and any attachments associated thereto are NULL and

VOID AB INITIO and are UNENFORCEABLE for lack of jurisdiction and fraud and must be DISMISSED WITH PREJUDICE.

Total sum principal amount \$322,000.00 payable in lawful money of .9999 fine silver bullion coins or bars.

Therefore, administrative order styled as ORDER DISMISSING PETITION, WITHOUT PREJUDICE,

is unconstitutional, notwithstanding, null and void ab initio and is not enforceable for lack of jurisdiction and fraud. See **United States v. Throckmorton, 98 U.S. 61, 25 L.Ed. 93** (*"Fraud vitiates the most solemn contracts, documents, and even judgments."*); and see **Elliot v. Peirsol, 26 U.S. 328, 340 (1828)** (*"Courts are constituted by authority, and they cannot act beyond the power delegated to them. If a court acts without authority, its judgments and orders are regarded as nullities. They are not voidable, but simply void; and form no bar to a remedy sought in opposition to them, even prior to a reversal. They constitute no justification; and all persons concerned in executing such judgments, or sentences, are considered, in law, as trespassers."*).

It is further **ORDERED AND ADJUDGED** that the collusive action and de facto administrative proceedings under color of law in case number 2020-DR-011435-O, in the


