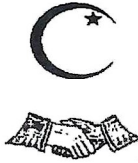

Stare Decisis Law

“Courts are constituted by authority and they cannot act beyond the power delegated to them. If a court acts without authority, its judgments and orders are regarded as nullities. They are not voidable, but simply void; and form no bar to a remedy sought in opposition to them, even prior to a reversal. They constitute no justification; and all persons concerned in executing such judgments, or sentences, are considered, in law, as trespassers.” See Elliot v. Peirsol, 26 U.S. 328, 340 (1828)

Nizer, (first name unknown) Micklus #567, William Saunders #453, Devin Arends #515, Richard Swann #656, Maurice S. Johnson #714, and Troy D. Berry were duly served with process at your mailing location via United State Postmaster Certified Mail with the Affidavit of Fact: Writ of Quo Warranto [Exhibit A], the Affidavit of Fact: Rescission of Signature on Alleged Summons [Exhibit: B] and attachment EXHIBIT: B1 which were entered into case number D-042-CR-22-000811 in the records of the private foreign de facto corporate entity name DISTRICT COURT FOR CHARLES COUNTY (INC.) and you were given three (3) days upon your receipt to answer and prove jurisdiction.

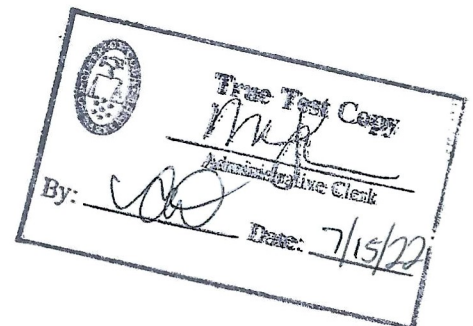
ORDERED AND ADJUDGED that this default judgment be and the same is hereby entered against you, Andrea R. S. Watkins, Markisha Gross, Anthony B, Covington, Kristen Schulz, Christine E. Nizer, (first name unknown) Micklus #567, William Saunders #453, Devin Arends #515, Richard Swann #656, Maurice S. Johnson #714 and Troy D. Berry (hereinafter "Judgment Debtors");

It is further **ORDERED AND ADJUDGED** that the Judgment Debtors are obligated to I, Nina Eliza Bey (hereinafter "Judgment Creditor") for the following judgment:

- i. the immediate dismissal with prejudice of case number D-042-CR-22-000811 and any other attachments associated thereto for lack of jurisdiction and fraud; and
- ii. the outstanding amount of \$19,697,600.00 payable in lawful money of .9999 fine silver bullion coins or bars for compensatory and punitive damages;

IT IS FURTHER ORDERED AND ADJUDGED that this default judgment shall serve as a judgment lien against the oaths of office, surety bonds, and all property (real and personal; corporeal and incorporeal) and assets of the Judgment Debtors as well as their spouse, heir(s), successor(s) and assign(s), in order to secure the performance of this judgment, and to levy on such property and assets for the satisfaction of this judgment if payment cannot be made.

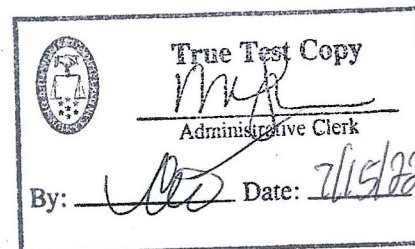
