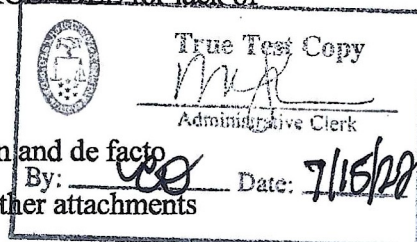
I am in receipt of your spurious misrepresented instrument (untitled) dated June 22, 2022 and addressed to the fictitious person / nom de guerre NINA ELIZABETH WASHINGTON (race: Black) under color of law within purview of the unconstitutional 14th Amendment. Your instrument does not constitute an answer to anything. Furthermore, your instrument attempts to misrepresent the Affidavit of Fact: Default Judgment [EXHIBIT: C] and the Writ of Error [EXHIBIT: D] to be “motions”, by your error, which constitutes fraud. See **EXHIBITS: E1 and E2** attached hereto; and see **United States v. Throckmorton, 98 U.S. 61, 25 L.Ed.93** (“*Fraud vitiates the most solemn contracts, documents, and even judgments.*”).

It is therefore considered **ORDERED AND ADJUDGED** that this writ of error be and the same hereby entered against you, Andrea R. S. Watkins, Markisha Gross, Anthony B, Covington, Kristen Schulz, (first name unknown) Micklus #567, William Saunders #453, Devin Arends #515, Richard Swann #656, Maurice S. Johnson #714 and Troy D. Berry;

It is further **ORDERED AND ADJUDGED** that the misrepresented instruments – bills of attainder / foreign bills of exchange (untitled) dated June 22, 2022, and any proceedings associated thereto are UNCONSTITUTIONAL, NOTWITHSTANDING, NULL and VOID AB INITIO and are UNENFORCEABLE for lack of jurisdiction and fraud;

It is further **ORDERED AND ADJUDGED** that the misrepresented instrument – bill of attainder / foreign bill of exchange styled as an administrative bench warrant dated June 13, 2022, and any other attachments associated thereto are UNCONSTITUTIONAL, NOTWITHSTANDING, NULL and VOID AB INITIO and are UNENFORCEABLE for lack of jurisdiction and fraud;

It is further **ORDERED AND ADJUDGED** that the collusive action and de facto administrative proceedings in case number D-042-CR-22-000811 and any other attachments



associated thereto are UNCONSTITUTIONAL, NOTWITHSTANDING, NULL and VOID AB INITIO and are UNENFORCEABLE for lack of jurisdiction and fraud.

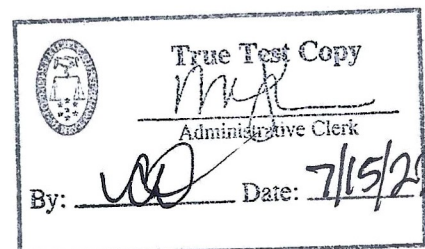
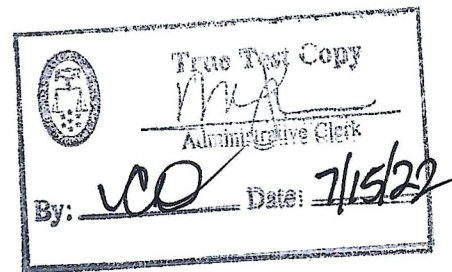

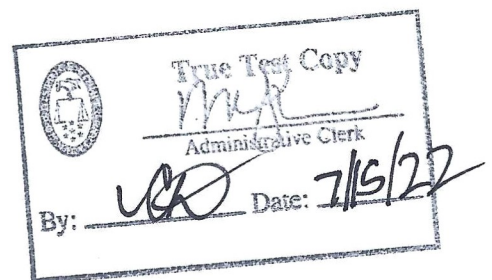
