On May 4, 2021, you were served with process at your current address via hand delivery with the Affidavit of Fact: Writ of Quo Warranto [Exhibit: A] with attachments Exhibits A1 and A2, and you failed to answer and prove jurisdiction which constitutes default. It is therefore considered:

**ORDERED AND ADJUDGED** that a Writ of Error be and the same is hereby entered against you, Dorothy J. Wilson and Maria Fields;
