For the record, I am Lamont Maurice El, a Moorish-American national (not a U.S. citizen or stateless), natural person, in full life, in propria persona (not pro se), sui juris, authorized representative, ex rel. LAMONT BUTLER-EL. I am an aboriginal sovereign national to this land by jus sanguinis and as such, you and your private foreign de facto corporation acting as

an administrative agency, i.e., ALEXANDRIA CITY GENERAL DISTRICT COURT (Inc.), do not have or possess lawful jurisdiction to hear, present, or pass judgment in any matter concerning my affairs under your quasi civil non-sanctioned tribunal of private foreign color of law process.

Furthermore, your lack of jurisdiction and fraud is proved by conclusive evidence, e.g., the Affidavit of Fact: Default Judgment [Exhibit:C-DEF] received by you and entered in the records of case number GV22-6109 on or about February 21, 2023. Therefore, your continued attempt to erroneously schedule another de facto administrative hearing for March 16, 2023, or for any other date thereafter under color of law by your color of authority and in want of jurisdiction constitutes fraud and a violation of my right to due process of law which is guaranteed to be secured under Article III, section 2, and the 5th Amendment of the Constitution for the United States of North America.

WHEREFORE, it is hereby ORDERED and ADJUDGED that a writ of error be and the same is hereby entered against you, Sonya Sacks, Marion W. Jackson, and Jessica Blajeh;

It is further ORDERED and ADJUDGED that the collusive action and de facto administrative proceedings under color of law in case number GV22-6109 in the records of the foreign de facto ALEXANDRIA CITY GENERAL DISTRICT COURT (Inc.), including the de facto administrative hearing scheduled for March 16, 2023, and for any other date thereafter, and any other attachments associated thereto are unconstitutional, notwithstanding, null and

void ab initio, and unenforceable for lack of jurisdiction and fraud.
