Stare Decisis Law

Kolovrat v. Oregon, 366 U. S. 187, 194, 81 S.Ct. 922 (1961) (“A state cannot refuse to give foreign nationals their treaty rights because of fear that valid international agreements may possibly not work completely to the satisfaction of state authorities. Under the supremacy clause of the United States Constitution Art. VI, clause 2, state policies....must give way to overriding federal treaties and conflicting arrangements.”).

For the record, I am Jermaine Tyrone Bolden Bey, a natural person, in full life, in propria persona, sui juris, authorized representative, ex rel. JERMAINE TYRONE BOLDEN. My nationality / citizenship is verified by my national identification card under classification number AA 222141, Class A, in the Library of Congress Copyright Office, Washington, District of Columbia republic, as an aboriginal and indigenous Moorish American national and rightful heir of Morocco, Maghrib al Aqṣá, at North-West Amexem / North America by *jus sanguinis*. I am a ‘foreign national’ under the consular jurisdiction of the Consulate General of Morocco at the Maryland state republic, for the protection and enforcement of my treaty rights secured under the Treaty of Peace and Friendship of 1836 between the United States of North America and Moroccan Empire. See the ‘Consular Notification and Access’ manual 5th Edition 2018, issued by the United States Department of State.

I hereby rescind *nunc pro tunc* and hold as null and void ab initio my autograph(s) inscribed on any and all 'registration', 'driver's license', and voter's registration instruments under the private foreign corporate de facto entities named STATE OF MARYLAND (Inc.), MARYLAND DEPARTMENT OF MOTOR VEHICLES (Inc.) and MARYLAND DEPARTMENT OF TRANSPORTATION (Inc.), on the information of the nom de guerre: JERMAINE TYRONE BOLDEN, Address: 7300 Latham Court, Hughesville, Maryland [20603], Driver's License No. B-435-402-809-995 (issue date: September 16, 2020) which unlawfully deprives me of my right of travel under color of law within purview of the unconstitutional 14th Amendment by way of fraud in the inducement. See **United States v. Throckmorton**, 98 U.S. 61, 25 L.Ed. 93 ("*Fraud vitiates the most solemn contracts, documents, and even judgments.*").

Wherefore, I hereby give notice of the exercise and enforcement of my inalienable birthright to travel on my inherited ancestral land at North America, absence of any 'license' or 'registration' issued under color of law by the private foreign corporate entity known as MARYLAND DEPARTMENT OF MOTOR VEHICLES (Inc.) and MARYLAND DEPARTMENT OF TRANSPORTATION (Inc.); and such instruments are held in law as unconstitutional, notwithstanding, null and void ab initio for lack of jurisdiction and fraud in the inducement. Anything to the contrary constitutes deprivation of rights under color of law per Title 18 USC 242.
