## MEMORANDUM

The misrepresented instrument – bill of attainder / foreign bill of exchange styled as an Administrative Bench Warrant dated January 6, 2022, filed in case number: C-08-CR-21-000334 is made out to the fictitious corporate person / nom de guerre JERMAINE TYRONE BOLDEN, Race: Black, under color of law within purview of the unconstitutional 14<sup>th</sup> Amendment with the intent to kidnap me, denationalize me and hold me hostage for profit as surety for the nom de guerre JERMAINE TYRONE BOLDEN, Race: Black, in unlawful imprisonment against my consent, absent of a lawful warrant and without due process of law in violation of my secured rights under Article III, section 2, and the 4<sup>th</sup>, 5<sup>th</sup>, and organic 13<sup>th</sup> Amendments (section 12) of the Constitution for the United States of North America, and in violation of my secured treaty rights to consular jurisdiction under Articles 20 and 21 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire. Therefore, your instrument styled as an Administrative Bench Warrant dated January 6, 2022, is unconstitutional, notwithstanding, null and void ab initio and is not enforceable for lack of jurisdiction and fraud. See **EXHIBIT: C1** attached hereto; and see *United States v. Throckmorton*, 98 U.S. 61, 25 L.Ed. 93 (*"Fraud vitiates the most solemn contracts, documents, and even judgments."*); and see *Elliot v. Peirsol*, 26 U.S. 328, 340 (1828) (*"Courts are constituted by authority, and they cannot act beyond the power delegated to them. If a court acts without authority, its judgments and orders are regarded as nullities. They are not voidable, but simply void; and form no bar to a remedy*

*sought in opposition to them, even prior to a reversal. They constitute no justification; and all persons concerned in executing such judgments, or sentences, are considered, in law, as trespassers. ”).*

On or about December 29, 2021, you were duly served with process at your mailing address the Affidavit of Fact: Writ of Quo Warranto [Exhibit: A] which was entered in the records of case number C-08-CR-21-000334 and was given three (3) days from that date to answer and prove your jurisdiction. You failed to answer and prove jurisdiction which constitutes default.

On or about January 5, 2022, you were duly served with process at your mailing address the Affidavit of Fact: Default Judgment [Exhibit: B] which was entered in the records of related case number C-08-CR-21-000334 as conclusive evidence of your lack of jurisdiction and fraud. Therefore, it is hereby:

ORDERED AND ADJUDGED that a writ of error be and the same is hereby entered against you, Sharon L. Hancock, Anthony Bruce Covington, Constance Beatty Kopelman, and any other person related;

It is further ORDERED AND ADJUDGED that the misrepresented instrument – bill of attainder / foreign bill of exchange styled as an Administrative Bench Warrant dated January 6, 2022, and any attachments associated thereto are NULL and VOID AB INITIO and are UNENFORCEABLE for lack of jurisdiction and fraud;

It is further ORDERED AND ADJUDGED that the collusive action and de facto administrative proceedings taken under color of law in case number C-08-CR-21-000334 in the records of the foreign CIRCUIT COURT FOR CHARLES COUNTY (Inc.) are

UNCONSTITUTIONAL, NOTWITHSTANDING, NULL and VOID AB INITIO and are  
UNENFORCEABLE for lack of jurisdiction and fraud;
