**Stare Decisis Law**

*Elliot v. Peirsol, 26 U.S. 328, 340 (1828) ("Courts are constituted by authority, and they cannot act beyond the power delegated to them. If a court acts without authority, its judgments and orders are regarded as nullities. They are not voidable, but simply void; and form no bar to a remedy sought in opposition to them, even prior to a reversal. They constitute no justification; and all persons concerned in executing such judgments, or sentences, are considered, in law, as trespassers.")*

**MEMORANDUM**

I am in receipt of your misrepresented instrument – bill of attainder / foreign bill of exchange titled SUMMONS FOR UNLAWFUL DETAINER dated January 11, 2022. However, your instrument was issued under color of law within purview of the unconstitutional 14<sup>th</sup> Amendment due to your failure to prove jurisdiction and judicial authorization under Article III, sections 1 and 2 of the Constitution for the United States of North America. Therefore, your instrument titled SUMMONS FOR UNLAWFUL DETAINER dated January 11, 2022, and any attachment associated thereto are unconstitutional, notwithstanding, null and void ab initio and are not enforceable for lack of jurisdiction and fraud. See **United States v. Throckmorton, 98 U.S. 61, 25 L.Ed. 93** (*"Fraud vitiates the most solemn contracts, documents, and even judgments."*); and see **Elliot v. Peirsol, 26 U.S. 328, 340 (1828)** mentioned above.

On or about January 13, 2022, you were duly served with process at your mailing address with the Affidavit of Fact: Default Judgment [Exhibit: B] which was entered in the records of case number GV21018870-00 and which stands as conclusive evidence of your lack of jurisdiction and fraud.

WHEREFORE, it is considered ORDERED AND ADJUDGED that a writ of error be and the same is hereby entered against you, Susan Damara Madsem and Sang K. Park, and all other persons similarly situated that are involved and are not herein listed;

It is further ORDERED AND ADJUDGED that the misrepresented instrument – bill of attainder / foreign bill of exchange titled SUMMONS FOR UNLAWFUL DETAINER dated January 11, 2022, and any attachments associated thereto are NULL and VOID AB INITIO and are UNENFORCEABLE for lack of jurisdiction and fraud;

It is further ORDERED AND ADJUDGED that the collusive action and de facto administrative proceedings in case number GV21018870-00 in the records of the foreign FAIRFAX COUNTY GENERAL DISTRICT COURT (Inc.), including the de facto administrative hearing set for February 4, 2022, are UNCONSTITUTIONAL, NOTWITHSTANDING, NULL and VOID AB INITIO and are UNENFORCEABLE for lack of jurisdiction and fraud;
