C-08-CR-22-000652, and C-08-CR-23-000122) addressed to LAMONT
MAURICE BUTLER, a colored person.

I am in receipt of your three (3) misrepresented instruments titled: NOTICE OF HEARING/TRIAL dated May 9, 2023, regarding the unconstitutional bills of attainder titled case numbers 08-K-13-000884, C-08-CR-22-000652, and C-08-CR-23-000122 which are notwithstanding and unenforceable pursuant to Article I, section 10, clause 1 of the Constitution for the United States of America, which over the following (in relevant part):

"No state shall pass any bill of attainder."


Furthermore, your three (3) misrepresented instruments identify the wrong person because they are addressed to the colored person/nom de guerre LAMONT MAURICE BUTLER, Race: Black male, which does not identify me and constitutes improper service of process^{and fraudulent misrepresentation}. Also, I never made a general (voluntary) appearance in the records of case numbers 08-K-13-000884, C-08-CR-22-000652, or C-08-CR-23-000122 as the alleged defendant LAMONT MAURICE BUTLER, Race: Black male, at any time.

WHEREFORE, I, Lamont Maurice El (a Moorish-American, foreign national; race: Asiatic/Human), in full life, in propria persona, sui juris, make special appearance in case numbers 08-K-13-000884, C-08-CR-22-000652, and C-08-CR-23-000122, and I object to your improper service of process on the grounds of you identifying the wrong person as the alleged defendant in the records of such cases, and I request that such cases be immediately dismissed with prejudice and closed due to improper service of process, and fraudulent misrepresentation. See United States v. Throckmorton, 98 U.S. 61, 25 L.Ed. 93 ("Fraud vitiates the most solemn contracts, documents, and even judgments."). I am identified by my consular (national) identity card and I have identified myself in all my un rebutted affidavits filed in the records of such cases which is contrary to the identity of the alleged defendant.


